Spencer Perceval; by which fatal and deplorable event your Royal Highness has been deprived of a taithful and zealous Minister, and the kingdom of an able and upright statesman. We deem it our duty thus publicly to express our abhorrence of the horrid crime of murder, whenever or wheresoever committed; and our feelings on this painful occasion are greatly increased by the consideration, that the assassin's hand has destroyed a man of the first eminence and consideration in the state; and in private life, of the most amiable and exemplary character. Amidst the dismay that surrounds us it is some consolation to know, that this sad instance of human depravity is to be ascribed to the wickedness of an individual, and is not imputable to any plan of con-Whatever attempts may be federated malignity. made by designing men to inflame the public mind, in these eventful times, by false representations of assumed grievances, or by exaggerated statements of unavoidable calamities, incident to unfruitful scasons, and to the subtle machinations of a powerful and unrelenting enemy, we confidently hope that all such mischievous designs will be frustrated by the vigilant exertion of those powers which the laws have wisely placed in the hands of government, for the preservation of the public peace, for the safeguard of human life, and for the protection of private property.

Deign, Sir, to accept this address, as the humble pledge of our loyalty to the King, of our duty to your Royal Highness as Regent, and of our-respect and veneration for the laws and constitution of the

realm.
