PRESENT,

His Royal Highness the PRINCE REGENT in Council.

WHEREAS by an Act passed in the twenty-cighth year of the reign of His present Majesty, intituled "An Act for regulating the "Trade between the Subjects of His Majesty's Colonies and Plantations in North America and " in the West India Islands and the Countries be-"longing to the United States of America, and between His Majesty's said Subjects and the "Foreign Islands in the West Indies;" it is amongst other things enacted, That it shall and may be lawful for His Majesty in Council, by order or orders to be issued and published from time to time, to authorise, or by warrant or warrants under his sign manual, to empower the Governor of Newfoundland for the time being, to authorise in case of necessity the importation into Newfoundland of bread, flour, Indian corn, and live stock, from any of the territories belonging to the said United States for the supply of the inhabitants and fishermen of the Island of Newfoundland, for the then ensuing season only; provided always, that such bread, flour, Indian corn, and live stock, so authorised to be imported into the Island of Newfoundland, shall not be imported, except in conformity to such rules, regulations, and restrictions, as shall be specified in such order or orders, warrant or warrants respec-tively, and except by British subjects, and in Britishbuilt ships, owned by His Majesty's subjects, and navigated according to law.

And whereas it is expedient and necessary, that provision be made for fully supplying the inhabitants and fishermen of the Island of Newfoundland, for the ensuing season, with bread, flour, pease, Indian corn, and live stock, and also pitch, tar, and turpentine; His Royal Highness the Prince Regent doth thereupon, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, hereby order and declare, that for the supply of the inhabitants and fishermen His Majesty's Revenue in Irela of the Island of Newfoundland for the ensuing whom such licence was granted.

T the Court at Carlton-House, the 23d of season only, bread, flour, pease, Indian corn, and live stock, and also pitch, tar, and turpentine, may live stock, and also pitch, tar, and turpentine, may be imported into the said island from any of the territories belonging to the said United States, by British subjects, and in British-built ships, owned by His Majesty's subjects, and navigated according to law, and which within the space of nine months previous to the time of such importation, have cleared out from some port of the United Kingdom of Great Britain and Ireland, or other His Majesty's dominions in Europe, for which purpose a licence shall have been granted by the Commissioners of His Majesty's Customs in England or Scotland, or the Commissioners of His Majesty's Revenue in Ireland, or any other person or persons who may be duly authorised in that kingdom respectively, in the manner and form herein-after mentioned; which licences hall continue and be in force for nine calendar months from the day of the date upon which such licence is respectively granted, and no longer; provided that no such licence as aforesaid, granted after the thirtieth day of September next, shall be of any force or effect: And His Royal Highness is hereby further pleased to order, in the name and on the behalf of His Majesty, that the master or person having the charge or command of any ship or vessel to whom such licence shall be granted, shall, upon the arrival of the said ship or vessel at the port, harbour, or place in the Island of Newfoundland where he shall discharge such bread, flour, pease, Indian corn, and live stock, pitch, tar, and turpentine, deliver up the said licence to the Col-lector or other proper Officer of the Customs there, having first indorsed on the back of such licence the marks, numbers, and contents of each package of bread, flour, pease, Indian corn, pitch, tar, and urpentine, and the number of live stock, under the penalty of the forfeiture in the said Act mentioned; and the Collector or other proper Officer of the Customs at Newfoundland, is hereby enjoined and required to give a certificate to the master or person having the charge or command of such ship or vessel, of his having received the said licence so indorsed as before directed, and to transmit the same to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland resp

Now be it known, that the said [person's name] hath a licence to lade on board the said ship, [ship's name] at and from any port or place belonging to the United States of America, bread, flour, pease, Indian corn, and live stock, and also pitch, tar, and turpentine, the produce of the said United States, and no other article whatsoever; and to carry the said bread, flour, pease, Indian corn, and live stock, pitch, tar, and turpentine, to some port or place in the Island of Newfoundland; and on the arrival of the said ship at any port, harbour, or place of discharge in Newfoundland, the master or person having the charge or command of the said ship, is required and enjoined to deliver up the said licence to the Collector or other proper Officer of His Majesty's Customs there, and to indorse on the back thereof the marks, numbers, and contents of each package of bread, flour, pease, Indian corn, pitch, tar, and turpentine, and the number of live stock, and shall thereupon receive a certificate thereof from the said Collector or other proper Officer of the Customs.

Copy of a Letter from Lieutenant Simmonds, commanding His Majesty's Gun-Vessel Attack, addressed to Rear-Admiral Foley, and transmitted to John Wilson Croker, Esq.

His Majesty's Gun-Brig Attack, Dover-Roads, July 5, 1812.

inform you; that in executing your orders, to Hornings, in Scotland, i cruize in His Majesty's brig under my command, Newbiggin, Esq deceased.

for the protection of trade and the annoyance of the enemy, at six P.M. yesterday evening, Calais Cliff bearing S. by E. four miles, I observed a transport galliot, a sloop, and a privateer, coming out of Calais Harbour, and endeavouring to run along shore: perceiving this to be their intention, and knowing that the shewing a disposition to make an immediate attack would cause them all to put back, or run their vessels on shore, I made sail to windward, in the hope of decoying them so far from their own shore as to be able to cut them off. Judging this to be the proper opportunity for such an attempt, I immediately made all sail in shore, and at half past eight, manned and sent the gig. away, with six men, under the direction of Mr. Councy, the Second Master, still keeping His Majesty's brig towards the enemy. At twelve, there being light airs, and within half gun-shot of the enemy's shore, the Second Master discovered the galliot in tow of the privateer.

Mr. Couney, undaunted by such an unequal force, and under the galling fire of their musketry, immediately boarded the transport, while on the other side she was boarded by the privateer's men; but on the Second Master's having killed one of their men in boarding, they thought it prudent to desist and sheer off, leaving the boat's crew in possession of their prize. She proves to be the transport galliot No. 637, of two hundred and fifty-six tons burthen, manned with sixteen men, and armed with muskets; the privateer was armed with a sixpounder, swivels, cohorns, and musketry, and a complement of thirty men, commanded by Lieutenant de Vaisseau Gröthe.

It is with great pleasure I have to state, that it has pleased God to spare the lives of the little crew of His Majesty's brig engaged in this contest, who have escaped, to a man, unhurt.

The gallantry displayed by Mr. Couney and the men employed with him, merits any approbation that can be bestowed on them, for, independent of the fire of the enemy's musketry, the vessel was exposed to the batteries, which kept up a fire of round and grape upon them. From His Majesty's brig being becalmed from the time the boat shoved off, I was unable to close with them; my anxiety was great for the fate of the people, but from my knowledge of Mr. Couney's conduct, since he has been with me, I had great confidence in him.

I cannot conclude without mentioning the steady conduct of my officers and men throughout the whole of the affair; and had we been so fortunate as to have had a breeze, we, no doubt, should have captured the whole.

BY THE LORDS COMMISSIONERS OF HIS MAJESTY'S TREASURY.

third year of His present Majesty's reign, intituled. "An Act for permitting certain Goods" imported into Great Britain to be secured in "Warehouses without Payment of Duty," it is enacted, that it should be lawful for the importer or importers, proprietor or proprietors, consiguee

or consignees of any of the goods, wares, or merchandize enumerated or described in the table thereunto annexed, marked (B), and which shall be legally imported and brought into the port of London, to lodge and secure the same under the joint locks of the Crown and the London Dock Company, in any warehouse or warehouses, erected or to be erected, situate within the premises belonging to the London Dock Company, without payment at the time of the first entry of such goods, wares, and merchandize, of the duties of Customs or Excise due on the importation thereof; subject nevertheless to the rules, regulations, and restric-tions therein contained; provided that no such goods, wares, or merchandize should be so lodged or secured, unless and until such warehouses or other works belonging or to belong thereto, should be so far completed that in the judgement of the Lord High Treasurer, or the Commissioners of His Majesty's Treasury for the time being, or any three or more of them, the same shall be fit and proper in every respect for the reception of such goods, wares, and merchandize, and wherein the same might respectively be safely and securely deposited, and remain under the regulations and di-rections in the said act contained; and the said Lord High Treasurer, or Commissioners of His Majesty's Treasury for the time being, or any three or more of them, were thereby authorized and empowered, in writing under his or their hand or hands, to certify and make known his or their approbation of such warehouses, which certificate should be published three times at least in the London Gazette, and in two or more public morning news-papers usually circulated in London: And whereas the table marked (B) above referred to, is in the words following; viz.

"A list of articles which (not being imported by the United Company of Merchants of Engliand trading to the East Indies, or not being imported from the West Indies,) may be secured in the warehouses within the premises belonging to the London Dock Company, without the duties due on the importation thereof being first paid".

Chelsea-Hospital, July 4, 1812. THESE are, by order of the Right Honourable . the Lords and others Commissioners for managing the Affairs of the Royal Hospital at Chelsea. to give notice, that all Out-Pensioners belonging to the said Hospital, residing in London or within twenty-five miles thereof, are required to appear personally and regimentally, with their instructions and certificates of admission, at the Secretary's Office in the said Hospital, on the respective days, and in their different classes, according to their several rates of pension, as under-mentioned, when attendance will be given from nine o'clock in the. morning until three in the afternoon, for the payment of half a year's pension in advance to Mid-summer next, with the augmentation in proportion to their disability and length of service, according to His Majesty's late regulations in their favour.

On Wednesday the 8th of July.

And such of them as were admitted on account of blindness are ordered to transmit, with their halfyearly affidavits, a certificate as to the state of their sight, signed by an Army Surgeon, or other medical person resident in their neighbourhood; but in such distant parts, where a medical certificate is impracticable, a certificate from the Minister of the parish to that fact, and to ascertain the continuance

of their blindness, will be admitted.
