THEREAS the time limited by the Order of His Royal Highness the Prince Regent in Conneil of the sixth day of January last, for pro-bibiting the exportation out of this kingdom, or carrying coastwise, gunpowder or salt petre, or any sort of arms or ammunition, will expire on the eighth day of August next; and whereas it is judged expedient for His Majesty's service and the safety of this kingdom, that the said pro-hibition should be continued for some time longer; His Royal Highness, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-Generál of the Ordnance for His Majesty's service) do at any time during the space of six months (to commence from the said eighth day of August next,) presume to transport into any parts out of this kingdom, or carry coastwise, any gunpowder or salt petre, or any sort of arms or ammunition, or ship or lade any gunpowder or salt petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any parts beyond the seas, or carrying the same coastwise, without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective foricitures and penalties inflicted by an Act passed in the twenty-ninth year of His late Majesty's reign, initialled, "An Act to empower" His Majesty to prohibit the exportation of salt "petre, and to enforce the law for empowering "His Majesty to prohibit the exportation of gun-" powder, or any sort of arms or ammunition, "and also to empower His Majesty to restrain the carrying coastwise of salt petre, gunpowder, or any sort of arms or ammunition;" and the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for exe-

HEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the sixth day of January last, prohibiting, in the name and on the behalf of His Majesty, the transporting into any parts out of this Kingdom of any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sheet copper, or other naval stores, will expire upon the eighth day of August next; and whereas it is judged expedient for His Majesty's service and the safety of this kingdom, that the said prohibition should be continued for some time longer; His Royal Highness, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth therefore hereby order, require, prohibit, and command, that no person or persons whatsoever do at any time, for the space of six months from the said eighth day of August next, presume to transport into any parts out of this kingdom any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sheet copper, sail-cloth or canvas, or other naval stores, or do ship or lade any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, howsprits, oars, oakum, sheet copper, sail-cloth or canvas, or other naval stores, on board any ship or vessel, in order to transporting the same into any parts beyond the seas, without leave or permission first being had and obtained from His Majesty or His Privy Council,



upon pain of incurring the forfeitures inflicted by an Act passed in the thirty-third year of His Majesty's reign, intituled, "An Act to enable " His Majesty to restrain the exportation of naval "stores, and more effectually to prevent the ex-" portation of salt petre, arms, and ammunition, "when prohibited by Proclamation or Order in Council." But it is nevertheless His Royal Highness's pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majesty's ships of war, or to any other ships or vessels or boats in the service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any ship or vessel from taking or having on board such quantities of naval stores as may be necessary for the use of such ship or vessel, during the course of her intended voyage, or by licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the time being; nor to the exportation of the said several articles to Ireland, or to His Majesty's yards or garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies; provided that, upon the exportation of any of the said articles for the purposes of trade to Ireland, or to His Majesty's yards and garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies, the exporters of such articles do first make oath of the true destination of the same to the places for which they shall be entered outwards, before the entry of the same shall be made, and do give full and sufficient security by bond (except as hereinafter excepted), to the satisfaction of the Commissioners of His Majesty's Customs, to carry the said articles to the places for which they are so entered outwards, and for the purposes specified, and none other; and such bond shall not be cancelled or delivered up, until proof be made to the satisfaction of the said Commissioners, by the production, within a time to be fixed by the said Commissioners and specified in the bond, of a certificate or certificates, in such form and manner as shall be directed by the said Commissioners, showing that the said articles have been all duly landed at the places for which they were entered outwards. But it is His Royal Highness's pleasure, nevertheless, that the fellowing articles, viz. bar iron, white and tarred rope, tallow or mill grease, tarpaulins for waggon covers, pitch, tar, and tur-pentine, shall be permitted to be exported, upon payment of the proper duties, without bond being entered into by the merchant exporter, to any of the British Plantations in the West Indies, or to any of 'His Majesty's settlements in South America; provided the merchant exporter shall first verify, upon oath, that the articles so exported are intended for the use of a particular plantation or settlement, to be named in the entry outwards, and

ment has not before been furnished with any supply of the said articles during the same season; and provided also that the exportation of the said articles shall in no case exceed the value of fifty pounds sterling for any given plantation or settlement, whether by one or more shipments within the same season: And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary directions herein as to them may respectively appertain.

HEREAS by an act, passed in the forty-eighth year of His Majesty's reign, intituled "An Act for further continuing, until three months after the ratification of a definitive treaty of peace, an act made in the forty-fourth year of His present Majesty, for permitting the importa-tion into Great Britain of hides and other articles in foreign ships," it is enacted that an act, made in the forty-fourth year of His present Majesty, intituled "An Act for permitting, until the fifth day of May, One thousand eight hundred and five, the importation of hides, calf-skins, horns, tallow, and wool (except cotton wool), in foreign ships, ou payment of the like duties as if imported in British. or Irish ships;" which by an act, made in the fortyfifth year of His present Majesty, was revived and further continued until the twenty-fifth day of March One thousand eight hundred and six, and extended to goat-skins imported in foreign ships; and which was further continued by an act made in the forty-seventh year of his present Majesty, until the twenty-fifth day of March One thousand eight hundred and eight, should be and the same. was thereby further continued until three months. after the ratification of a definitive treaty of peace: And whereas by the said acts it is lawful for His Majesty, by his Order in Council from time to time, when and as often as it may be judged expedient, to. permit any hides, picces of hides, dressed or un-dressed calf-skins, or pieces of calf-skins dressed or undressed, horns or pieces of horns, tallow, and' wool (except cetton wool), and also goat-skins, to be imported in any foreign ship or vessel, and to be admitted to entry in any port or place in the United Kingdom, on payment of such and the like duties, of customs and excise as are due and payable on the like goods when imported in any British or Irish-. built ship or vessel; any thing contained in any act to the contrary notwithstanding: His Royal, Highness the Prince Regent, in the name and on. the behalf of His Majesty, and by and with the advice of His Majesty's privy council, is thereupon pleased, in pursuance of the powers vested in His. Majesty by the said above-recited act, to allow, and not for sale, and that the said plantation or settle- doth hereby allow, for the space of six months,

from the eighth day of August next, the importation of hides, or pieces of hides, dressed or undressed calf-skins, or pieces of calf-skins, dressed or undressed horns or pieces of horns, tallow, and wool (except cotton wool), and also of goat-skins, dressed or undressed, in any foreign ship or vessel, from any port from which the British flag is excluded; and that on the arrival at any port of the United Kingdom of any foreign ship or vessel, from any port from which the British flag is excluded, with any of the articles abovementioned, the said goods shall be admitted to entry on payment of the same duties of customs and excise as are due and payable on the like goods when imported in any British or Irish-built ship or vessel:—And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly. The humble Address of the Bishop and the Clergy of the Diocese of Bristol, resident within the City and Deanery of Bristol.

May it please your Royal Highness,

WE, His Majesty's most dutiful and loyal Subjects, the Bishop and the Clergy of the Diocese of Bristol, resident within the City and Deancry of Bristol, humbly beg leave to approach your Royal Highness with sentiments of the deepest condolence on the dreadful act of assassination committed upon the person of the late Right Honourable Spencer Perceval.

Such a deed, at all times, and under all circumstances, most abhorrent from the feelings of Englishmen, cannot but call forth, upon the present occasion, a more than usual degree of regret and

indignation.

A faithful and upright Minister, acknowledged by every description of His Majesty's subjects to have uniformly acted according to the dictates of a most pure and uncorrupted mind, is suddenly cut off by the arm of an assassin, within the walls of that house where he had long and laboriously dedicated his best services to his Sovereign and his country.

But, in addition to the grief and indignation which this atrocious act has universally excited, we cannot but be sensible to the loss which religion has sustained by the death of this virtuous Statesman, whose attention was steadily directed to its interests, and who extended its influence upon the minds and hearts of men, by that best lesson,

the example of his own life.

We humbly entreat your Royal Highness to accept, together with our condolence upon this calamitous event, the assurance of our unfeigned loyalty to His Majesty, of our dutiful attachment to your Royal Highness, and of our determination to persevere in inculcating such principles as, under Divine Providence, may best promote the welfare of our fellow-subjects, and most effectually main-

tain and support our present happy constitution in church and state.

The humble Address of the Freeholders, Commissioners of Supply, and Justices of Peace of the county of Dumbarton.

May it please your Royal Highness.

WE, the Freeholders, Commissioners of Supply, and Justices of Peace of the county of Dumbarton, assembled at a general meeting, beg leave again to approach your Royal Highness with assurances of our unfeigned loyalty and warm attachment to your Royal Highness, deeply impressed as we are, with sentiments of duty and gratitude for your unwearied exertions upon a late most eventful

We are far from supposing, that the much-lamented loss of that most worthy and able Minister, who recently fell at the door of Parliament by the hands of an obscure assassin, was at all connected with the violence and hostility of party opposition; but surely too great a licence had been given to the malignancy and virulence of personal abuse, and too much encouragement to a loose and disorderly spirit among the ignorant and ill designing. On that, and other accounts, it would perhaps have been desirable that the wish of the House of Commons had taken effect by an amicable conciliation of differences; and by forming, if possible, a more united government, selected from the known abilities of different contending Statesmen; this your Royal Highness undertook to accomplish, but your endeavours were frustrated by causes well understood, and unnecessary here to be detailed.

What more could be done under such circumstances? If the pretensions of some, who had been looked to as fit, were too high-if moderation was not to be expected from that quarter-and if the conduct of others was imprudent, your Royal Highness had no choice left, but either to resign your own exalted situation, or once more have re-course to those whose high merits had already undergone a severe trial, and with whose conduct the great body of the people were satisfied.

Permit us most humbly to offer it as our clear opinion, that your Royal Highness has been actuated, through the whole of these unexampled occurrences by a genuine sense of public duty alone, uninfluenced by private favour, unawed by the turbulence of faction, and unaffected by the indecent and groundless obloquy of disappointed men. "A list of articles which (not being imported by the United Company of Merchants of Eng-" land trading to the East Indies, or not being imported from the West Indies,) may be secured " in the warehouses within the premises belonging " to the London Dock Company, without the duties due on the importation thereof being first paid".
