His Royal Highness the PRINCE REGENT in Council.

MITHEREAS it is expedient to prevent doubts respecting the continuance and effect of the Order in Council of the nineteenth of August one thousand eight hundred and seven, respecting vessels under the flag of Mecklenburg, Oldenburg, Papenburg, and Kniphausen, and the Order in Council of the twenty-fifth November one thousand eight hundred and seven, respecting the ships and goods belonging to Prussia and Lubec; His Royal Highness the Prince Regent is pleased, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, to order and declare, and it is hereby ordered and declared, that the said two Orders in Council, bearing date respectively the nineteenth day of August one thousand eight hundred and seven, and the twenty-fifth of November one thousand eight hundred and seven, shall be considered as null and of no effect; provided nevertheless, that nothing in this Order contained, shall be construed to affect any question depending in judgment, respecting either of the said Orders, on any capture made prior to the date of this Order: but such questions shall be decided in the same manner as if this Order and Declaration had not been issued.

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, His Majesty's Principal Secretaries of State, the Lords Commissioners of the Admiralty, and the Judge of the High Court of Admiralty, and the Judges of the Courts of Vice-Admiralty, are to take the necessary measures herein as to them may respectively apportain,

THE following Address has been presented to His Royal Highness the Prince Regent; which Address His Royal Highness was pleased to receive very graciously:

To His Royal Highness George Prince of Wales, PRINCE REGENT of the United Kingdom of Great Britain and Ireland.

WE, His Majesty's most dutiful and loyal subjects, the Protestant Inhabitants of the County of Fermanagh, in Ireland, beg leave to approach your Royal Highness with the strongest expressions of our regard for your Royal Highness's person and dignity, and our firm attachment to our glorious Constitution in Church and State. In common with a large majority of the Protestant inhabitants of this part of the United Kingdom, we have to lament, that our brethren the Roman Catholics of Ireland have determined again to bring forward their claims before your Royal Highness and both Houses of Parliament. We had hopes, that gratitude for the numerous benefits which, during the mild and tolerant reign of His present Majesty had been vouchsafed them, would not so soon have been superseded by any discontent; and that at the time when the nation is engaged in arduous con-flict with its enemies, the attention of your Royal Highness's Ministers would not have been distracted by a discussion, which might better have been deferred to a season of general tranquillity.

The only disabilities which remain, as we are informed, to affect the Roman Catholics of Ireland, are their exclusion from certain high offices of trust and profit, and from seats in both Houses of Parliament. And, with great deference, we beg leave to represent to your Royal Highness, that such exclusion of persons professing a religion, at whose head is a foreign prelate, has always been deemed most salutary to the preservation of the independence of the State, and the liberty of the people. To remove these barriers would, as we apprehend, endanger the Protestant succession to the throne, would weaken the connection between the parts of the United Kingdom, and would finally subvert the Church, by law established in Ireland.

We therefore most humbly request, that your Royal Highness will not give your Royal countenance to the prayer of the Roman Catholic petition, but will continue to afford your Royal Highness's firm support to the wise cautions of that Constitution, under which the country has advanced in prosperity, under which the people have preserved their freedom, and the State has main-John Aikin, Sheriff. tained its independence.

Copy of a Letter from Captain Austen, of His Ma-jesty's Ship the Elephant, to John Wilson Croker, Esq. dated at Sca, the 28th December 1812.

SIR,

E pleased to acquaint the Lords Commissioners of the Admiralty, that His Majesty's ship under my command, in company with the Hermes, this morning captured, in latitude 38 deg. 40 min. N. and longitude 39 deg. 45 min. W. the American schooner privateer Sword Fish, of Gloucester, John Evans, Master, out sixteen days from Boston, and had made no capture. She is one hundred and fiftysix tous, burthen, not six months off the stocks, copper fastened, mounted twelve six pounders (ten of which were thrown overboard during the chase), manned with eighty-two men, and appears to sail very fast, having ran us upwards of one hundred miles, in a chase of eleven hours, although not four miles ahead of us at the commencement of it.

His Majesty's Stoop Charybdis, Sombrero Passage, December 31, 1812.

BEG leave to acquaint you, that at half-past BEG reave to acquaint you, nine this morning, the Island of Saba bearing N. E. six leagues, I fell in with, and after five hours

and a half chase, captured the Blockade American schooner privateer, of ten guns and sixty-six men, her first cruize, had only taken a small schooner belonging to St. Lucia, but being chased by one of our brigs, two days ago, was obliged to abandon

The Blockade is a fine schooner, only three months since her keel was laid, is one hundred and twenty-eight tons, has thrown all her guns overboard, except one, in the chase.

To Widows of Officers of the Land and Marine
Forces.

THIS Royal Highness the Prince Regent in the

War-Office, January 2, 1813.

Is Royal Highness the Prince Regent, in the name and on behalf of His Majesty, having been graciously pleased to abolish the former practice of transferring the payment of the pensions of the widows of officers of the land forces, from Great Britain to Ireland, and vice versa, upon the removal of regiments from one establishment to the other; and to direct, that in future every widow shall, from the 25th day of December last, inclusive, receive payment of her pension in the country in which she resides; the following rules are to be observed in this respect, videlicet:

Every widow, whether on the British or Irish establishment, should immediately notify her place of residence, and the name of her agent, to the War-Office of that country in which she at present receives her pension.

Any widow residing in Great Britain, whose pension is now issued in Ireland, should also notify her place of residence to the War-Office in Dublin, in order that official directions may be given for the payment of her pension in Great Britain from the date abovementioned.

In like manner, any widow residing in Ireland, whose pension is now issued in Great Britain, should make a similar report to the War-Office in London, when instructions will be given for the payment of her pension in Ireland from the date abovementioned.

If a widow should afterwards be desirous of changing her place of residence, she is to give two months previous notice of her intended removal, to the War-Office of the country in which she is then resident.

In pursuance of an Order of the Honourable House of Commons, of the 22d day of December 1812, notice is hereby given, that application is now making to Parliament for a bill for enlarging the market-place at Smithfield, in the City of London; for improving the avenues into and about the same; and for the better regulation of the said market.
