His Royal Highness the PRINCE REGENT in Council.

HEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the seventeenth day of July last, prohibiting, in the name and on the behalf of His Ma-jesty, the transporting into any parts out of this kingdom of any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sheet copper, or other naval stores, will expire upon the eighth day of this instant February; and whereas it is Judged expedient for His Majesty's service and the safety of this kingdom, that the said prohibition should be continued for some time longer, His Royal Highness, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth therefore hereby order, require, prohibit, and command, that no person or persons whosoever do at any time, for the space of six months from the said eighth day of this instant February, presume to transport into any parts out of this kingdom any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sheet copper, sail-cloth or canvas, or other naval stores, or do ship or lade any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowspitts, oars, oakum, sheet copper, sail-cloth or canvas, or other naval stores, on braid any ship or vessel, in order to transporting the same into any parts beyond the seas, without leave or permission first being had and obtained from His Majesty or His Privy Council, upon pain of incurring the forfeitures inflicted by an Act, passed in the thirty-third year of His

Majesty's reign, intituled, "An Act to enable" His Majesty to restrain the exportation of naval stores, and more effectually to prevent the exre portation of salt petre, arms, and ammunition, when prohibited by Proclamation or Order in " Council," But it is nevertheless His Royal Highness's pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majesty's ships of war, or to any other ships or vessels or boats in the service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any ship, or vessel from taking or having on board such quantities of naval stores as may be necessary for the use of such ship or vessel during the course of her intended voyage, or by licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the time being; nor to the exportation of the said several articles to Ireland, or to His Ma-jesty's yards or garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies; provided that, upon the exportation of any of the said articles for the purposes of trade to Ireland, or to His Majesty's yards and garrisons, or to His Majesty's colonics and plantations in America or the West Indies, or to the island of Newfoundland, or to His Majesty's forts and settlements, on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies, the exporters of such articles do first make oath of the true destination of the same to the places for which they shall be entered outwards, before the entry of the same shall be made, and do give full and suffi-cient security by bond (except as hereinafter ex-cepted), to the satisfaction of the Commissioners of His Majesty's Customs, to carry the said articles to the places for which they are so entered outwards, and for the purposes specified, and none other; and such hond shall not be cancelled or delivered up, until proof be made to the satisfaction of the said Commissioners, by the production, within a time to be fixed by the said Commissioners and specified in the bond, of a certificate or certificates.

by the said Commissioners, shewing that the said articles have been all duly landed at the places for which they were entered outwards. But it is His Royal Highness's pleasure, nevertheless, that the following articles, viz. bar iron, white and tarred rope, tallow or mill grease, tarpaulins for waggon covers, pitch, tar, and tur-pentine, shall be permitted to be exported, upon payment of the proper duties, without bond being entered into by the merchant exporter, to any of the British plantations in the West Indies, or to any of His Majesty's settlements in South America; provided the merchant exporter shall first verify, upon oath, that the articles so exported are intended for the use of a particular plantation or settlement, to be named in the entry outwards, and not for sale, and that the said plantation or settle-ment has not before been furnished with any supply of the said articles during the same season; and provided also that the exportation of the said articles shall in no case exceed the value of fifty pounds sterling for any given plantation or settlement, whether by one or more shipments within the same season: and the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary directions herein as to them may respectively appertain. BEG you will be pleased to inform my Lords Commissioners of the Admiralty, that yesterday, at half past seven P. M. Beachey Head bearing N. E. about seven miles, a French lugger privateer came out from under the land, and fired at His Majesty's ship under my command; I tacked and brought her under our lee guns, and fired several shot at her, and from her obstinate endeavours to escape, she sunk at half past nive; and, I am sorry to say, without a possibility of my saving any of the crew.

Copy of a Letter from Captain Galwey, of His Majesty's Ship Dryad, addressed to Commodore Malcolin, and transmitted by Admiral Lord Keith to John Wilson Croker, Esq.

His Majesty's Ship Pryad, Basque-Roads, December 27, 1812. SIR,

I BEG to acquaint you, that cruising, in the execution of your orders, between Bolleisle and the Isle Dieu, on the morning of the 23d instant, we saw a large brig on the weather beam, in shore of us, which I immediately chased. The weather being thick and hazy, we soon lost sight; but clearing a little again about eleven o'clock, she was perceived on the weather boy working into the Isle Dieu. I continued standing after her by the help of the lead, the fog olearing at intervals, to push through the passage between the island and the main, should she have endeavoured to escape by main, should she have chacavoured to escape by that way; but getting closer in, we discovered ther at an anchor under the battery of the island. I determined, if possible in this situation, to lay her on board, and bore up for that purpose; but the moment I did so she cut her cable, hoisted her jib and foretop-sail, and ran upon the rocks. The batteries then opened a heavy fire, and hulled us three or four times, and wounded the foremast badly, but without any other effect; and in the course of that night and the following day, the brig went to pieces.

I have not been able to find out her name, or any other particular more than that she was a French national brig of war, mounting twenty-two guns. I have the honour to be, &c.

Regulations for granting Pensions to Officers of the Commissariat Department, losing an Eye or a Limb on Service.

If an Officer of the Commissariat shall be wounded in action, and it shall appear upon an inspection made of him by the Army Medical Board, at any period not sooner than a year and a day after the time when he was wounded, that he has in consequence of his wound lost a limb or an eye, or has totally lost the use of a limb, or that his wound has been equally prejudicial to his habit of body with the loss of a limb, such Officer shall be entitled to a pension, commencing from the time when he was wounded, and depending as to its amount upon the rank he held at that period, according to the scale annexed. This pension being granted as a compensation for the injury sustained, is to be held together with any other pay and allowance to which such Officer may be otherwise entitled, without any deduction on account thereof.

Officers who shall have lost more than one limb or eye, shall be entitled to the pension for each eye or limb so lost.

Applications for this pension are to be made to the Commissary in Chief, and must always be accompanied by the certificate of the Army Medical Board, if the Officer applying is at home, or by that of a Local Army Medical Board, or of the principal Medical Officer on the station where he may be, if the Officer should be abroad. In the latter case, however, the Officer must, as soon as he returns home, be inspected by the Army Medical Board, and transmit their certificate to the Commissary in Chief.

All Officers of the Commissariat Department who may have sustained such an injury as would entitle them to this pension, by any wounds received since the commencement of hostilities in the year 1793, will, upon the production of the proper certificate from the Army Medical Board, he allowed a pension, proportioned, according to the scale, to the rank they held at the time when wounded, and commencing from the 25th December 1811.
