A T the Court at Carlton-House, the 20th of February 1813,

PRESENT,

His Hoyal Highness the PRINCE REGENT in Council.

THEREAS, by virtue of the powers vested in His Majesty by sundry Acts of Parliament, His Royal Highness the Prince Regent was pleased, by His Order in Council of the twentieth of March one thousand eight hundred and twelve, in the name and on the behalf of His Majesty, to allow, and did thereby allow, until the twenty-fifth day of March one thousand eight hundred and thirteen, the -importation into any port or place of Great Britain, of certain articles of provisions, in the manner and under the conditions therein mentioned; and whereas by an Act, passed in the fifty-first year of His present Majesty, cap. 14, it is enacted, that an Act, made in the thirty-ninth year of His present Majesty, intituled "An Act for enabling His Majesty to pro-" hibit the Exportation, and permit the Import-" ation of Corn, and for allowing the Importation " of other Articles of Provision without Payment " of Duty, to continue in force until Six Weeks " after the Commencement of the next Session of " Parliament," which was continued by an Act of the thirty-ninth and fortieth years of His present Majesty, and amended and further continued by several subsequent Acts until the twenty-fifth day of March one thousand eight hundred and eleven, shall, from and after the said twenty-fifth day of March one thousand eight hundred and eleven, be, and the same is thereby further continued during the continuance of the war, and until

six months after the ratification of a definitive treaty of peace; His Royal Highness the Prince Regent is thereupon pleased, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, to allow, and doth hereby allow, for the space of twelve months, to commence from the twenty-fifth day of March next, the importation from any port or place whatsoever into any port or place of Great Britain, of any beans, called kidney or French beans, tares, lentiles, calavancies, and all other sorts of pulse; and also of bulls, cows, oxen, calves, sheep, lambs, and swine; and of beef, pork, mutton, veal, and lamb (except salted beef and pork); and of bacon, hams, tongues, butter, cheese, potatoes, rice, sago, sago powder, tapioca, vermicelli, millet seed, poultry, fowls, eggs, game, and sour crout, in any British ship or vessel, or in any other ship or vessel belonging to persons of any kingdom or state in amity with His Majesty, and navigated in any manner whatever, without payment of any duty whatsoever, except in respect to the article of rice, which, when imported, shall be subject to such duties as may by law be payable thereon; provided that a due entry shall be made of all such articles as aforesaid that shall be imported, with the proper officers of the Customs at the port where the same shall be imported, under the penalties and forfeitures mentioned and referred to in the said above-recited Act, passed in the thirty-ninth year of His present Majesty : And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly. To His Royal Highness the PRINCE REGENT.

The Address of the undersigned Protestant Noblemen, Gentlemen, Clergy, Freeholders, and Inhabitants of the County of Kildare.

May it please your Royal Highness,

WE, His Majesty's most dutiful and loyal subjects, the undersigned Protestant Noblemen, Gentlemen, Clergy, Frecholders and Inhabitants of the County of Kildare, beg leave to approach your Royal Highness with sentiments of the most perfect attachment to your Royal Highness's person, family and government, and with the most unbounded admiration and gratitude for the dignified. William Raper, Gent. to be Quarter-Master. Dated temper, moderation, firmness and wisdom with March 9, 1810. which your Royal Highness administers the government of this great empire. We beg leave to represent to your Royal Highness that the countenance afforded of late, by persons of great cminence and power, to the demands of the Roman Catholies, which now extend to the total repeal of all the disabilities that still continue to affect them, has filled us with the greatest alarm, and impells us humbly to implore your Royal Highness's protection against this dangerous innovation, which, if achieved, would change the whole character and principles of the State, the succession to the Crown, and the establishment of the Church, in itself a revolution.

That the same laws, framed on the same principles, and administered by the same tribunals, protect alike the property and the persons of the Roman Catholics and the Protestants, and the free exercise of their religion is enjoyed under the most perfect and extended toleration, leaving the chief, if not the only object of the proposed repeal, the acquirement of political power, by admission to Parliament, and to every office in the State, whatever he its description.

That the Constitution having been finally (and we trust irrevocably) established at the Revolution, on the basis of the Protestant Religion, and the State thereby rendered wholly Protestant, it cannot, as we humbly apprehend, admit those who profess the Popish Religion to participate in its government, or in the formation or the administration of its laws, much less can it entrust the superintendance and protection of its religion to men who, by the tenets of their faith, declared by themselves to be immutable, are bound to its extirpation.

History has already warned us of the calamities that result from the admission of Popish counsels in the dreadful events that preceded and led to the revolution, while our own experience supplies, in the unexampled prosperity of the empire, the happrest proof of the blessings derived from their exclusion.

That in addition to the dangers so justly to be dreaded in a Protestant State from the political influence of the Popish Religion, we cannot contemplate without dismay the rashness of admitting into the legislature, and to the powers of government, those who are bound by their religion to a foreign power: the obedience required by this strange but paramount allegiance has been alledged. it is true, to extend to objects of a spiritual nature only, but no subtlety of language or of thought can separate the subjects purely spiritual in all their bearings from those of temporal concern, so as effectually to prevent in practice the exercise of such an authority from extending even to matters of State.

That at so late a period as 1789 the authority of the Pope interposed in England between the Sovereign and his subjects, and that too in the manner of testifying their allegiance, (the oath being as-sumed to be a spiritual act); and thus a measure, involving the temporal interests of a numerous class of His Majesty's subjects, and anxiously wished for by them, was totally defeated by the authority of the Pope, exercised through his Apostolic

That when, amidst so many perils, we look around for the benefits by which they are to be compensated, we can find nothing but promised forbearance and conditional loyalty.

We beg leave further to represent to your Royal Highness, that concessions to the Roman Catholics, instead of producing the promised satisfaction and expected gratitude, appear to have been uni-formly collsidered by them as beneficial only so far as they might afford more powerful means of aggrandizement, and have served only to excite new demands, urged by louder clamours and bolder efforts for disturbance.

That it is therefore vain to expect at their hands, whatever be the concession, even from the unconditional surrender of all they now demand, such a change, either in opinion or feeling, as would lead to the future tranquillity of Ireland'; on the con-trary, the powers thereby conceded would open more extended views to individual ambition, and, by affording more effectual means, excite the more ardent pursuit of ulterior objects, already suggested by some of their leaders-the aggrandizement of their hierarchy, the ascendancy of their religion, the subversion of the Protestant Church, the possession of its revenues and of the forfeited estates, with others possibly of more remote contemplation.

Already have those leaders moulded their followers into an instrument of party, assuming the exclusive and arbitrary direction of the elective franchise of the whole Catholic population of Ireland, denouncing all candidates who do not support the principles and the men they are pleased to approve.

An usurpation so monstrous and so tyrannical may well teach the Catholics themselves how little liberty would be permitted, even to them, under the domination of their own religion, and furnishes to all other men such a warning as must appal their most enthusiastic advocates.

That under the Constitution, framed and administered as it has been, and under the auspices of your Royal Highness's most august Father, the inhabifants of the British Islands have enjoyed an extent of regulated liberty unknown to any other portion of the human race in any age or country; and the empire has risen to a degree of power and renown Devond all former times, secure in its own great-ness, amidst the wreck of nations, the refuge of the oppressed, the avenger of the wrongs and assertor of the independence of Europe.

While we thus deduce the glories of the British Empire, and the happiness of millions, from the Constitution as it stands, we cannot suppress our humble, but most anxious hopes, that it may long remain unchanged, to dispense to future ages, under the protection of your Royal Highness and your Hlustrious family, the inestimable blessings of liberty

Under these impressions, therefore, we beg leave with all humility to implore your Royal Highness to preserve the Constitution as established at the Revolution, Protestant in Church and State, and that the laws by which the Roman Catholics are excluded from power may not be repealed.
