

cence and permission that he may accept and wear the insignia of an Honorary Knight Commander of the Royal Portuguese Military Order of the Tower and Sword, with which His Royal Highness the Prince Regent of Portugal has honoured him, in testimony of the high sense which that Prince entertains of the distinguished courage and intrepidity displayed by the said Lieutenant-Colonel Mac Bean in several actions with the enemy in the Peninsula: Provided nevertheless, that His Majesty's said licence and permission doth not authorize, and shall not be deemed or construed to authorise the assumption of any style, appellation, rank, precedence, or privilege appertaining unto a Knight Bachelor of these Realms.

And His Royal Highness hath been further pleased to command, that the said royal concession and declaration be registered, together with the relative documents, in His Majesty's College of Arms.

His Royal Highness the Prince Regent hath been pleased, in the name and on the behalf of His Majesty, to declare and ordain, that Catherine Frances Feilding, Mary Anne Feilding, and Emily Feilding, daughters of William Robert Feilding (commonly called Viscount Feilding) deceased, and sisters of William Basil Percy, now Earl of Denbigh, Viscount Feilding, and Baron Feilding in England, also Earl of Desmond, Viscount Callan, and Baron Feilding in Ireland, shall from henceforth have, hold, and enjoy the same titles, place, preheminance and precedence as if their said late father had succeeded to the said dignities of Earl of Denbigh, &c.

And also to command, that the said order be registered in His Majesty's College of Arms.
