#### PRESENT,

His Royal Highness the PRINCE REGENT in Council.

WHEREAS it has been represented to His Royal Highness the Prince Regent, that, on the recapture of ships and goods belonging to His Majesty's subjects, whereof the owners and proprietors are entitled to the restitution on salvage as by law established, losses have been occasioned by the sale of ships and cargoes, on the unlivery thereof by authority of the Courts of Vice-Admiralty, for the purpose of settling the salvage due thereon, in cases wherein the owners and pro-prictors, or their agents specially authorised, are

not present to claim;

His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, is pleased, by and with the advice of His Majesty's Privy Council, to order, and it is hereby ordered, that, in the cases aforesaid, on a claim being given for the ship by the master, or in his absence by the mate; and for the cargo, by the supercargo or master, or by the mate in the absence of the master, the Court shall direct a valuation of the ship and cargo to be made by appraisement without sale or unlivery, as far as the same shall be practicable; and on such valuation to be approved and confirmed by the Court, shall direct the ship and cargo to be restored to the person or persons aforesaid claiming the same, on payment of the proportion decreed to be paid to the captors, in lieu of salvage, and of such costs and expences as shall be directed by the Court; and in default of such payment, the Court shall order and direct so much of the cargo to be sold as shall be sufficient for the payment of the salvage and expences due thereon; and further so much of the said cargo as shall be sufficient to pay the salvage and expences due on the ship, if the person or persons to whom the cargo shall be restored by decree of the Court shall consent thereto.

T the Court at Carlton-House, the 30th of the Court proceed to order the ship or goods to be sold or unlivered, save as aforesaid, unless such sale or unlivery shall, owing to special circumstances, become necessary; in which case the reasons on which the Judge shall proceed to make such order, shall be noted summarily in the minutes of Court: and the Right Honourable the Lords Commissioners of the Admiralty, the Judge of the High Court of Admiralty, and the Judges of the Courts of Vice-Admiralty, are to take the necessary measures herein as to them may respectively apportain. Extract of a Letter from Captain De Courcy, of His Majesty's Sloop Mutine, addressed to Rear-Admiral Lord Amelius Beauclerk, and transmitted by Admiral Sir Robert Calder to John Wilson Croker. Esq.

His Majesty's Sloop Mutine, at Sea, April 18, 1813.

HAVE great pleasure in acquainting your Lord-ship, that yesterday morning, while in execution of your Lordship's orders, at daylight, a strange ship was discovered on our lee bow, to which chace was given immediately; at two P. M. the stranger hoisted French colours, and commenced a fire from her stern guns, which, disabling us in our sails and rigging, occasioned us to drop a-stern; at forty minutes past eight, being again within gun-shot, he hoisted a light, and opened a fire from his broadside, which was continued until forty-five minutes past ten, when his maintop gallant-masts and jibs being shot away, we were enabled to close him; still it was not until after a spirited resistance of fifty minutes, that at half past eleven she hauled down her colours. I am convinced that had the action taken place during the day, it would have been of much shorter continuance: she proved to he L'Invincible privateer corvette, of Bayonne, Martin Jortis, Commander, pierced for twenty guns, mounting sixteen, viz. twolve eighteen-pounder carronades (French calibre) and four long sixes, And it is further ordered, that in no case shall with a complement of eighty-six men (partly Ame-

It gives me pleasure to state to your Lordship, that no loss has been sustained on my side, save two men slightly wounded; our standing and running rigging and sails much cut, and masts wounded.

#### Whitehall, May 11, 1813.

As several Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late Majesties King George the First and Second, and of His present Majesty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them: And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

#### Statute 5 George I. Chap. 27.

F any person shall contract with, entice, or solicit, any artificer in wool, iron, steel, brass, or other metal, clock-maker, watch-maker, or any other artificer of Great Britain, to go into foreign countries out of the King's dominions, and shall be convicted thereof, upon indictment or in-formation in any of the Courts at Westmiuster, or at the Assizes or Quarter Sessions, he shall be fined any sum not exceeding ONE HUNDRED POUNDS for the first offence, and shall be imprisoned three months, and till the fine be paid. And if any person having been once convicted shall

the Court, and imprisoned twelve months, and till

the fine be paid.

If any of the King's subjects, being such artificers, shall go into any country out of His Majesty's dominions, to exercise or teach the said trades to foreigners; and if any of the King's subjects in any such foreign country, exercising any of the said trades, shall not return into this realm within six months after warning given by the Ambassador, Minister, or Consul of Great Britain, in the country where such artificers shall be, or by any person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this realm; such persons shall be incapable of taking any legacy, or of being an executor or administrator, or of taking any lands, &c. within this kingdom, by descent, devise, or purchase, and shall forfeit all lands, goods, &c. within this kingdom, to His Majesty's use, and shall be deemed alien, and out of His Majesty's protection.

Upon complaint made, upon oath, before any Justice of Peace, that any person is endeavour-ing to seduce any such artificer, or that any such artificer hath contracted or is preparing to go out of His Majesty's dominions, for the purposes aforesaid, such Justice may send his warrant to bring the person complained of before him, or before some other Justice; and if it shall appear by the oath of one witness, or by confession, that he was guilty of any of the said offences, such Justice may bind him to appear at the next Assizes or Quarter Sessions: And if such person shall refuse to give security, the Justice may commit him to gaol till the next Assizes or Quarter Sessions, and until he shall be delivered by due course of And if any such artificer shall be convicted, upon indictment, of any such promise, contract, or preparation to go beyond the seas, for the purpose aforesaid, he shall give such security to the King not to depart out of His Majesty's dominions, as such Court shall think reasonable, and shall be imprisoned till security given.

If any of the above offences shall be committed

in Scotland, the same shall be prosecuted in the

Court of Justiciary or the Circuits there.

#### Statute 23 George H. Chap. 13.

IF any person shall contract with, or endeavour to seduce any artificer in wool, mohair, cotton, or silk, or in iron, steel, brass, or other metal, or any clock-maker, watch-maker, or any other artificer in any other of the manufactures of Great Britain or Ireland, to go out of this kingdom or Ireland into any foreign country not within the dominions of the Crown of Great Britain, and shall be convicted, upon indictment or information, in the King's Bench at Westminster, or by indictment at the Assizes or General Gaol Delivery for the county, &c. wherein such offence shall be committed in England, or by indictment in the Court of Justiciary or any of the Circuit Courts in Scotland, or by indictment or information in the King's Bench at Dublin, if such offence be committed in Ireland; the person so convicted shall, for every artificer contracted with or seduced,

diffend again, he shall be fined at the discretion of forfeit FIVE HUNDRED POUNDS, and shall suffer imprisonment in the common gaol of the county or stewartry wherein such offender shall be convicted for twelve calendar months, and until forfeiture be paid: And in case of a subsequent offence of the same kind, the persons so again offending shall forfeit, for every person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer imprisonment in the common gaol of the county or stewartry wherein such offender shall be convicted, for two years, and until such forseiture be paid.

If any person in Great Britain or Ireland shall put on board any ship or boat, not bound directly to some port in Great Britain or Ireland, or to some other of the dominions of the Crown of Great Britain, any such tools or utensils as are commonly used in, or proper for the preparing, working up, or finishing of the woollen or silk manufactures, or any part of such tools, he shall, for every offence, forfeit all such tools, or parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by action of debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's warehouses, all such tools or utensils prohibited to be exported, as such officer shall find on board any vessel not bound directly to some port in Great Britain or Ireland, or to some other of the dominions of the Crown of Great Britain; and all tools so seised shall, after condemnation, be publicly sold to the best bidder; and one moiety of the produce shall be to the use of His Majesty, and the other moiety to the officer who shall seize

and secure the same.

If the Captain of any vessel in Great Britain or Ireland knowingly permit any of the said tools, prohibited to be exported, to be put on board his vessel, he shall, for every such offence, forfeit ONE HUNDRED POUNDS, to be recovered as the penalties inflicted upon persons exporting the tools; and, if the vessel belongs to His Mathe Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forfeit his employment, and be incapable of any employment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ircland, take, or knowingly suffer to be taken, any entry outward, or sign any cocket or sufferance for the shipping or exporting of any of the said tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his office, and be incapable of any office

under His Majesty.

One moiety of the forfeitures shall be applied to the use of His Majesty, and the other moiety to the use of the person who shall sue for the

Statutes 14, 21, 25, and 26 of His present Majesty. BY these Statutes the like penalties and forfeitures as above-mentioned are extended to persons packing or putting on board any vessel, not bound directly for some port in Great Britain or Ireland, any machine, engine, tool, press, paper, utensil, or implement whatsoever, used in or proper for the working or finishing of the cotton, steel, or iron manufactures of this kingdom, or any part or parts of such machines or implements, or any models or plans thereof; and all Captains of ships and other persons receiving or being in possession of any such articles, with an intent to export the same to foreign parts, and all Custom-house Officers suffering an entry to be made thereof, are respectively liable to the like penalties as are above-mentioned, in the case of tools and utensils used in the woollen and silk manufactures.
