HEREAS by an Act, passed in the fortythird year of the reign of His present Majesty, intituled "An Act for permitting certain goods imported into Great Britain to be secured " in warchouse without payment of duty," it is amongst other things enacted, that it shall and may be lawful for the importer or importers, proprietor or proprietors, consignee or consignees of any of the goods, wares, or merchandise enumerated or described in the table thereunto annexed marked (E), and which shall have been legally imported or brought into the Port of London, to lodge and secure in a warehouse or warehouses, to be provided for that purpose, any such goods, wares, or mer-chandise under the joint locks of the Crown and the merchant, without payment at the time of the first entry of the duties of Customs due on the importation thereof; and it is by the said recited Act further enacted, that if the Lord High Treasurer, or the Commissioners of His Majesty's Treasury for the time being, or any three or more of them, shall deem it expedient that the provisions of the said Act should be extended to any goods, wares, and merchandise not enumerated or described in either of the tables annexed thereto, and should cause a list of such goods, wares, and merchandise to be published in the London Gazette, then and from thenceforth all and every the provisions, regulations, and restrictions of the said Act shall extend to such goods, wares, and merchandise, in every respect in as full and ample a manner as if the same had been inserted and enumerated in the said tables respectively at the time of passing the said Act:
