HE following Address was presented to His Royal Higgses the Print Part of His Royal Higness the Prince Regent, on Wed-nesday the 29th of June 1814, at Wansted-House, Essex, the Residence of William Pole Tylney Long Wellesley, Esq. the Lord Warden of the Forest of Essex :

To His Royal Highness George Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

May it please your Royal Highness,

WE, the Lord Warden, the Verderers, the Lieutenant, the Riding Forester, the Purlieu Ranger, and the Chief Foresters of His Majesty's forest of Essex, humbly beg leave to offer to your Royal Highness the tribute of our respectful loyalty and dety.

In this house the once exiled, but now restored royal family of France, for many years found a refuge; that the august head of that family is now recalled to the throne of his ancestors, is, under Providence, to be attributed to those councils which, first adopted under the sway of your Royal Highness's ever-to-be revered parent, have been perseveringly pursued by the wisdom of your Royal Highness, and so ably carried into effect by the

valour of the British fleets and armies. Some of your Royal Highness's predecessors have delighted in enjoying the pleasures of the chace within this forest; should your Royal Highness ever be desirous of partaking of that recreation, it will be no less our happiness than it is our duty to attend your Royal Highness on that occasion : your Royal Highness would then have the opportunity of observing, in a forest in the immediate vicinity of the metropolis, features of heauty and grandeur not less worthy of your Royal Highness's

observation, than those in more distant parts of the kingdom.
