A PROCLAMATION,

For recalling and prohibiting His Majesty's naturalborn Subjects from serving in the Sea or Land Forces of the United States of America. GEORGE, P.R.

HEREAS by the ancient law of this realm, founded upon the principles of general law, the natural-born subjects of His Majesty cannot, either by swearing allegiance to other Princes or States, or by any other their own acts, or by the acts of any foreign Princes or States, either alone or concurring with their own, discharge themselves, or be discharged, from the natural allegiance which, from their birth, they owe to His Majesty, His heirs and successors, which natural allegiance being antecedent and paramount to any other claim of allegiance whatsoever, cannot, by these or any other such acts, be withdrawn or cancelled: And whereas it hath been represented to Us, that divers of the natural-born subjects of His Majesty have accepted letters of naturalization, or certificates of citizenship, from the United States of America, and have sworn allegiance to the said States, and professed to renounce the natural allegiance which they owe, and must continue to owe, to His Majesty, His heirs and successors, and have, in violation of such natural allegiance, engaged by sea and land, in hostile and traitorous acts against His Majesty: And whereas some of the said natural-born subjects of His Majesty may have been induced so to act, from an erroneous persuasion and belief, which they may have been led to entertain, that their duty of natural allegiance was capable of being dissolved or withdrawn from His Majesty, His heirs and successors; We have, therefore, thought fit, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, to issue this Proclamation, hereby warning all the natural-born subjects of His Majesty, that the natural allegiance which they owe, and of right ought to bear and pay, to His Majesty, His heirs and successors convert either by their same successors convert either by their and successors, cannot, either by their own acts, or by the acts of any foreign Princes or States, either alone, or concurrent with their own, be dissolved or withdrawn from His Majesty, His heirs or successors: And We have further thought fit, in the name and on the behalf of His Majesty, and by and with the advice aforesaid, in consideration that some of the said natural-born subjects of His Majesty, may, through delusion or error, have so acted

as aforesaid, by this Proclamation to publish and I declare, that all such the said natural-born subjects of His Majesty who, having so acted, shall, within four months from the date hereof, withdraw themselves from the service of the sald. United States, shall receive His Majesty's free and gracious pardon: And We do, moreover, in the name and on the behalf of His Majesty, and by and with the advice aforesaid, hereby also publish and declare, that all natural-born subjects of His Majesty who shall hereafter voluntarily enter, or, having entered, shall voluntarily continue to serve in the land forces, or on board any of the ships or vessels of war, of the said United States of America, or in the private ships or vessels of war belonging to the citizens of the said States at enmity with His Majesty, being thereby guilty of high treason, shall be punished with the utmost severity of the law.

THEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the twenty-first day of January last, for prohibiting the exportation out of this kingdom, or carrying coastwise, gunpowder or salt petre, or any sort of arms or animunition, will expire on the eighth day of August next; and whereas it is judged expedient for His Majesty's service, and the safety of this kingdom, that the said prohibition should be continued for some time longer; His Royal Highness, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months, to commence from the eighth day of August next, presume to transport into any parts out of this kingdom, or carry coastwise, any gunpowder or sast petre, or any sort of arms or aumunition, or ship or lade any gunpowder or salt petre, or any sort of arms or ammunition, on board any ship or wessel, in order to transporting the same into any parts beyond the seas, or carrying the same coastwise, without leave or permission in that be-half first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by on Act, passed in the twenty-ninth year of His late Majesty's reign, intituled "An Act to empower " His Majesty to prohibit the exportation of salt petre, and to enforce the law for empowering Ilis Majesty to prohibit the exportation of gun" powder, or any sort of arms or ammunition, and also to empower His Majesty to restrain the earrying coastwise of salt petre, gunpowder, or any sort of arms or ammunition: But it is His Royal Highness's pleasure, that nothing in this Order contained shall prevent the exportation of any of the articles, specified in the Order in Council of the twentieth of May one thousand eight hunand thirteen. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain. HEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the twenty-first day of January last, prohibiting, in the name and on the behalf of His Majesty, the transporting into any parts out of this kingdom of any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sheet copper, or other naval stores, will expire upon the eighth day of August next; and whereas it is judged expedient for His Majesty's service, and the safety of this kingdom, that the said prohibition should be continued for some time longer, except as to the article of sheet copper; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth therefore hereby order, require, prohibit, and command, that no person or persons whosoever do, at any time for the space of six months from the said eighth day of August next, presume to transport into any parts out of this kingdom, any pig iron, bur iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, howsprits, oars, oakum, sailcloth or canvas, or other naval stores (sheet copperexcepted), or do ship or lade any pig iron, bar iron,. hemp, pitch, tar, rosin, turpentine, anchors, cables,. cordage, masts, yards, bowsprits, oars, oakum, sailcloth or carwas, or other naval stores (sheet copper excepted), on board any ship or vessel, in order to. transporting the same into any parts beyond the seas,.. without leave or permission first being and and obtained from His Majesty or His Privy Council, upon pain of incurring the forfeitures inflicted. by an Act, passed in the thirty-third year of His Majesty's reign, intituled, "An Act to enable " His Majesty to restrain the exportation of navalstores, and more effectually to prevent the exportation of salt petre, arms, and ammunition, when prohibited by Proclamation or Order in " Council;" But it is nevertheless His Royal Highness's pleasure, that nothing herein contained shall Lords Commissioners of His Majesty's Treasury extend, or be construed to extend, to any of His Majesty's ships of war, or any other ships or vessels or boots in the service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any ship or vessel from taking or baying on board such quantities of naval stores as may he necessary for the use of such ship or vessel during the course of her intended voyage, or by licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the time being; nor to the exportation of the said several articles to Ireland, or to His Majesty's yards or garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies; provided that, upon the exportation of any of the said articles for the purposes of trade to Ireland, or to His Majesty's yards and garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to the island of Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies, the exporters of such articles do first make oath of the true destination of the same to the places for which they shall be entered outwards, before the entry of the same shall be made, and do give full and sufficient security by bond (except as hereinafter excepted), to the satisfaction of the Commissioners of His Majesty's Customs, to carry the said articles to the places for which they are so entered outwards, and for the purposes specified, and none other; and such bond shall not be cancelled or delivered up, until proof be made to the satisfaction of the said Commissioners, by the production, within a time to be fixed by the said Commissioners and specified in the bond, of a certificate or certificates, in such form and manner as shall be directed by the said Commissioners, shewing that the said articles have been all duly landed at the places for which they were entered outwards. But it is His Royal Highness's pleasure, nevertheless, that the following articles, viz. bar iron, white and tarred rope, yellow or mill grease, tarpaulins for waggen covers, pitch, tar, and turpentine, shall be permitted to be exported, upon payment of the proper duties, without bond being entered into by the merchant exporter, to any of the British plantations in the West Indies, or to any of His Majesty's settlements in South America; provided the merchant exporter shall first verify, upon oath, that the articles so exported are intended for the use of a particular plantation or settlement, to be named in the entry outwards, and not for sale, and that the said plantation or settlement has not before been furnished with any supply of the said articles during the same season; and provided also that the exportation of the said articles shall in no case exceed the value of fifty pounds sterling for any given plantation or settlement, whether by one or more shipments, within the same season: and the Right Honourable the

The humble and dutiful Address of the Freeholders, Justices of the Peace, Commissioners of Supply, and Heritors of the County of Linlingow.

WE, His Majesty's most loyal and dutiful subjects, the Frecholders, Justices of the Peace, Commissioners of Supply, and Heritors of the County of Linlithgow, beg leave humbly to offer to your Royal Highness our hearty congratulations on the glorious result of that great and ardnous contest,.. in which the British empire has been so long engaged.

In reviewing the unparalleled events that haveduring that period occurred, we; in common with our fellow subjects, feel a generous pride in reflect-ing, that throughout this long and obstinate struggle, amidst the wreck of the ancient governments of surrounding nations, the British people have been enabled, under Divine Providence, tooppose with success tyrannical oppression, to standforth on all occasions the bulwark of the libertiesof Europe, and, by exhibiting a noble example of steady perseverance, contribute, in a pre-eminent degree, to keep alive the almost extinguished flame of national independence, and at length succeed inrousing the Continental nations to those magnanimous efforts, which have at last accomplished their:

It is with deep satisfaction that we beg leave to assure your Royal Highness of the lasting gratitude, not only of ourselves,' and our fellow citizens, but also, we may with confidence venture to add, that of Europe, of the world, and of posterity, for your steady adherence to those enlightened and vigorous councils, which, originally adopted by our venerable and ever-to-be-respected Sovereign, and since persevered in by your Royal Highness, have enabled this great and happy nation to bear so great a part in restoring to mankind the blessings of order, of

liberty, and legitimate government.

That your Royal Highness may long live to witness and to share the blessings you have so largely contributed to diffuse, and that His Majesty's subjects may continue to persevere in that course of steady loyalty to their King, and unshaken attachment to their Constitution, which have carried them through such unprecedented difficulties, shall ever be the ardent prayer of the Freeholders, Justices of the Peace, Commissioners of Supply, and Heritors of the county of Linlithgow.

WE, His Majesty's dutiful and loyal subjects, the Nobility, Gentry, Clergy, Freeholders and other Inhabitants, of the County of Hertford, beg leave to approach your Royal Highness, with our heartfelt congratulations upon the late anspicious termination of the long and inveterate hostilities in which the country has been engaged. Upon this occasion we are called upon in a more especial ness our sincere and heartfelt congratulations on

manner, to express our approbation of the wise and liberal principles upon which the late great combination of the powers of Europe has been formed, and of the skill, perseverance and unanimity, with which their operations have been conducted. We. cannot but feel peculiar exultation in the many splendid victories by sea and land, which have attended His Majesty's arms, during this arduous contest; and it appears to us but justice to bestow: our cordial praise, upon the firm and cautious councils which have produced the desired result of military exertion, in a pacification honourable and advantageous, and concluded upon such terms as: afford the most reasonable prospect of permanence and security. Under such circumstances it would naturally be our anxious wish to avoid all topics, except those of satisfaction and congratulation, but. we could not observe without the deepest sorrow, the introduction into the treaty with France, of a privion for the revival and continuance by that power, for a certain period, of the African slave After the repeated discussions, through investigations and legislative enactments, which have taken place upon this subject, it is entirely unnecessary for us, again to enumerate the melancholy catalogue of dangers, miseries and horrors, which have been proved to accompany and follow this remorseless and inhuman traffic. It is equally superfluous to point out that, which is but too obvious, the deeper distress and more aggravated misfortune, both to the Europeon settlements in the West-Indies, and to the continent of Africa, which must attend a renewal of this nefarious practice underthe stipulation of the present treaty. reasons, however, we abstain from delivering any. opinion upon the political necessity, which has been stated to have induced His Majecty's negotiators to consent to the admission of such an article, but more particularly because we have heard with great satisfaction, the gracious answer of your Royal Highness to both Houses of Parliament, that they may rely upon the unremitting exertions of your Royal Highness, for the abolition of the slave trade, and in consequence of this solemn pledge on the part of the highest authorities in the realm, we rest assured that the most effectual measures will be taken at the approaching congress, and upon every future occasion, to procure as speedily and as universally as possible, the extinction of a system repugnant to every sentiment of humanity, and incompatible with the most sacred duties of the Christian religion.

WE, His Majesty's most dutiful and loyal subjects, the Inhabitants of the Town of Birmingham, beg leave to present to your Royal Highness our sincere and heartfelt congratulations on those great events, which, through the interposition of Divine Providence, have been passing in such rapid succession before our eyes, and which have finally rescued the Continent of Europe from the miseries inseparably attendant upon a state of warfare.
