WARRANT granting an Increase in the Rates of Half-Pay to Officers who may be reduced upon the Formation of a Peace Establishment, or who may have been placed on Half-Pay in the Course of the late. War, on Account of Wounds or Instructed upon Service.

By His Royal Highness the PRINCE REGENT of the United Kingdom of Great Britain and Ireland. GEORGE, P. R.

E, having taken into Our gracious consideration the distinguished conduct of the Officers of the Army in the course of the late war, are pleased, in the name and on the behalf of His Majesty, to mark Our sense of their services, by granting an increase in the rates of half-pay to the Officers of the Line who shall be reduced upon the formation of a peace establishment, or who may have been placed on half-pay in the course of the war, on account of wounds or of infirmities contracted upon service; the same to commence from 25th June 1814, with respect to Officers reduced at that date, according to the following scale, viz.

For recalling and prohibiting His Majesty's naturalborn Subjects from serving in the Sea or Land Forces of the United States of America.

THEIVEAS by the ancient law of this realm, founded upon the principles of general low,

T the Court at Carlton-House, the 15th of | the natural-born subjects of His Majesty cannot, either by swearing allegiance to other Princes or States, or by any other their own acts, or by the acts of any foreign Princes or States, either alone or concurring with their own, discharge themselves, or be discharged, from the natural allegiance which, from their birth, they owe to His Majesty, His heirs and successors, which natural allegiance being antecedent and paramount to any other claim of allegiance whatsoever, cannot, by these or any other such acts, be withdrawn or cancelled. And whereas it hath been represented to Us, that divers of the natural-born subjects of His Majesty have accepted letters of naturalization, or certificates of citizenship, from the United States of America, and have sworn allegiance to the said States, and professed to renounce the natural allegiance which they owe, and must continue to owe, to His Majesty, His heirs and successors, and have, in violation of such natural allegiance, engaged by sea and land, in hostile and traitorous acts against His Majesty: And whereas some of the said natural-born subjects of His Majesty may have been induced so to act, from an erroneous persuasion and belief, which they may have been led to entertain, that their duty of natural allegiance was capable of being dissolved or withdrawn from His Majesty, His heirs and successors; We have, therefore, thought fit, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, to issue this Proclamation, hereby warning all the natural born subjects of His Majesty, that the natural allegiance which they owe, and of right ought to bear and pay, to His Majesty, His heirs and successors, cannot, either by their own acts, or by the acts of any foreign Princes or States, either alone, or concurrent with their own, be dissolved or withdrawn from His Majesty, His heirs or successors: And We have further thought fit, in the name and on the behalf of His Majesty, and by and with the advice aforesaid, in consideration that some of the said natural-born subjects of His Majesty, may, through delusion or error, have so acted as aforesaid, by this Proclamation to publish and declare, that all such the said natural-born subjects of His Majesty who, having so acted, shall, within four months from the date hereof, withdraw themselves from the service of the said United States, shall receive His Majesty's free and gracious pardon: And We do, morcover, in the name and on the behalf of His Majesty, and by and with the advice aforesaid, hereby also publish and declare, that all natural-born subjects of His Majesty who shall hereafter voluntarily enter, or, having entered, shall voluntarily continue to serve in the land forces, or on board any of the ships or vessels of war, of the said United States of America, or in the private ships or vessels of war belonging to the citizens of the said States at enmity with His Majesty, being thereby guilty of high treason, shall be punished with the utmost severity of the law.

To His Royal Highness George Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

- May it please your Royal Highness,

WE, His Majesty's dutiful and loyal subjects, the Deputies from the several Congregations of Protestant Dissenters of the Three Denominations, residing in and about the Cities of Longon and Westminster, humbly beg leave to approach the throne to offer to your Royal Highness our warmest congratulations on the successful and glorious termination of the late tremendous contest; protracted by the gigantic efforts of a mad and unprincipled ambition, till Europe has been convulsed to its centre, and millions involved in misery and ruin.

In contemplating this grand event, while we admire the fortitude and bravery of our illustrious Allies, we cannot but exult in the accession of glory which Britain has obtained from the part she has taken in the conflict; nor do we less applaud that spirit of magnanimity and moderation which ruled the allied councils in the hour of triumph, and contributed so largely to the accomplishment of a pacification on which we trust that we may safely build the hope of permanent peace and happiness. Above all, we desire to bow in grateful adoration before that over-ruling Providence whose wise and beneficent hand has conducted us through so many perils, to a state of quiet and security:

But, feeling on all these topics only in common with our fellow subjects, we cannot as Protestant Dissenters approach your Royal Highness's presence to expresss our sentiments of the just and equitable spirit of your Royal Highness's government as conspicuous of these most important and wide spreading concerns, without at the same time taking occasion to acknowledge the advantage we have derived from the extension of its influence to ourselves. WE, the Nobility, Gentry, Clergy, Freeholders, and Inhabitants of the County of Leicester, beg leave unanimously to lay before your Royal Highness our unfeigned congratulations on the successful and glorious issue of the arduous contest in which we have been so long engaged against the late aggressive Government of France; and in retracing the various and complicated evils to which this country and the world have been unremittingly exposed in the late sanguinary war, we cannot fail to express the honest satisfaction with which we contemplate the loyal and unceasing fortitude manifested by every description of His Majesty's faithful subjects; and humbly to assure your Royal Highness, that had not the greatest dispensations of Providence removed from us the sad necessity, we should still have cheerfully continued our great exertions, in the full conviction, that as early as possible the care of your Royal Highness would procure for us the restoration of those blessings attendant upon a permanent and honourable

We further beg leave at this auspicious moment to assure your Royal Highness, that, under that Power which disposes of the fate of nations, we cannot but attribute our present proud pre-eminence amongst mighty empires, to the vigorous and decisive measures wisely adopted and persevered in by your Royal Highness, in concert with our august Allies; and after the many sacrifices occasioned by this long and arduous warfare, we are happy in reflecting, that the splendour of our arms by sea and by land has only been equalled by our moderation in the hour of victory; that our efforts and example have mainly tended to strengthen and cement that grand alliance, which, springing from the insufferable miseries of conquered and afflicted nations, was brought into successful action by the fostering aid of our national character and resources, and has at length procured the only legitimate objects of war, security and peace.

That in this dignified and successful assertion of national honour and the general interests of mankind, we further beg leave to congratulate your Royal, Highness on the partial success of that benevolent interference which has procured from the governments of Holland and of Sweden, the immediate and total abolition of the African slave trade; but with a most painful sincerity lament that a just recognition of these suffering rights of humanity could not be at once obtained from the government of France to the same extent. We confidently hope, however, that every measure will be adopted in the renewed negociation with France, and in the general Congress about to be held at Vienna, to prevail upon all the Powers there assembled, to concur as early as possible in the total

ings of the enlightened age in which we live.

We finally beg leave to congratulate your Royal Highness on the brighter prospects now opened by these great achievements, and implore the blessings of Providence in turtherance of that just cause which, in its signal success, has established the thonour, the freedom, and the welfare of European nations: and we trust that the malignant and infuriated councils of America, which have not listened to the voice of moderation, will, ere long, be taught, by the more vigorous measures reluctantly adopted by your Royal High sess against that still unfriendly Power, to acknowle ge those national rights which she would perversely efface from the code of nations and of nature.

To His Royal Highness the Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

May it please your Royal Highness,

WE, His Majesty's most dutiful and loyal subjects, the Nobility, Gentry, Clergy, and Freeholders, of the County of Essex, beg leave to offer to your Royal Highness, our warm and dutiful congratulations, on the happy event of the reestablishment of general tranquillity in Europe.

We saw with the highest satisfaction, its greatest Monarchs renouncing their former jealousies and differences, and uniting their councils and arms in the sacred cause of national independence. cordially rejoice in the success with which their noble exertions have been crowned, and particularly in the downfall of that military despotism, which had reduced France to the most degrading servitude, and had spread desolation over so large a

part of the civilized world.

We reflect with exultation, on the part which our own country has borne in this great contest, in the triumphs which have been achieved by the valour and discipline of the British fleets and armies, and by the talents and patriotism of their great commanders; and while we are duly grateful to that Providence, which has exempted us from those dreadful calamities by which every other country in Europe has been successively afflicted, in becoming the theatre of this long and widely extended war; we have derived from its final result, additional grounds for cherishing that free and happy constitution, which is at once the pride and bulwark of our country, the object of all our exertions, and the source of all our strength.

In venturing to approach your Royal Highness, with these ser inents of pride and gratification, we can lot help limenting, that by a carticle in the Treaty, the Fra ch government have not acceded to the complete abolition of the African slave trule; the prospect of its continuance, even for a limited time, has occasioned in the minds of all classes o His Majesty's subjects, sensations of the deepes concern; though they are indeed alleviated by you

abolition of a traffic so repugnant to the best feel- I Royal Highness will use your best exertions at the approaching congress, for the attainment of an alteration in this part of the definitive treaty.

Under these impressions, we presume to entertain a well-grounded hope, that by your Royal Highness's powerful influence, aided by that of your illustrious Allies, the French government may be still induced to give effect to the unqualified extinction of a traffic so repugnant to our feelings as a nation, and so disgraceful to Europe.

THereas it hath been humbly represented to His Royal Highness the Prince Regent, Royal Highness's gracious assurance, that your that, on the morning of Monday the 11th day of July last, between the hours of one and two o'clock, Elizabeth Noyce, late of the parish of Fawley, in the county of Southampton, widow, deceased, was found in a field of Mr. Covey's, in the said parish, but a very short distance from her own house, lying upon her side in a state of total insensibility, with her face covered with dirt; and her nostrils filled, apparently for the purpose of producing suffocation: and whereas about ten minutes after nine o'clock in the evening of Sunday the previous day, she was seen to go from ber, own house up the roadway which bounds Mr. Covey's field, having stated that she was going to a house at the other end of the village: and whereas the said Elizabeth Noyce lingered until Friday the 15th day of the same month of July, and then died, having during that period some short inter-vals of understanding, in the course of which she three times declared to a Magistrate, that she was knocked down by a violent blow in the back part of the head, which stunned her instantly; that she did not see the person who struck her, but that she heard him distinctly come out of Mr. Covey's field, over the gate, and walk behind her: and whereas there is no doubt but the said Elizabeth Noyce was barbarously and cruelly murdered, by being knocked down in the road, and afterwards dragged through the gateway and thrown down in the corner of the field where she, was found; a stake of uncommon size being found near the gate the sext morning .

His Royal Highness, for the better apprehending and bringing to justice the actual perpetrator of this wicked murder, is hereby pleased, in the name and on the behalf of His Majesty, to promise His Majesty's most gracious pardon to any person or persons concerned therein (except the person who actually committed the said murder), who shall discover his, her, or their accomplices or accomplices therein, so that he, she, or they may be apprehended and convicted thereof.

REGULATIONS IN RESPECT TO THE HALF-PAY AND APPOINTMENT OF MASTERS OF THE ROYAL NAVY.

Admiralty-Office, July 26, 1814.

III IS Royal Highness the Prince Regent having been graciously pleased to approve of certain regulations, proposed by the Lords Commissioners of the Admiralty, for the encouragement and re-ward of Masters of the Royal Navy, and for regulating the appointment of this highly meritorious and useful class of Officers, notice is hereby given, that the following regulations have been established, by Order in Council, dated the 23d justant :-

I .- 'That Masters, on their first appointments, shall be allowed their travelling expences, at the same rate, and in the same manner, as the Licu-' tenants of His Majesty's Fleet.

II .- That, in lieu of the half-pay established for Masters in the Royal Navy, by the 7th article of the Order in Council of 15th August 1805, and the regulations appertaining thereto, the following rate of half-pay shall be established and allowed, from the 1st July instant, viz.:-

To the first 100 Masters, being qualified for

Ist and 2d rates, 7s. per diem.
To the next 200 being qualified for 3d and 4th rates, 6s. per diem.

The remainder, 5s. per diem.

The said rates of half-pay for Masters to be subject to the same regulations and restrictions as the half-pay of the Commissioned Officers of ' the Fleet, and also to the following regulations,

' That such Master as shall have served five years ' in His Majesty's Navy, two of which as Acting "Master, Second Master, Master's-Mate, or Midshipman, previously to receiving an appointment as Master, shall be entitled to half-pay inmediately on his being put out of commission.

That such Master as shall have served as aforesaid, in His Majesty's Navy, but not hor the full space of five years, shall be entitled to half-pay only when the time of his service as Master, added to that before passed in the King's Service, shall complete the said period of five years.

And that such as shall have been appointed . Master without having previously served in the Royal Navy, shall be entitled to half-pay, after having served as Master five years. But that no · Master shall be permitted in time of war, on any account whatever, to receive half-pay during such time as he shall be employed in the merchant service, or in any other occupation, unless sufficient proof be adduced to the Commissioners of the Navy, that such person is, from infirmity of body, absolutely incapable of performing the duty of a Master in His Majesty's Navy.

III .- ' And His Royal Highness has been further " graciously pleased to direct, that Masters of the Royal Navy, instead of being required, as at present, to pass an examination before the Master and Wardens of the Corporation of Trinity House, · for each rate of ships separately, shall be required only to pass an examination touching their qualifications to serve as Masters of the following rates jointly:

First and second rates jointly. Third and fourth rates jointly. Fifth and sixth rates jointly. Sloops and smaller vessels jointly.

-' And in order to prevent any unnecessary or improvident increase of the number of Masters, and, at the same time to ensure, that all persons warranted as Masters in His Majesty's Navy, be men of experience and judgment.

'That no person shall be warranted as Master, until the number of Masters on the list be reduced below the number of ships on the list of the navy (exclusive of such as are building, and have not been launched), and that no more Masters shall be ever appointed, than the number of such ships at the time that any appointment of Master is to be made.

'That no person shall be allowed to pass an examination touching his qualifications to serve as Master in the Royal Navy before he shall have attained the age of twenty-one years, or after the age of thirty-five years, and have been at least seven years at sea, two of which must have been served in His Majesty's Navy in the quality of Acting Master by order, Second Master, Master's-Mate, or Midshipman, or being within the aforesaid ages, and having served seven years at sea, shall have actually been one year or more Chief Mate, and two years Master, or two years Chief Mate, and one year Master of a merchant ship; and shall produce certificates of diligence, sobriety, and good conduct, from the owners; for the time he served as Master, and from the Owners and . Master for the time he served as Mate.

! That no Master shall be permitted to pass his

' examination for a higher rate, until he shall have served one complete year in a ship in commission, under his last qualification.' J. W. CROKER.

REGULATIONS IN RESPECT TO THE HALF-PAY, APPOINTMENT, AND RANK, OF PURSERS OF THE ROYAL NAVY.

Admiralty-Office, July 26, 1814.

S Royal Highness the Prince Regent having been graciously pleased to approve of certain regulations proposed by the Lords Commissioners of the Admiralty, for the encouragement and reward of Pursers of the Royal Navy, and for regulating the appointment, and fixing the rank of this useful and deserving class of Officers: Notice is hereby given, that the following regulations have been established by Order in Council, dated the 23d instant; and that orders have been in consequence given for the immediate discharge of all Pursers from ships in ordinary and the cheque of the several yards.

1. That Pursors of the Royal Navy, instead of heing considered as standing Warrant Officers of His Majesty's ships, and borne in ships in ordinary, or on the chequenat, the several dock-yards for personal pay and allowances of provisions, as at present, shall, when the ships to which they are warranted may be paid off, be immediately discharged, and allowed in lieu of their present wages and provisions, half-pay according to the following scale, ziz,

To the first 100 Pursers on the Seniority List, 5s. per diem.

The next 200, 4s. per diem. The remainder, 3s. per diem.

The said half-pay of Pursers shall commence from the 1st of July instant, and be subject to the same regulations and restrictions as the half-pay of the Commissioned Officers of His Majesty's fleet, and be allowed to all Pursers, who shall have been five years in His Majesty's service, either as Clerk or Purser, from the day on which their respective ships may be put out of commission.

That all pursers coming on half-pay shall report themselves to this Office, without loss of time, in order to be placed on the Quarterly half-pay Lists. on pain of forfeiting the half-pay for the time not reported.
