THEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the twenty-third day of July last, for prohibiting the exportation out of this kingdom, or carrying coastwise, gunpowder or salt petre, or any sort of arms or ammunition, has expired; and whereas it is judged expedient for His Majesty's service, and the safety of this kingdom, that the said prohibition should be continued for some time longer; His Royal Highness, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to commence from the date of this Order), presume to transport into any parts out of this kingdom, or carry coastwise, any gunpowder or salt petre, or any sort of arms or ammunition, or ship or lade any gunpowder or salt petre, or any sort of arms or ammunition, on board any ship or

parts beyond the seas, or carrying the same without leave or permission first being had and ob-coastwise, without leave or permission in that be-tained from His Majesty or His Privy Council, half first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled "An Act to empower " His Majesty to prohibit the exportation of salt petre, and to enforce the law for empowering His Majesty to prohibit the exportation of gunpowder, or any sort of arms or ammunition, and also to empower His Majesty to restrain the " carrying coastwise of salt petre, gunpowder, or any sort of arms or ammunition:" But it is His Royal Highness's pleasure, that nothing in this Order contained shall prevent the exportation of any of the articles, specified in the Order in Council of the twentieth of May one thousand eight hundred and thirteen, to the coast of Africa, under the conditions contained in the said Order. HEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the twenty-third day of July last, prohibiting, in the name and on the behalf of His Majesty, the transporting into any parts out of this kingdom of any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, or other naval stores; has expired; and whereas it is judged expedient for His Majesty's service, and the safety of this kingdom, that the said prohibition should be continued for some time longer; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth therefore hereby order, require, prohibit, and command, that no person or persons whosoever do, at any time for the space of six months from the date of this Order, presume to transport into any parts out of this kingdom, any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sail-cloth or canvas, or other naval stores (sheet copper excepted), or do ship or lade any pig iron, bar iron, hemp, pitch, tar, rosin, turpentine, anchors, cables, cordage, masts, yards, bowsprits, oars, oakum, sailcloth or canvas, or other naval stores (sheet copper excepted), on board any ship or vessel, in order to transporting the same into any parts beyond the seas,

tained from His Majesty or His Privy Council, upon pain of incurring the forfeitures inflicted by an Act, passed in the thirty-third year of His Majesty's reign, intituled, "An Act to enable " His Majesty to restrain the exportation of naval stores, and more effectually to prevent the exportation of salt petre, arms, and ammunition, when prohibited by Proclamation or Order in Council;" But it is nevertheless His Royal Highness's pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majesty's ships of war, or any other ships or vessels or boats in the service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Ma-jesty's Navy; nor to prevent any ship or vessel from taking or having on board such quantities of naval stores as may be necessary for the use of such ship or vessel during the course of her intended voyage, or by licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the time being; nor to the exportation of the said several articles to Ireland, or to His Majesty's yards or garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies; provided that, upon the exportation of any of the said articles for the purposes of trade to Ireland, or to His Majesty's yards and garrisons, or to His Majesty's colonies and plantations in America or the West Indies, or to the island of Newfoundland, or to His Majesty's forts and settlements on the coast of Africa, or to the island of Saint Helena, or to the British settlements or factories in the East Indies, the exporters of such articles do first make oath of the true destination of the same to the places for which they shall be entered outwards, before the entry of the same shall be made, and do give full and sufficient security by bond (except as hereinafter excepted), to the satisfaction of the Commissioners of His Majesty's Customs, to carry the said articles to the places for which they are so entered outwards, and for the purposes specified, and none other; and such bond shall not be cancelled or delivered up, until proof be made to the satisfaction of the said Commissioners, by the production, within a time to be fixed by the said Commissioners and specified in the bond, of a certificate or certificates, in such form and manner as shall be directed by the said Commissioners, shewing that the said articles have been all duly landed at the places for which they were entered outwards. But it is His Royal Highness's pleasure, nevertheless, that the following articles, viz. bar iron, white and tarred rope, tallow or mill grease, tar paulins for waggon covers, pitch, tar, and tur-pentine, shall be permitted to be exported, upon payment of the proper duties, without bond being entered into by the merchant exporter, to any of the British plantations in the West Indies, or to any of His Majesty's settlements in South America; provided the merchant exporter shall first verify, upon oath, that the articles so exported are

intended for the use of a particular plantation or settlement, to be named in the entry outwards, and not for sale, and that the said plantation or settlement has not before been furnished with any supply of the said articles during the same scason; and provided also that the exportation of the said articles shall in no case exceed the value of fifty pounds sterling for any given plantation or settlement, whether by one or more shipments, within the same scason: and the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary directions herein as to them may respectively appertain.

BY THE LORDS COMMISSIONERS OF HIS MAJESTY'S TREASURY.

THEREAS by an Act, passed in the fortysixth year of the reign of His present Majesty, intituled " An Act for altering and en-' larging the powers of an Act, made in the forty-"third year of His present Majesty, for the further improvement of the port of London, by making " docks and other works at Blackwall, for the " accommodation of the East India shipping in " the said port," it is (amongst other things) re-

cited and enacted as follows:

" And whereas the said East India Dock Company have, in execution of the said Act, made in the forty-third year of the reign of His present Majesty, formed two docks at Blackavall aforesaid, called an outer and an inner dock: And whereas the quays or wharfs surrounding such outer dock are bounded on the north side by the wall which separates the same from the inner dock : on the south side by the River Thames; at the cast end by the entrance bason and locks leading from the River Thames to the inward dock; and at the west end by the ship-builders yard, in the occupation of Messrs. Perry and Wells: And whereas it may not be necessary that such outer dock should be intirely surrounded by a high wall; be it therefore enacted, that when and as soon as it shall appear to the Lord High Treasurer, or any three or more of the Commissioners of His Majesty's Treasury for the time being, that such outerdock is well and sufficiently inclosed and defended, although such outer dock shall not be intirely surrounded by a high wall or walls, then and in such case it shall and may be lawful for the Lord High Treasurer, or any three or more of the Commissioners of His Majesty's Treasury for the time being, to certify, by warrant under his hand or their hands, that such outer dock is well and sufficiently inclosed and defended, and upon such certificate being granted as aforesaid, the quays and wharfs which shall be built or made by the said Directors within or along the sides or banks of such onter dock, shall at all times, from and after the date of such certificate, be deemed and taken, and are hereby declared to be, to all intents and purposes whatsoever, legal quays and wharfs for lading and shipping of any goods, wares, or mer-chandise whatsoever within the port of London,

save and except for the lading and shipping of such goods, wares, and merchandise as are or shall be subject or liable to any duty or duties of Excise, any law, statute, usage, or custom, or any thing herein contained, to the contrary thereof in anywise notwithstanding.

We, the undersigned, Lords Commissioners of His Majesty's Treasury, do, in pursuance of the said Acts of Parliament, passed in the forty-third and forty-sixth years of His present Majesty's reign, certify, that the following works, made and erected by the East India Dock Company, under the authority of the said Acts of Parliament, are well and sufficiently inclosed and defended for the reception of ships, and for lading and shipping of goods, wares, and merchandise; that is to say,

The outer or export dock lying between the inner or import dock and the River Thames, at Blackwall aforesaid, with the quays or wharfs on the banks or sides of the said outer or export dock.
