public Thanksgiving be reverently and decently observed by all His Majesty's loving subjects in Scot-land, on the said eighteenth day of January next, as they tender the favour of Almighty God, and would avoid His wrath and indignation, and upon pain of such punishment as may be justly inflicted on all such as contemn or neglect the performance of so religious a duty: Our will and pleasure is, therefore, and We charge, that this Our Proclamation seen, ye pass to the Market-Cross of Edinburgh, and all other places needful, and there, in His Majesty's name and authority, make publication thereof; that none pretend ignorance: and Our will and pleasure is, that His Majesty's Solicitor do cause printed copies hereof to be sent to the Sheriffs of the several shires, Stewarts of stewartries, and Bailiffs of regalities, and their Clerks, whom We ordain to see the same published; and We appoint them to send copies thereof to the several parish churches within their bounds, that, upon the Lord's Day immediately preceding the day above-mentioned, the same may be published and read from the pulpits immediately after Divine Service.
