The Lords of His Majesty's Most Honourable Privy Council.

HEREAS by an Act, passed in the forty-fifth year of His Majesty's reign, intituled " An Act for making further provisions for the " effectual performance of quarantine," it is, amongst other things, enacted, that it shall and may be lawful for the Lords and others of His Majesty's Privy Council, or any three or more of them, to make such Order as they shall see necessary and expedient upon any unforeseen emergency, or in any particular case or cases with respect to any ship or ships, vessel or vessels arriving and having any infectious disease or distemper on board, or on board of which any infectious disease or distemper may have appeared in the course of the voyage, or arriving under any other alarming or suspicious circumstances as to infection, although such ship or ships, vessel or vessels, shall not have come from any place or places from which His Majesty, His heirs or successors, by and with the advice of His or Their Privy Council, may have adjudged and declared it probable that the plague or any such infectious disease or distemper may be brought, and also with respect to the persons, goods, wares, and merchandise on board the same, and all such Orders so made by the Lords and others of the Privy Council, or any three or more of them as aforesaid, shall be as good, valid, and effectual to all intents and purposes (as well with respect to the Commander, Master, or other person having the charge of any such ship or vessel,

and all other persons con board the same, as with respect to any other persons having any intercourse or communication with them, and to the penalties, forfeitures, and punishments to which they may respectively become liable) as any Order or Orders made by His Majesty, His heirs or successors, by and with the advice of His or Their Privy Council concerning quarantine, and the prevention of infection as aforesaid, and notified by Proclamation,

or published in the London Gazette:

And whereas advices have been received that the plague has made its appearance at Noya and along the Coast of the Adriatic, and at Corfu and the territories contiguous to Fiume, and in the Peninsula of Istria, and it appearing by such advices, that all vessels from suspected places have been forced to quit the Neapolisan harbours; and will in all probability take shelter in French or Spanish ports where they will evade the quarantine laws; it is thereupon ordered in Council, that all ships or vessels coming from and through the Mediterranean, within the Streights of Gibraltar (although furnished with clean bills of health), shall, on arrival at any of the ports of the United Kingdom, be freated as vessels arriving with suspected bills; and shall be subject to all the rules, regulations, and restrictions, pains, penalties, forfeitures, and multishinents contained in His Majesty's Order in Council, bearing date the fifth day of April one vessels arriving with suspected bills of health: And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for conjuning the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief for the time being of the Isles of Guernsey, Jersey, Alderney, Sark, and Man, are to give the necessary directions herein, as to them may respec-Jas. His Royal Highness the Prince Regent in Council of the twentieth day of July last, for prohibiting the exportation out of this kingdom, or carrying coastwise, gunpowder or salt-petre, or airy sort of arms or ammunition, will expire on the thirteenth day of this instant February and whereas it is judged expedient, that the said prohibition, so far as applies to the countries hereinafter named, should be continued for some this tonger; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons

It any person shall contract with, satisfe, or says.

Light, any artificer in wood, iron, steel, brass. or other metal, clock-maker, watch-maken or any other artificer of Great Britains to go into foreign countries out of the King's dominious, and shall be convicted thereof, upon indictment or information in any of the Courts at Westminster, of at the fessues or Openter Sessions, he shall be fined are supported for the first office, and shall be imprisoned three months, and till the fine be paid. If any of the King's subjects, being such artificers, shall go into any country out of His Majest is dominions, to exercise or teach the said trades to foreigners; and if any of the King's subjects in any such foreign country, exercising any of the said trades, shall not return into this realm within six months after, warning given by the Ambassador, Minister, or Consul of Great British. trin, in the country where such artificers shall be, or by any person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from lienceforth inhabit within this realm; such persons shall be incapable of taking any legacy, or of being an executor or administrator, or of taking any lands, &c. within this kingdom, by descent, devise, or parchase; and shall forfeit all lands, goods, &c. within this kingdom, to His Majesty's use, and shall be deement after, and out of His Majesty's

protection.

"Uson complaint made, upon oath, before any Justice of Peace, that any person is endeavouring to seduce any such artificer, or that any such artificer hath contracted or is preparing to go out of His Majesty dominions, for the purposes aloresaid, such Justice may send his warrant to bring the person complained of before him, or hetere some other justice; and if it shall anyear herore some other Justice; and if it shall appear by the oath of one witness, or by confession, that he was guilty of any of the said offences, such Justice may bind him to appear at the next Assizes or Quarter Sessions: And if such person shall refuse to give security, the Justice may commit him to gaol till the next Assizes or Quarter Sessions, and until he shall be delivered by due course of law. And if any such artificer shall be convicted, upon indictment, of any such promise, contract, or preparation to go beyond the seas, for the purpose aforesaid; he shall give such security to the King not to depart out of His Majesty's do-minions, as such Court shall think reasonable, and shall be imprisoned till security given.

If any of the above offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary or the Circuits there.

If the Captain of any vessel in Great Britain or Ireland knowingly permit any of the said tools, prohibited to be exported, to be put on board his vessel, he shall, for every such offence, forfeit ONE HUNDRED POUNDS, to be recovered as the penalties inflicted upon persons exporting the tools; and, if the vessel belongs to His Ma-

BY these Statutes the like penalties and forfeitures as above-mentioned are extended to persons packing or putting on board any vessel; not bound directly for some port in Great Britain or Ireland, any machine, engine, tool, press, paper, utensil, or implement whatsvere, used in or proper for the working or finishing of the cotton, steel, or iron manufactures of this kingdom, or any part or parts of such machines or implements, or any or parts of such machines or implements, or any models or plans thereof; and all Captains of ships and other persons receiving or being in possession of any such articles, with an intent to export the same to foreign parts, and all Custom-house Officers, suffering an entry to be made thereof, are respectively liable to the like penalties as are above mentioned, in the case of tools and utensils. used in the woodlen and silk manufactures.
