or any such infectious disease or distemper may be brought, and also with respect to the persons, goods, wares, and merchandle on board the same, and all such Orders iso midde by the Lords and others of the Privy Council, or any three or more of them as aforesaid, shall be as good, valid, and effectual to all intents and purposes (as well with respects to the Commander, Master, or other person having the charge of any such ship or vessel, and all other persons on board the same, as with respect to any other persons having any intercourse or communication with them, and to the penalties, forfeitures, and punishments to which they may respectively become liable) as any Order or Orders made by His Majesty, His heirs or successors, by and with the advice of His or Their Privy Council concerning quarantine, and the prevention of in-fection as aforesaid, and notified by Proclamation, or published in the London Gazette :

And whereas advices have been received that the plague has made its appearance at Noya and along he Coast of the Adriatic, and at Corfu and the cerritories contiguous to Fiume, and in the Peninala of Istria, and it appearing by such advices, hat all vessels' from suspected places have been orced to guit the Neapolitan harbours, and will in ll probability take shelter in French or Spanish ports where they will evade the quarantine laws; it is thereupon ordered in Council, that all ships or vessels coming from and through the Mediterrancan, within the Streights of Gibraltar (although furnished with clean bills of health), shall, on arrival at any of the ports of the United Kingdom, be treated as vessels arriving with suspected bills; and shall be subject to all the rules, regulations, and restrictions, pains, penalties, forfeitures, and punishments contained in His Majesty's Order in Council, bearing date the fifth day of April one thousand eight hundred and five, with respect to vessels arriving with suspected bills of health : And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, His Majesty's Secretary 'at War, and the Governors or Commanders in Chief for the time being of the Isles of Guernsey, Jersey, Alderney, Sark, and Man, are to give the necessary directions herein, as to them may respectively appertain. His Royal Highness, for the better apprehending and bringing to justice the persons concerned in the atrocious act above mentioned, is hereby pleased, in the name and on the behalf of His Majesty, to promise His Majesty's most gracious pardon to any one of them (except the person who actually set fire to the said stacks of wheat), who shall discover his, her, or their accomplice or accomplices therein, so that he, she, or they may be apprehended and convicted thereof.
