His Royal Highness the PRINCE REGENT in Council.

THEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the twelfth day of February last, for prohibiting the exportation out of this kingdom, or carrying coastwise, gunpowder or salt-petre, or any sort of arms or ammunition, will expire on the thirteenth day of this instant August; and whereas it is judged expedient, that the said prohibition, so far as applies to the countries hereinafter named, should be continued for some time longer; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to com-mence from the said thirteenth day of this instant August), presume to transport any gunpowder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa, or in the pertain.
