Gaby and Dowling, were maliciously destroyed by fire, together with a very large quantity of flour, wheat and other property, then being therein;

His Royal Highness the Prince Regent, acting in the name and on the behalf of His Majesty, for the better apprehending and bringing to justice the persons concerned in sending the said threatening letter, or in serting fire to the said mills, is hereby pleased to promise His most gracious pardon to any one of them, (except the person who actually wrote the said letter, or actually set fire to the said mills), who shall discover his, her or their accomplice or accomplices therein, so that he, she or they may be apprehended and convicted thereof.
