Regent proceeded in state from St. James's Palace to the House of Lords, where he arrived at two o'clock; and, having alighted from the state coach, he was received at the portico by the Great Officers and others, and proceeded to the robing room in the usual manner; His Royal Highness was there robed, his hat on his head, and the procession moved into the house in the following order:

His Royal Highness the PRINCE REGENT.

His Royal Highness being seated on the throne, the Great Officers and others standing on the right and left, Sir Thomas Tyrwhitt, Gentleman Usher of the Black Rod, was sent with a message from His Royal Highness to the House of Commons, commanding their attendance in the House of Peers. The Commons being come thither accordingly, His Royal Highness, in the name and on the behalf of His Majesty, was pleased to deliver the following most gracious speech to both Houses of Parliament:

My Lords, and Gentlemen,

IT is with deep regret that I am again obliged to announce to you, that no alteration has occurred in the state of His Majesty's lamented indisposition.

I continue to receive from foreign powers the strongest assurances of their friendly disposition towards this country; and of their earnest desire to maintain the general tranquillity.

The hostilities to which I was compelled to resort, in vindication of the honour of the country, against the Government of Algiers, have been attended with the most complete success.

The splendid achievement of His Majesty's fleet, in conjunction with a squadron of the King of the

Serjeants at Arm

Netherlands, under the gallant and able conduct of Admiral Viscount Exmouth, led to the immediate and unconditional liberation of all Christian captives then within the torritory of Algiers, and to the renunciation by its Government of the practice of Christian slavery.

I am persuaded that you will be duly sensible of the importance of an arrangement so interesting to humanity, and reflecting, from the manner in which it has been accomplished, such signal honour on the British nation.

In India the refusal of the Government of Nepaul to ratify a treaty of peace, which had been signed by its Plenipotentiaries, occasioned a renewal of military operations.

The judicious arrangements of the Governor-General, seconded by the bravery and perseverance of His Majesty's forces, and of those of the East India Company, brought the campaign to a speedy and successful issue; and peace has been finally established upon the just and honourable terms of the original treaty of Land and the warrant

They have been formed upon a full consideration of all the present circumstances of the country, with an atixious desire to make every reduction in our establishments which the safety of the empire and sound policy allow. In a 18 days

. I recommend the state of the public income and expenditure to your early and serious attention.

I regret to be under the necessity of informing you, that there has been a deficiency in the produce of the revenue in the last year; but I trust that it is to be ascribed to temporary causes; and I have the consolation to believe, that you will find it practicable to provide for the public service of the year, without making any addition to the burthens of the people; and without adopting any measure injurious to that system by which the public credit of the country has been hitherto sustained.

My Lords, and Gentlemen,

I have the satisfaction of informing you, that the arrangements which were made in the last session of Parliament, with a view to a new silver coinage, have been completed with unprecedented

I have given directions for the immediate issue of the new coin, and I trust that this measure will

be productive of considerable advantages to the trade and internal transactions of the country.

The distresses consequent upon the termination of a war of such unusual extent and duration have been felt, with greater or less severity, throughout all the nations of Europe; and have been considerably aggravated by the unfavourable state of the season.

Deeply as I lament the pressure of these evils upon this country, I am sensible that they are of a nature not to admit of an immediate remedy; but whilst I observe with peculiar satisfaction the fortitude with which so many privations have been borne, and the active benevolence which has been employed to mitigate them, I am persuaded that the great sources of our national prosperity are essentially unimpaired, and I entertain a confident expectation that the native energy of the country will at no distant period surmount all the difficulties in which we are involved.

In considering our internal situation, you will, I doubt not, feel a just indignation at the attempts which have been made to take advantage of the distresses of the country, for the purpose of exciting a spirit of sedition and violence." "

I am too well convinced of the loyalty and good sense of the great body of His Majesty's subjects, to believe them capable of being perverted by the arts which are employed to seduce them; but I am determined to omit no precautions for preserving the public peace, and for counteracting the designs of the disaffected: and I rely with the utmost confidence on your cordial support and co-operation, in upholding a system of law and government, from which we have derived inestimable advantages, which has enabled us to conclude, with unexampled glory, a contest whereon depended the best interests of mankind, and which has been hitherto felt by ourselves, as it is acknowledged by other nations, to be the most perfect that has ever fallen to the lot of any people.

A PROCLAMATION.

GEORGE, P. R.

THEREAS on the twenty-eighth day of this instant month of January divers persons, riotously assembled and stationed in different places in the City of Westminster, proceeded to commit certain daring and highly criminal outrages, in gross violation of the public peace, to the actual danger of Our Royal Person, and to the interruption of Our passage to and from the Parliament; we therefore, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, in pursuance of an address from the two Houses of Parliament, do hereby enjoin all Magistrates, and all other His Majesty's loving subjects, to use their utmost endeavours to discover and cause to be apprehended the authors, actors, and abettors concerned in such outrages, in order that they may be dealt with according to law: And We do hereby promise, that any person or persons, other than those actually concerned in doing any act by which Our Royal Person was immediately endangered, who shall give information, so as that any of the authors, actors, or abettors concerned in such outrages as aforesaid, may be apprehended and brought to justice, shall receive a reward of

ONE THOUSAND POUNDS,

to be paid on conviction of every such offender; which said sum of one thousand pounds the Lords Commissioners of Ilis Majesty's Treasury are hereby required and directed to pay accordingly: And We do further promise, that any person or persons concerned in such outrages as aforesaid, other than such as were actually concerned in any act by which Our Royal Person was immediately endangered, who shall give information, so as that any of such authors, actors, or abettors as aforesaid, shall be apprehended and brought to justice, shall, upon conviction of such offender or offenders, receive His Majesty's most gracious pardon.

HEREAS by Our Proclamation, bearing date the eighteenth day of this instant, We thought fit, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, in pursuance of an Act passed in the fifty-sixth year of His Majesty's reign, intituled "An Act to provide for a new " silver coinage, and to regulate the currency of " the gold and silver coin of this realm," to name and appoint the third day of February now next ensuing, as the day from and after which, and from thence until the seventeenth day of February then next ensuing, as the period of time during which it should and might be lawful for any person or persons to deliver into His Majesty's Mint any old silver coin, heretofore coined and current, which should by any officer or officers of the said Mint, to be appointed for that purpose by the Master of the Vint, be judged and deemed to be such silver coin of this realm; and the said third day of February now next ensuing as the day from and after which. and from thence until the seventeenth day of February then next ensuing, as the period of time during which there should be delivered out of the said Mint, new silver coins, as in the said Act is

mentioned, pursuant to the regulations and directions thereof: And whereas We have thought fit, by and with the advice of His Majesty's Privy Council, to postpone the commencement of the period of time during which it shall and may be lawful for any person or persons to deliver into His Majesty's said Mint any such old silver coin, and during which there shall be delivered out of the said Mint new silver coins of equal amount according to the respective denominations of the said silver: We do hereby, in the name and on the behalf of His Majetsy, and by and with the advice of His Majesty's Privy Council, revoke and discharge Our said Proclamation of the Eighteenth of this instant January: and We do by this Proclamation, by and with the advice of His Majesty's Privy Council, name, and appoint the thirteenth day of February now next ensuing, as the day from and after which, and from thence until the twenty-seventh day of February then next ensuing, as the period of time during which it shall and may be lawful for any person or persons to deliver into His Majesty's said Mint any such old silver coin, and the said thirteenth day of February now next ensuing, as the day from and after which, and from thence until the twenty-seventh day of February then next ensuing, as the period of time during which there shall be delivered out of the said Mint new silver coins, as in the said Act is mentioned, pursuant to the regulations and directions thereof.

"between His Majesty's said subjects and the
"Foreign Islands in the West Indies," it is,
amongst other things, enacted, that it shall and
may be lawful for His Majesty in Council, by

Order or Orders to be issued and published from time to time, to authorise, or by Warrant or Warrants under His sign manual, to empower the Governor of Newfoundland for the time being, to authorise, in case of necessity, the importation into Newfoundland of bread, flour, Indian corn. and live stock, from any of the territories belonging to the said United States, for the supply of the inhabitants and fishermen of the Island of Newfoundland, for the then ensuing season only; provided always, that such bread, flour, Indian corn. and live stock, so authorised to be imported into the Island of Newfoundland, shall not be imported except in conformity to such rules, regulations, and restrictions as shall be specified in such Order or Orders, Warrant or Warrants respectively, and except by British subjects, and in British-built ships, owned by His Majesty's subjects, and navigated according to law:

And whereas it is expedient and necessary, that provision be made for fully supplying the inhabitants and fishermen of the Island of Newfoundland, for the ensuing season, with bread, flour, Indian corn, and live stock, His Royal Highness the Prince Regent doth thereupon, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, hereby order and declare, that for the supply of the inhabitants and fishermen of the Island of Newfoundland, for the ensuing season only, bread, flour, Indian corn, and live stock, may be imported into the said island from any of the territories belonging to the said United States, by British subjects, and in British-built ships, owned by His Majesty's subjects, and navigated according to law, and which within the space of nine months previous to the time of such importation, have cleared out from some port of the United Kingdom. of Great Britain or Ireland, or other His Majesty's dominions in Europe, for which purpose a licence shall have been granted by the Commissioners of His Majesty's Customs in England or Scotland, or the Commissioners of His Majesty's Revenue in Ireland, or any other person or persons who may be duly authorised in that kingdom respectively, in the manner and form herein-after mentioned; which licence shall continue and be in force for nine calendar months from the day of the date upon which such licence is respectively granted, and no longer; provided that no such licence as aforesaid, granted after the thirtieth day of September next, shall be of any force or effect: and His Royal Highness is hereby further pleased to order, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, that the master or person having the charge or command of any ship or vessel to whom such licence shall be granted, shall, upon the arrival of the said ship or vessel at the port, harbour, or place in the said Island of Newfoundland where he shall discharge such bread, flour, Indian corn, and live stock, deliver up the said licence to the Col-lector or other proper Officer of the Customs there, having first indorsed on the back of such licence the marks, numbers, and contents of each package of bread, flour, Indian corn, and the number of live stock, under the penalty.

of the forfeiture in the said Act mentioned; and the Collector or other proper Officer of the Customs at Newfoundland, is hereby enjoined and required to give a certificate to the master or person having the charge or command of such ship or vessel, of his having received the said licence so indorsed as before directed, and to transmit the same to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland, respectively, by whom such licence was granted.

Now be it known, that the said [person's name] hath a licence to lade on board the said ship, [ship's name] at and from any port or place belonging to the United States of America, bread, flour, Indian corn, or live stock, the produce of the said United States, and no other article whatever; and to carry the said bread, flour, Indian corn, and live stock, to some port or place in the Island of Newfoundland; and on the arrival of the said ship at any port, harbour, or place of discharge in Newfoundland, the master or person having the charge or command of the said ship, is required and enjoined to deliver up the said licence to the Collector or other proper Officer of His Majesty's Customs there, and to indorse on the back thereof the marks, numbers, and contents of each package of bread, flour, Indian corn, and the number of live stock, and shall thereupon receive a certificate thereof from the said Collector or other proper Officer of the Customs.

WHEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the third day of August last, for prohibiting the exportation out of this kingdom, or carrying coastwise, gunpowder or salt-petre, or any sort of arms or ammunition, will expire on the thirteenth day of February next; and whereas it is judged expedient, that the said prohibition, so far as applies to the countries hereinafter named, should be continued for some time longer; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to com-mence from the said thirteenth day of February next), presume to transport any gunpowder or salt-petre, or any sort of arms or annumition, to any port or place on the Coast of Africa, or in the West Indies, or on any part of the Continent of America (except to a port or place, or ports or places, in His Majesty's territories or possessions on the Continent of North America, or in the territories of the United States of America), or ship or lade any gunpowder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places on the Coast of Africa, or in the West Indies, or on the Continent of America (except as above excepted), without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled "An Act to empower His Majesty to "prohibit the exportation of salt-petre, and to enforce the law for empowering His Majesty to prohibit the exportation of gunpowiler; or any sort of arms or ammunition, and also to empower His Majesty to restrain the carrying coastwise of salt-petre, gunpowder, or any sort "of arms or ammunition;" and also by an Act, passed in the thirty-third year of His Majesty's reign, cap. 2, initialed "An Act to enable His Majesty to restrain the exportation of naval-" stores, and more effectually to prevent the exportation of salt-petre, arms, and ammunition, when prohibited by Proclamation or Order in Council:" But it is His Royal Highness's pleasure, that nothing in this Order contained shall be construed to alter or repeal the Order in Council of the twentieth of May one thousand eight hundred and thirteen, for regulating the export of gunpowder and arms to the coast of Africa. under the conditions therein specified.
