**T**HE following Addresses have been presented to His Royal Highness the Prince Regent; which Addresses His Royal Highness was pleased to receive very graciously:

To His Royal Highness the PRINCE REGENT.

WE, the Dean and Canons of His Majesty's Free Chapel of Saint George, within His Castle of Windsor, beg leave to express our unfeigned horror at the outrageous and treasonable attack upon the Person of your Royal Highness, on your return from opening this Session of Parliament.

We entertain so deep a sense of the important benefits which we enjoy under a Constitution framed with singular wisdom for the protection of our religious and civil rights, that we are naturally led to dread the near approach of any danger which may threaten its security.

We deeply lament that the wicked counsels of evil-minded men, should have excited a rebellious spirit in the hearts of those, who, but for these evil counsellors, would never have arranged the wisdom or care of their constitutional governors, as the cause of that distress, with which it has been the will of Providence, that this nation, in common with the rest of Europe, should be visited; but for these self-constituted legislators, with the great body of the nation of all conditions, (who in every part of the kingdom now vie with each other in dutifully testifying the affection which they bear to your Royal Highness, and the confidence which they repose in the two other estates of the kingdom, that they will discreetly, faithfully, and zealously discharge their several duties,) they would patiently have acquiesced in that temporary distress, which no wisdom of human counsels could have averted or controlled, and would have continued gratefully to acknowledge the aid which the ready hand of private liberality, encouraged by the munificence of your Royal Highness, had extended, with a view of alleviating, at least their immediate wants, much less would they wantonly and maliciously have had recourse to acts of atrocious violence, or lifted up the weapons of assassination against their Protector and their Prince.

We further venture to express our confident ex-

pectations that the general declaration of the public sense of the nation, expressed in its loyal addresses on this occasion to your Royal Highness, will have a most salutary effect, and by the full avowal of its sentiments, and its firm determination to support the Constitution, as by law established, against all its enemies, will contribute to impress on the minds of the deluded partizans of disaffected and traitorous demagogues, a due sense of the wickedness and enormity of proceedings, which, instead of improving the condition of the poor, have an obvious tendency to endanger, if not destroy, the safety and happiness of all orders of society.

We have only to add our most fervent prayers that the Almighty will be graciously pleased to vouchsafe to your Royal Highness the continuance of his protection.

To His Royal Highness the PRINCE REGENT.

WE, His Majesty's dutiful and loyal subjects, the Bishop of Oxford, the Dean and Canons of Christ Church, and the Archdeacon and Clergy of the Diocese of Oxford, humbly beg leave to approach your Royal Highness with the assurance of our unshaken attachment and devotion.

We consider the unreserved avowal of our sentiments at the present crisis to be our especial duty, when we have seen your Royal Highness's Person exposed to insults the most cruel, and to an assault the most violent and atrocious; aggravated, moreover, by the time selected for the perpetration of the crimes, when your Royal Highness was actually discharging the highest functions of the Royal Authority.

We thankfully acknowledge the gracious hand of Providence in the preservation of your Royal Highness's Person, through perils so alarming and imminent, and we most heartily concur with the great mass of His Majesty's faithful people, in the strongest feelings of grief and indignation, that there exist any persons capable of being irritated to the commission of acts so dangerous to the peace of the State, as well as disgraceful to the national character.

But we trust, that the delusion of these infatuated persons is rapidly passing away. They will reflect how easy it is for a few designing men, (regardless of the fate of the wretched instruments of their treason) to turn an occasion of public difficulty to the selfish purposes of rapacity or ambition—purposes which are often best effected by plausible falsehood and base misrepresentation, artfully contrived to inflame the passions of the unthinking, and to weaken the general allegiance to lawful Government. The firm, the wise, and temperate counsels which distinguish your Royal Highness's Administration of the Royal Power, will not fail to open the eyes of the misguided; they will become sensible that the most effectual relief of their distresses, and the best security for their liberties, will be found in a dutiful respect to the laws of their country, and in the maintenance of that Constitution which has placed them under your Royal Highness's protection.

It is the earnest desire of our hearts, and the subject of our fervent prayer to Almighty God, (and we are persuaded that every rank of people throughout His Majesty's dominions, as well as those more particularly committed to our spiritual charge, will join us with one voice,) it is our earnest desire and our fervent prayer that your Royal Highness may long be preserved to us in tranquillity and happiness; ever, under the blessing of Heaven, experiencing that, to which your anxiety for the public good is justly entitled, the grateful affections of a faithful, virtuous, and united people.

To His Royal Highness the PRINCE REGENT of the United Kingdom of Great-Britain and Ireland.

*May it please your Royal Highness,*

WE, the dutiful and loyal subjects of His Majesty, the Vicar, Churchwardens, and Vestrymen of the Parish of Saint Martin, in the Fields, in Vestry assembled, impressed with a deep sense of the heinous nature of the base and traitorous act so recently committed, by which the life of your Royal Highness was endangered, and regarding, with equal grief and indignation, an offence, thus perpetrated in the face of day, against the Sovereign dignity of your sacred office, most humbly entreat permission to express our lively abhorrence and regret for this public scandal.

It is some relief to our minds to be able to contrast this instance of enormity, with the loyal spirit, unshaken zeal, and known affections of a faithful people, sincerely mindful of the blessings which they derive under the Divine favour, from that happy Constitution of which your Royal Highness is the Guardian and Defender.

We view with astonishment the violation of this exercise of the supreme Power in its salutary course, and in the moment of its application to the highest and most important of its functions. The reflection is most painful to us, that the chief authority of the State, so happily invested in your Royal Person, should receive this daring and flagitious interruption, by the criminal attempt of frantic and misguided men.

We cannot contemplate this event without much humiliation on our own parts. The name and honour of the nation would stand deeply tainted and affected by it, were it not most certain, that this crime, so foreign to the British character, is hateful in the eyes of all who are entitled in any manner to the privileges and distinctions of their country.

Were it possible to add to these general and well-founded motives for that concern, which on this occasion, must influence the heart and agitate the mind of every loyal subject of this empire, we could not fail to call to our remembrance the recent instance of paternal kindness, with which the poor inhabitants of this parish, together with those around us, have been favoured. We beg leave to assure your Royal Highness of the grateful sense which we entertain of that gracious token of peculiar bounty and indulgence, whilst we cherish in our hearts a common feeling with all those who value the religion, laws, and liberty of their country, which are fostered under its unrivalled Government, and of which they must ever form substantial parts.

Penetrated with these unfeigned convictions of what we owe to the protecting hand of Providence, we beg leave to assure your Royal Highness of our entire attachment to the rule established in this realm under a mild and equal sceptre, and of our inviolable respect for its constituted authorities in Church and State.

We desire more especially to embrace this opportunity of testifying our cordial and united wishes, and our joint prayers for the continued blessings of Divine Providence in the preservation of your Royal Highness, together with our earnest hope, that your own happiness may be increased with the welfare of the nation, and with the prosperity of a grateful and much favoured people.

WE, the Mayor, Bailiffs, Burgesses, and Freemen of the Corporation of Wexford, beg leave thus early to approach your Royal Highness, with heartfelt congratulations on your Royal Highness's late providential escape, on returning from the House of Parliament, on the 28th of January last, and with the expression of our abhorrence and indignation against the authors of the atrocious attempt.

Little indeed could we have imagined that, whilst the nations around hail your Royal Highness's name with gratitude and admiration for the unexampled wisdom, fortitude and energy, with which your Royal Highness supported the sinking liberties of Europe, and enabled her despairing sons to bring the eventful struggle to a triumphant issue, the extinction of these heroic virtues, could have been meditated by the heart, or attempted by the hand of a Briton.

Far from conceiving the present outrage to be the solitary act of an unconnected individual, we are persuaded that it is a branch, and the commencement of an extensive system, organized by men, who, however they may cloak their wicked views, under the specious veil of reform, aim at nothing less than the subversion of the law and the

Constitution; who inflame the minds of the vulgar, by descanting on imaginary grievances, and tantalize their hopes by the suggestion of impracticable remedies; and thus enlisting their prejudices and their passions, render them the blind instruments of their own abominable machinations. In devising practicable measures for the removal of real evils, which press upon us in common with the rest of the world, we are well aware that your Royal Highness is anxiously and unweariedly occupied; we look forward therefore without apprehension, fully confident, that the consummate wisdom of those counsels, which have carried us safely through a protracted period of gigantic peril, and almost desperate hazzard, will experience but a comparatively trifling difficulty, on an occasion of minor interest, and we confidently trust but of temporary duration.

For the accomplishment of this desirable object, and such other measures as may prove conducive to the welfare of the empire, we humbly beseech that Providence, which has deigned in this recent instance, to shield from the attack of the assassin, the person of your Royal Highness, still to vouchsafe to watch over and protect a life, with which the happiness and prosperity of our country are inseparably connected.

To His Royal Highness the PRINCE REGENT.

*May it please your Royal Highness,*

WE, His Majesty's dutiful and loyal subjects, the Principal and Professors of the University of Edinburgh, beg leave to present, with profound respect, to your Royal Highness, the assurance of our strong and steady attachment to your Royal Highness's Person and Family, and to the Government of which, in the name and in behalf of our venerable Sovereign, the administration is entrusted to your Royal Highness.

Cherishing that attachment, we view with deep horror and reprobation, the late insulting and flagitious assault on the Person of your Royal Highness, while in the act of discharging the high and sacred duties of the First Magistrate of the Empire. We are equally astonished and indignant at an occurrence which involves, in its principle and ten-

dency; at once a direct and dangerous aggression on the inviolability of the Crown, on the dignity of the Parliament, and on the safety of that political Constitution under which our fathers and we have enjoyed a freedom and happiness, and have acquired a glory of which no other nation of the earth could ever justly boast.

A PROCLAMATION.

GEORGE, P. R.

**W**Hereas by an Act passed in the fifty-sixth year of His Majesty's reign, intituled "An Act to provide for a new silver coinage, and to regulate the currency of the gold and silver coin of this realm," the Master and Worker of

His Majesty's Mint, in London, was authorised and empowered to coin, or cause to be coined, silver bullion into silver coins, consisting of crowns, half-crowns, shillings, and sixpences, of the standard of eleven ounces and two penny weights of fine silver, and eighteen penny weights alloy to the pound troy, and in weight after the rate of sixty-six shillings to the pound troy:

And whereas, in virtue of the powers so given, a coinage of half-crowns, shillings, and sixpences, at the rate of sixty-six shillings to the pound troy, and of the standard of fineness above-mentioned; every such half-crown piece having for the obverse impression the head of His Majesty, with the inscription "Georgius III. Dei Gratia," and the date of the year; and for the reverse, the ensigns armorial of the United Kingdom, contained in a shield, surrounded by the Garter, bearing the motto "Honi soit qui mal y pense," and the collar of the Garter, with the inscription "Britanniarum Rex Fid: Def:" with a newly invented graining on the edge of the piece; every such shilling and six penny piece having for the obverse impression the head of His Majesty, with the inscription "Georgius III. D. G. Britt. Rex. F. D." and the date of the year, and for the reverse, the ensigns armorial of the United Kingdom, contained in a shield surrounded by the Garter, bearing the motto "Honi soit qui mal y pense," with a newly invented graining on the edge of the piece, has been completed and is now ready to be delivered for the use of his Majesty's subjects; We have therefore, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, thought fit to issue this Proclamation, and we do hereby ordain, declare and command, that the said pieces of silver money shall from and after the thirteenth day of this instant February, be current and lawful money of the Kingdom of Great Britain and Ireland, and shall pass and be received as current and lawful money of the said Kingdom, that is to say, such half-crown pieces as of the value of two shillings and six pence; such shilling pieces as of the value of one shilling; and such six penny pieces as of the value of six pence, in all payments and transactions of money.

And We do hereby in further pursuance of the powers given to His Majesty by virtue of the said first recited Act, in the name and on behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, proclaim, ordain, declare and name the said thirteenth day of February as the day from and after which no tender of payment of money made in the silver coin of this realm of any sum exceeding the sum of forty shillings at any one time shall be reputed a tender in law or allowed to be a legal tender within the United Kingdom of Great Britain and Ireland, either by tale or weight of such silver coin, or otherwise howsoever.

The above-named James Watson is a Surgeon by profession, and has been employed in that capacity on board a Greenland ship: He is a young man, apparently about twenty-three or twenty-four years of age, but is only twenty, dark hair, rather pale complexion, five feet five inches high, has a mark or mole with a few hairs on it, on his left cheek bone near the eye, the left eyelid rather drooping over the eye, very faint remains of small pox in his face, has rather a wide mouth, and shews his teeth, (which are very black) when he laughs; he sometimes wore a brown great coat, black under coat, black waistcoat, drab breeches and long

gaiters, and at other times he wore a black coat and waistcoat, blue pantaloons, and Hessian boots; his appearance shabby genteel: he formerly lodged in Hyde-Street, Bloomsbury.

Arthur Thistlewood is about forty-five years of age, five feet eleven inches high, has a sallow complexion, long visage, dark hair (a little grey), small whiskers, dark hazel eyes, and arched eyebrows, a wide mouth, and a good set of teeth, has a scar under his right jaw, is slender made, walks very upright, and has much the appearance of a military man; was born in Lincolnshire, and apprenticed to an apothecary at Newark, and has been a lieutenant in the army; he usually wore a French grey coloured coat, buff waistcoat, grey coloured Wellington pantaloons, with Hessian boots under them, and at times a dark brown great coat.
