To His Royal Highness George Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland, &c. &c. &c.

The humble and unanimous Address of the Citizens of the County of the City of Waterford, assembled at their Town Hall, by public notice from the Mayor, pursuant to a requisition for that purpose.

May it please your Royal Highness,

WE, His Majesty's dutiful and loyal Subjects, the Citizens of Waterford, beg leave to approach your Royal Highness with our most sincere congratulations on the failure of that outrageous and atrocious attempt which so lately endangered the sacred Person of your Royal Highness while returning from the important discharge of your Royal Highness's functions in the Imperial Parliament.

Impelled at once both by duty and inclination, permit us to tender the unfeigned assurance of our zeal and affection for your Royal Highness's Person and Government, and at the same time to express, in the most unqualified manner, our marked abhorrence of those dangerous and delusive doctrines, which, artfully propagated by designing agitators, would ultimately tend, if not promptly and vigorously resisted, to shake to its foundation the venerable fabric of our unrivalled and glorious Constitution.

Deeply sensible of the value and importance of that Constitution, and of the blessings of Divine Providence, in preserving the life of a Prince who has uniformly persevered in promoting the best interests of this great empire, and in whose Councils have been planned all those glorious achievements by which the Tyrant of the world has been humbled, we beg leave to convey to your Royal Highness our firm and unalterable determination to rally round the Throne, and uphold, with our lives and properties, the Government and Constitu-

tion, in defiance of foreign enemies and domestic traitors.

Duly appreciating the many blessings which the people of this empire have enjoyed under the mild and beneficent sway of the illustrious House of Brunswick, we are convinced the great body of His Majesty's subjects are actuated by an unshaken devotion to your Royal Highness's Person and Family, and that there exists among them sufficient good sense as well as loyalty, successfully to resist

the arts that are used to seduce them.

Impressed with these sentiments, we beg to be permitted to express a confident hope that your Royal Highness will omit no precaution for preserving the public peace, and that the measures of your Royal Highness's Government being founded on sound and wise principles, will aid the strong disposition of the people of this united ampire to

uphold and hand down uninjured to posterity our admired Constitution.

The humble and dutiful Address of the Inhabitants of the City or Borough of Wells, and its suburbs.

May it please your Royal Highness, WE, His Majesty's most dutiful and loyal subjects, the Inhabitants of the ancient City or Borough of Wells, and its suburbs, humbly beg leave to lay before your Royal Highness the respectful assurances of our abhorrence of the late daring and atrocious outrage offered to the Person of your Royal Highness, whilst in the discharge of one of the most solemn and important of the Regal functions.

But whilst we express our detestation of the obscure perpetrators of an act so flagitious, affecting at once the safety of your Royal Highness's Person, the honour and dignity of Parliament, and the best interests of the British Empire, we should ill discharge that duty which we owe to your Royal Highness, to the public, and to ourselves, if we refrained from explicitly declaring our abhorrence of those persons who have goaded on, to the commission of these excesses, the deluded instruments of their criminal ambition.

It is, Sir, with equal indignation and disgust that we have seen the basest artifices resorted to, and most industriously employed to vilify and bring into contempt all the legally established authorities of the realm-to convert to seditious purposes, the distresses, under which the country is labouring, in consequence of a singulary unpropitious harvest, having afflicted us at the very moment when we were suffering under the effects of a long and arduous struggle for our independence-to aggravate these distresses by false suggestions, and by prejudicing the people against the means of alleviating them, and thus increasing that irritation of the public mind, which all good subjects would have been solicitous to soothe and finally, to scatter abroad the seeds of universal discontent, and insidiously to excite those disturbances of the public peace, which the authors of these artifices affect, with an ill-concealed duplicity, to deprecate and

We feel confident, however, that this recent outrage will open the eyes of the public to those practices which have led to the perpetration of it, and that in producing a firm union among all classes of His Majesty's loyal subjects, for the protection of our laws and our Constitution, it will give birth to a resolute determination, to resist the violence and counteract the arts of those disaffected persons, who, by taking advantage of the pressure of unexampled, but, (as we trust,) temporary distress, are seeking to accomplish the overthrow of both.

Relying upon the disposition of your Royal Highness's Government to adopt all proper and practicable means of alleviating the sufferings of the country—relying also upon its vigilance in detecting, and its promptitude and energy in repressing all attempts to disturb the public tranquillity, we feel a well founded hope, that, aided as your Royal Highness will be by the wisdom of Parliament, and by the efforts of a loyal people, our present difficulties will 'ere long be surmounted, and that we shall transmit, inviolate and unimpaired to our posterity, those laws, and that Constitution under which these kingdoms have so long flourished.

the hours of twelve and two in the afternoon, to nominate and choose another Peer of Scotland, to sit and vote in the House of Peers of this present Parliament of the United Kingdom of Great Britain and Ireland, in the room of the said George William Earl of Rothes, deceased, by open election and plurality of voices of the Peers that shall then be present, and of the proxies of such as shall be absent (such proxies being Peers, and producing a mandate in writing, duly signed before witnesses, and both constituent and proxy being qualified according to law), and the Lord Clerk Register, or such two of the Principal Clerks of the Session as shall be appointed by him to officiate in his name, are hereby respectively required to attend such meeting, and to administer the oaths required by law to be taken there by the said Peers, and to take their votes; and immediately after such election made and duly examined, to certify the name of the Peer so elected, and sign and attest the same in the presence of the said Peers the electors, and return such certificate into the High Court of Chancery of Great Britain. And We strictly charge and command that this Proclamation be duly published at the Market Cross at Edinburgh, and in all the county towns in Scotland, twentyfive days, at least, before the time hereby appointed for the meeting of the said Peers to proceed on such election.

crowns, shillings, and sixpences, of the standard By His Royal Highness the PRINCE of WALES of eleven ounces and two penny weights of fine silver, and eighteen penny weights alloy to the pound troy, and in weight after the rate of sixtysix shillings to the pound troy:

And whereas, in virtue of the powers so given, a coinage of half-crowns, shillings, and sixpences, at the rate of sixty-six shillings to the pound troy, and of the standard of fineness above-mentioned; every such half-crown piece having for the obverse impression the head of His Majesty, with the inscription "Georgius III. Dei Gratia," and the date of the year; and for the reverse, the ensigns armorial of the United Kingdom, contained in a shield surrounded by the Garter, bearing the motto " Honi soit qui mal y pense," and the collar of the Garter, with the inscription " Britanniarum Rex Fid: Def:" with a newly invented graining on the edge of the piece; every such shilling and six penny piece having for the obverse impression the head of His Majesty, with the inscription "Geor. III. D. G. Britt, Rex, F. D." and the date of the year, and for the reverse, the ensigns armorial of the United Kingdom, contained in a shield surrounded by the Garter, bearing the motto "Honi soit q mal y pense," with a newly invented graining on the edge of the piece, has been completed, part of which has been delivered for the use of His Majesty's subjects, and the remainder thereof is now ready to be delivered for the use of his Majesty's subjects; We have therefore, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, thought fit to issue this Proclamation; and We do hereby ordain, declare, and command, that the said pieces of silver money shall, from and after the day of the date of this Our Proclamation, be current and lawful money of the kingdom of Great Britain and Ireland, and shall pass and be received as current and lawful money of the said kingdom; that is to say, such half-erown pieces as of the value of two shillings and six pence; such shilling pieces as of the value of one shilling; and such six penny pieces as of the value of six pence; in all payments and transactions of money.

MITHEREAS an Act was passed in the fiftysixth year of His Majesty's reign, intituled An Act to provide for a new silver coinage, and " to regulate the currency of the gold and silver coin of this realm;" and whereas in pursuance of the said Act, great quantities of new silver coin have been delivered in exchange for old silver coin, current before the passing of the said Act, and further quantities are now ready to be delivered for the use of His Majesty's subjects, and it has been represented to us that some old silver coin may still remain in circulation, and we have thought it expedient that no such old silver coin of this realm should continue to be current in payment at any time after the date of this Proclamation; We have therefore, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, thought fit to issue this Proclamation: and we do hereby ordain, declare, and command, that no piece or pieces of old silver coin of this realm, current at any time before the passing of the said Act, shall pass or be current in any payment whatsoever, within the United Kingdom of Great Britain and Ireland, at any time after the date of this Proclamation: and We do hereby strictly prohibit and forbid all and every person or persons whomsoever, from and after the date of this Proclamation, to receive or utter in payment any piece or pieces of the said old silver coin: and We do hereby strictly require and command all His. Majesty's loving subjects strictly to conform to the orders hereby given, and to the directions and regulations enacted and required by the said Act of Parliament with respect to the cutting, breaking, or defacing of all such pieces of the said old silver coin as shall be of less value than the denominations thereof shall respectively import: and We being desirous as much as in Us lies to give ease tor His Majesty's subjects, and to prevent their sustaining any loss or inconvenience on account of the currency of old silver coin being prohibited as aforesaid, do hereby, in the name and on the behalf of His Majesty, authorise, command, and require the officers of His Majesty's Mint, for the space of three calendar months after the date of this Proclamation, to receive by tale only all such old silver coin of the realin, current at any time before the passing of the said 'Act,' which shall be brought by any person or persons whomsoever into His Majesty's Mint, or to any place to be appointed for that purpose by the Master and Worker of His Majesty's Mint, and which shall be of or above the several weights following, that is to say, all crown pieces which shall be of or above the weight of eighteen pennyweights, four grains, troy; all halfcrown pieces which shall be of or above the weight of nine penny weights, two grains, troy; all shillings which shall be of or above the weight of three pennyweights, fifteen grains troy; and all sixpenny pieces which shall be of or above the weight of one pennyweight, nineteen grains, troy; and to deliver out of the said Mint to every person bringing in and delivering such old silver coins, a sum in new silver coins equal to the amount of the silver coins so brought by any such person or persons as aforesaid, according to the respective denominations of such silver coins.

ATHEREAS by an Act, passed in the present session of Parliament, intituled " An Act " to continue and extend the provisions of an Act, " of the forty-ninth year of His present Majesty, " for regulating the trade and commerce to and " from the Cape of Good Hope, until the fifth " day of July one thousand eight hundred and " twenty; and also for regulating the trade of the " Island of Mauritius;" His Majesty is authorised, by and with the advice of His Privy Council, by any Order or Orders to be issued from time to time, to give such directions, and make such regulations touching the trade and commerce to and from all islands, colonies, or places, and the territories and dependencies thereof, to His Majesty belonging or in His possession, in Africa, or Asia

to the eastward of the Cape of Good Hope (excepting only the possessions of the East India. Company), as to His Majesty, in Council, shall appear most expedient and salutary, any thing contained in an Act, passed in the twelfth year of the reign of His Majesty King Charles the Second, intituled "An Act for the encouraging and increas-"ing of shipping and navigation," or in an Act, passed in the seventh and eighth years of the reign of His Majesty King William the Third, intituled " An Act for preventing frauds, and regulating " abuses in the plantation trade," or any other Act or Acts of Parliament now in force, relating to His Majesty's colonies and plantations, or any other Act or Acts of Parliament, law, usage or custom to the contrary in any wise notwithstanding: and whereas on the night of the twenty-fifth of September last, a dreadful fire broke out in the town of Port Lewis, in the Island of Mauritius, which totally destroyed the chief part of that town, together with a great mass of provisious and merchandise intended for the consumption and trade of its inhabitants, whereby a great number of families were reduced to extreme indigence, and left without a home; in consequence of which dreadful calamity the Governor of the said Island found hunself compelled to open the ports of the Island to foreign vessels, in order to afford the speediest relief of which the case would admit, and thereby to save His Majesty's subjects residing in that colony from the greatest extremity of distress; and whereas it is expedient that facilities should in consequence be granted to the trade of the Island of Mauritius, for a limited time, with the view of giving still further relief to its suffering inhabitants; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, is pleased to order, and it is hereby ordered, that all vessels, whether British or foreign vessels belonging to countries in amity with His Majesty, arriving at any port of the Island of Mauritius, or its dependencies, within twelve months from the date of this present Order, from any country in amity with His Majesty, laden with any articles the growth, production, or manufacture of any such country, excepting all articles composed of cotton, iron, steel, or wool of foreign manufacture, shall be permitted to enter and land their cargoes, and dispose of the same, in the said ports; provided always, that such articles, when imported in a foreign ship, shall pay a duty of two per cent. ad valorem, over and above

what may be payable upon similar goods when imported in a British ship.

And it is further ordered, that every such vessel, arriving as aforesaid, shall be permitted to export a cargo, consisting of any articles of the growth, produce, or manufacture of the Island of Mauritius, or its dependencies, or of any other articles which shall have been legally imported there; and that all such articles so exported in foreign vessels, shall in like manner be subject to a duty of two per cent. ad valorem, over and above the duties (if any) which shall be payable on similar articles when exported from the Mauritius, or its dependencies, in British vessels.

It is, however, hereby further ordered and declared, that no foreign vessel, allowed by the terms of this Order to export a cargo from the Island of Mauritius, or its dependencies, shall be permitted to export such cargo to any of His Majesty's possessions. But that every British vessel which shall during the continuance of this present Order, have imported a cargo into any port of the said Island of Mauritius, or its dependencies, either from the United Kingdom, or from any other place, shall be permitted to carry back a return cargo, consisting of the articles aforesaid, to any place whatever, either belonging to His Majesty, or to any state in amity with His Majesty. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary directions herein as to them may respectively appertain.

ONE THOUSAND POUNDS,

to be paid on conviction of every such offender; which said sum of one thousand pounds the Lords Commissioners of His Majesty's Treasury are hereby required and directed to pay accordingly: And We do further promise, that any person or persons concerned in such outrages as aforesaid, other than such as were actually concerned in any act by which Our Royal Person was immediately endangered, who shall give information, so as that any of such authors, actors, or abettors as aforesaid, shall be apprehended and brought to justice, shall, upon conviction of such offender or offenders, receive His Majesty's most gracious pardon.

The above-namnd James Watson is a Surgeon by profession, and has been employed in that capacity on board a Greenland ship: He is a young man, apparently about twenty-three or twenty-four years of age, but is only twenty, dark hair, rather pale complexion, five feet five inches high, has a mark or mole with a few hairs on it, on his left cheek bone near the eye, the left eyelid rather dropping over the eye, very faint remains of small pox in his face, has rather a wide mouth, and shews his teeth, (which are very black) when he laughs; he sometimes wore a brown great coat, black under coat, black waistcoat, drab breeches and long gaiters, and at other times he wore a black coat and waiscoat, blue pantaloons, and Hessian boots; his appearance shabby genteel: he formerly lodged in Hyde-Street, Bloomsbury.

Arthur Thistlewood is about forty-five years of age, five feet eleven inches high, has a sallow complexion, long visage, dark hair (a little grey), small wiskers, dark hasle eyes, and arched eyebrows, a wide mouth, and a good set of teeth, has a scar under his right jaw, is slender made, walks very upright, and has much the appearance of a military man; was born in Lincolnshire, and apprenticed to an apothecary at Newark, and has been a lieute-nant in the army; he usually wore a French grey coloured coat, buff waistcoat, grey coloured Wellington pantaloons, with Hessian boots under them, and at times a dark brown great coat.

time during the space of six months (to com-mence from the said thirteenth day of February next), presume to transport any gunpowder or next), presume to transport any gunpower of salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa, or in the West Indies, or on any part of the Continent of America (except to a port or place, or ports or places, in His Majesty's territories or possessions on the Continent of North America, or in the territories of the United States of America), or ship or lade any gunpowder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places on the Coast of Africa, or in the West Indies, or on the Continent of America (except as above excepted), without leave or per-mission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled "An Act to empower His Majesty to prohibit the exportation of salt-petre, and to enforce the law for empowering His Majesty " to prohibit the exportation of gunpowder, or " any sort of arms or animunition, and also to compower His Majesty to restrain the carrying coastwise of salt-petre, gunpowder, or any sort of arms or ammunition;" and also by an Act, passed in the thirty-third year of His Majesty's reign, cap. 2, intituled "An Act to enable His "Majesty to restrain the exportation of panel "Majesty to restrain the exportation of naval stores, and more effectually to prevent the ex-" portation of salt-petre, arms, and ammunition, when prohibited by Proclamation or Order in Council!"
