THIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Deputy Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed by the Prince Regent, in the name and on the behalf of His Majesty, for declaring His Majesty's Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archebishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for punishing mutiny and desertion, and for the better payment of the army and their quarters.

An Act for the regulating of His Majesty's royal

marine forces while on shore.

An Act to continue, until the fifth day of July one thousand eight hundred and eighteen, an Act of the forty-sixth year of His present Majesty, for granting an additional bounty on the exportation of the silk manufactures of Great Britain.

An Act to indemnify such persons in the United Kingdom as have omitted to qualify themselves for offices and employments, and for extending the time limited for those purposes respectively, until the twenty-fifth day of March one thousand eight hundred and eighteen; and to permit such persons in Great Britain as have omitted to make and file affidavits of the execution of indentures of clerks to attornies and solicitors, to make and file the same on or before the first day of Hilary Term one thousand eight hundred and eighteen.

We daily offer our prayers to God for the long continuance of those blessings, the fair prospect of which is open to us by the exercise of every public and domestic virtue which so highly distinguish your Royal Highness, both in your public and private character, and which hath laid the surest foundation for the future happiness of your people, together with your own, and ensured to your Royal Highness that glory and prosperity, which is the never-failing reward of every good and virtuous King, in the love and affection of a grateful people.

Whilst we have been contemplating, with pride and gratitude, the wigorous measures of your Royal Highness, and the plans pursued with so much perseverance and success, which have raised our country to the highest pitch of glory, and to the admiration of Europe, we most sincerely lament that the nation should be disgraced by profligate men, imposing on the ignorance of the multitude, and exciting them to sedition and rebellion, under the delusive pretext of a reform in Parliament.

Although we, in common with our fellow subjects, deplore the general distress, arising from a combination of circumstances, which no human effort could controul, yet we observe with satisfaction, that the people of the surrounding districts, uncontaminated by revolutionary principles, are struggling under their difficulties, with fortitude and patience, and, by their industrious exertions, gra-

dually overcoming them.

We further beg leave to avail ourselves of this opportunity of expressing our affectionate attachment to our venerable Sovereign,-to your Royal Highness's Person, -and to your Illustrious House, with which, we are deeply sensible, the liberties of this country are closely identified; and we pledge ourselves to support the Government of your Royal Highness, as by law established, and to maintain inviolate our glorious Constitution, with our lives and properties.

To His Royal Highness the Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

WE, the undersigned inhabitants of the parish of Riseley, although obscure individuals, and living in a village, deem it incumbent on us as dutiful and loyal subjects of Great Britain, to declare our sentiments on the present state of public affairs.

We are aware of the distresses which affect every class of the community, especially the poor, and are desirous that every lawful means be used for their relief, and we confidently hope and believe that the national resources are not radically impaired, but merely under a partial and temporary obstruction; that the difficulties we have to endure will, by the enlightened policy of Ministers, be overcome, and that the agriculture, manfactures and commerce of the country will soon revive, flourish and increase.

We are at the same time satisfied that nothing can tend more to retard the accomplishment of our hopes and wishes, the good designs of our Sovereign, and the blessings of God upon us, than the methods resorted to of late by designing and evilminded men, to persuade their hearers and readers that a speedy remedy is to be found in measures, which, under specious pretences, would effect the complete subversion of the Constitution. We are,

Parliaments and universal soffrage are inapplicable to the nature as well as to the state of the Empire; nor can any Government long or happily exist on such incoherent and self-destroying principles. To these endeavours may be traced the criminal excesses and treasonous practises, which have lately disgraced the metropolis and other parts of the Empire; in which, the self-sent delegates would persuade the simple and misguided populace, that they are abridged of their liberties, and deprived of their privileges; when the language they are unhappily, with impunity, permitted to use, the means they are allowed to employ, and the tumults they are suffered to excite, are such as are tolerated in no other civilised country; palpably refuting their unfounded calumnies, and pronouncing at the same time the loudest encomium on the abused freedom of Britons. Instead of murmuring under our embarrassments, and, above all, ascribing them to our Government; we believe that they are partly to be attributed to the inscrutable dispensations, and merciful though afflictive chastisements of Providence for our national and personal sins; and partly to the unavoidable consequence of the return to peace, after a long and arduous war, in which by our example and counsel, our fleets and armies, our blood and treasures, legitimate Sovereigns have been reinstated in their lost dominions, Europe has been delivered from the hand of oppression, and the British name and character has been raised, if possible, beyond its former elevation in the scale of nations, under the protection, and with the assistance and blessing of Almighty God.

Experiencing so many mercies, we cannot doubt that the hand of Providence will again be opened to us; that when things find their natural level, our income will equal our expenditures; and that England, already the queen and benefactress, will again become the emporium of nations. this hope we are strengthened and confirmed, as well from other reasons as from the noble sacrifices lately made, and therein the disposition evinced by His Royal Highness the Prince Regent, the economy and retrenchment practised by His Majesty's Ministers, and the self-denial of other illustrious individuals, all of which tend to shew a determination to make every sacrifice consistent with the security and dignity of the Crown, the proper discharge of official duties, the inviolability of vested right, and the rewards due to distinguished merit, and eminent public service. But all our hopes depend, under God, on the loyal obedience and cheertul submission of His Majesty's subjects, at these trying times of public calamity; and we therefore are convinced that the proceedings of the disaffected, unless promptly repressed, must and will lead to scenes of anarchy and blood, too appalling to contemplate, involving their own ruin with the hurt and damage of their country.

While we express our unfeigned regret at the too-long-permitted recurrence of these digraceful, seditious, and outrageous assemblages of the self-styled patriots and their seduced adherents, we are overwhelmed with horror, and know not how adequately to express our indignation, at the still more atrocious insult and treasonous assault, which has been recently committed against the sacred Person

moreover, convinced, that such novelties as annual Parliaments and universal suffrage are inapplicable to the nature as well as to the state of the Empire; nor can any Government long or happily exist on such incoherent and self-destroying principles.

Deeply lamenting that such outrages should have occurred, and at the same time, glorying in, and grateful for the undisturbed and unabridgedpossession of more personal liberties than ever were enjoyed by any other people, we, as true Britons, and faithful subjects of a gracious King, feel it to be a solemn and imperious duty which we owe to our country, to protest against these unconstitutional assemblages, the above fruits of which we have seen, and do so much lament, firmly believing, that the object thereof is, under the name of reform, to effect a revolution in the country, of a Government, the envy and admiration of every other nation, and the bulwark and glory of our own; containing in it every thing that is necessary for the power, free-dom, honour, and happiness of a people; and also, though unimportant as a parish, to pledge ourselves, r as we hereby do, collectively and individually, to do all in our power, at any sacrifice, by precept and example, influence and interest, endeavour and i exertion, to support the just exercise of the authority of Government, to promote obedience to the laws, loyalty to our Prince, and to support and maintain, as far as in us lies, the Constitution, both in Church and State, as by law established; convinced that they both must stand or fall together, determined to resist every attempt, whether of force or traud, that may be directed against the Monarchy or Hierarchy, our civil liberty or social peace, with all that is dear to us, as men, as subjects, as churchmen and as Britons.
