**T**HE following Addresses have been presented to His Royal Highness the Prince Regent; which Addresses His Royal Highness was pleased to receive very graciously:

To His Royal Highness George Prince of Wales,  
REGENT of the United Kingdom of Great Britain and Ireland.

*May it please your Royal Highness,*

WE, His Majesty's dutiful and loyal subjects, Inhabitants of the Town and Neighbourhood of Brigg, in the County of Lincoln, beg leave to approach your Royal Highness with sincere sentiments of duty and profound respect, feeling a consciousness of no inferiority to any of His Majesty's subjects, in sentiments of unaffected loyalty to His Majesty's Government, and attachment to your Royal Highness.

We regret not to have been sooner prepared to lay before you, the expressions of our indignation and abhorrence of the disgraceful and daring outrage recently committed against your Royal Highness's person, when on your return from exercising the most important and sacred prerogative attached to your high station, as Regent of this United Kingdom.

While contemplating with unfeigned concern, that any subject could have been found within these dominions capable of such atrocious and disgraceful violence, and conduct so foreign to the British character, we beg permission to express our hope, that your Royal Highness will cause to be adopted such immediate and effectual measures as will protect your royal person from a repetition of such rebellious attacks, and counteract the designs of individuals, who, dissatisfied and turbulent in themselves, wish to disseminate those principles of anarchy and confusion, so fatally experienced by a neighbouring country, with the vain hope of planting their noxious principles in this hitherto happy country.

However extended our opinions are of the firmness and loyalty of the British nation, yet we wish to see checked that spirit of virulence which has by a certain few been lately evinced, and under all cir-

cumstances we beg to assure your Royal Highness, that the inhabitants of the town of Brigg and its neighbourhood, will ever be foremost in defending and supporting, with unshaken zeal and devotion, the Throne and Constitution of these realms.

Though we regret the necessity of suspending the Habeas Corpus Act, the grand palladium of our liberties, yet we perfectly agree in the expediency of the measure, for which those, who have committed the daring outrage we lament, or by their inflammatory speeches led to its commission, must be considered as the cause.

We are sorry to think that our county has given birth to two such men as Watson and Thistlewood, but we can with confidence assure your Royal Highness, that no part of the kingdom is less affected with rebellious principles than the inhabitants of this town and county, where, we rejoice to say, the sufferings of the poor have been more moderate than in perhaps any other part of the King's dominions, and of course they have been less open to the artful insinuations of the profligate disturbers of the public peace.

WE, His Majesty's dutiful and loyal subjects, the Gentlemen, Traders, Farmers, Fishcurers, Ship-Owners and other Inhabitants of the Shire of Caithness, met at Thurso, impressed with the most heartfelt gratitude to the Supreme Disposer of all human events, for His wise dispensations to us especially, in the many and continued blessings, both sacred and civil, that we have enjoyed and continue to enjoy, since the establishment of the Crown of these realms in your Royal Highness's Family; and firmly attached to those principles that seated and established the Princes of the Sovereign House of Brunswick on the Throne, so much to the honour and interest of these free and united kingdoms and their own glory, as the unceasing assertors of public liberty and universal vindicators of the oppressed—feel with the warmest emotions of gratitude towards the Allwise Ruler of the Universe, for His most gracious dispensation to these realms, in preserving the sacred life of your Royal Highness from the premeditated attempts of unprovoked brutal rebellious ferocity, and for the bringing to light a traitorous conspiracy against the Government and State. **W**HEREAS by an Act, passed in the present session of Parliament, intituled "An Act to continue and extend the provisions of an Act, of the forty-ninth year of His present Majesty, for regulating the trade and commerce to and from the Cape of Good Hope, until the fifth day of July one thousand eight hundred and twenty; and also for regulating the trade of the Island of Mauritius;" His Majesty is authorised, by and with the advice of His Privy Council, by any Order or Orders to be issued from time to time, to give such directions, and make such regulations touching the trade and commerce to and from all islands, colonies, or places, and the territories and dependencies thereof, to His Majesty belonging or in His possession, in Africa, or Asia to the eastward of the Cape of Good Hope (excepting only the possessions of the East India Company), as to His Majesty, in Council, shall appear most expedient and salutary, any thing contained in an Act, passed in the twelfth year of the reign of His Majesty King Charles the Second, intituled "An Act for the encouraging and increasing of shipping and navigation," or in an Act, passed in the seventh and eighth years of the reign of His Majesty King William the Third, intituled "An Act for preventing frauds, and regulating abuses in the plantation trade," or any other Act or Acts of Parliament now in force, relating to His Majesty's colonies and plantations, or any other Act or Acts of Parliament, law, usage or custom to the contrary in any wise notwithstanding: and whereas on the night of the twenty-fifth of September last, a dreadful fire broke out in the town of Port Lewis, in the Island of Mauritius, which totally destroyed the chief part of that town, together with a great mass of provisions and merchandise intended for the consumption and trade of its inhabitants, whereby a great number of families were reduced to extreme indigence, and left without a home; in consequence of which dreadful calamity the Governor of the said Island found himself compelled to open the ports of the Island to foreign vessels, in order to afford the speediest relief of which the case would admit, and thereby to save His Majesty's subjects residing in that colony from the greatest extremity of distress; and whereas it is expedient that facilities should in consequence be granted to the trade of the Island of

Mauritius, for a limited time, with the view of giving still further relief to its suffering inhabitants; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, is pleased to order, and it is hereby ordered, that all vessels, whether British or foreign vessels belonging to countries in amity with His Majesty, arriving at any port of the Island of Mauritius, or its dependencies, within twelve months from the date of this present Order, from any country in amity with His Majesty, laden with any articles the growth, production, or manufacture of any such country, excepting all articles composed of cotton, iron, steel, or wool of foreign manufacture, shall be permitted to enter and land their cargoes, and dispose of the same, in the said ports; provided always, that such articles, when imported in a foreign ship, shall pay a duty of two per cent. *ad valorem*, over and above what may be payable upon similar goods when imported in a British ship.

And it is further ordered, that every such vessel, arriving as aforesaid, shall be permitted to export a cargo, consisting of any articles of the growth, produce, or manufacture of the Island of Mauritius, or its dependencies, or of any other articles which shall have been legally imported there; and that all such articles so exported in foreign vessels, shall in like manner be subject to a duty of two per cent. *ad valorem*, over and above the duties (if any) which shall be payable on similar articles when exported from the Mauritius, or its dependencies, in British vessels.

It is, however, hereby further ordered and declared, that no foreign vessel, allowed by the terms of this Order to export a cargo from the Island of Mauritius, or its dependencies, shall be permitted to export such cargo to any of His Majesty's possessions. But that every British vessel which shall during the continuance of this present Order, have imported a cargo into any port of the said Island of Mauritius, or its dependencies, either from the United Kingdom, or from any other place, shall be permitted to carry back a return cargo, consisting of the articles aforesaid, to any place whatever, either belonging to His Majesty, or to any state in amity with His Majesty. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary directions herein as to them may respectively appertain.
