make and maintain a road from Millbank-Row, I to report, and all goods, wares, and merchandize Westminster, to the Penitentiary.

An Act for making and maintaining a navigable canal from the Lothian Road, near the city of Edinburgh, to join the Forth and Clyde Navigation,

near Falkirk, in the county of Stirling.

An Act for giving further powers to the President and Assistants of the Charitable Society of the town of Belfast, in the county of Antrim, to supply the said town with water, and to improve their estates.

An Act for building a bridge across the River Irwell, from Water-Street, in the township of Salford, to Saint Mary's Gate, in the township of Manchester, all in the county of Lancaster, and for making proper avenues thereto.

An Act for granting further powers for improving the town of Great Bolton, in the county of Lancaster.

An Act for granting an equivalent for the diminution of the profits of the office of Gauger of the City of London, and increasing the payments to

be made by brokers.

An Act to enable Peltro William Tomkins, of New Bond-Street, in the city of Westminster, engraver to the Queen's Most Excellent Majesty, to dispose of his collection of paintings, drawings, and engravings, together with several copies of certain books therein mentioned, and the lease of the premises called the British Gallery of Pictures, by way of lottery.

THEREAS by the forty-third section of His Majesty's Order in Council, of the fifth of April one thousand eight hundred and five, it is ordered that all ships and vessels arriving in the ports of Great Britain, or the islands of Guernsey, Jersey, Alderney, Sark, or Man, having come from or through the Mediterranean, or from the West Barbary on the Atlantic Ocean, which with their officers, crews, passengers, and cargoes, shall have previously performed quarantine in the lazaret at Malta, Ancona, Venice, Messina, Leghorn, Genoa, or Marseilles, shall, upon their arrival, be put under quarantine in some of the ports or places hereinbefore appointed for the performance of quarantine, until the Commander, Master, or other person having the charge of such ship or vessel shall have produced to the Superintendant of Quarantine, or his Assistant, or to the Principal or other Officer of the Customs authorised to act in that behalf, the proper documents to prove that such ship or vessel, and the officers, crew, passengers, and cargo on board the same, have duly performed quarantine in one of the lazarets last mentioned, and upon so producing such documents, the said ship or vessel shall not be obliged to per-

on board thereof, not hereinbefore enumerated in the first class before stated, shall be admitted to entry; but all goods, wares, and merchandizes on board any such ship or vessel, which are enumerated in the first class before stated, shall in such case perform a further quarantine of fifteen days, at some of the ports or places hereinbefore appointed for that purpose, in such manner as has been heretofore practised: and whereas information has been received, that the establishment of the lazaret at Trieste is conducted upon the same plan. as that of Venice, and that consequently no danger is to be apprehended from admitting ships, vessels, or cargoes arriving from Trieste, having previously performed quarantine at that place, to all the indulgences granted by the before-mentioned Order, His Royal Highness the Prince Regent is thereupon pleased, in the name and on the behalf of His Majesty, and by and with the advice of His. Majesty's Privy Council, to order, and it is hereby ordered, that all ships and vessels arriving in theports of Great Britain, or the islands of Guernsey, Jersey, Alderney, Sark, or Man, having come from or through the Mediterranean, or from the West. Barbary on the Atlantic Ocean, which with their officers, crews, passengers, and cargons shall have previously performed quarantine in the lazaret at Trieste, shall be subject only to the rules and regulations prescribed by the forty-third section of His Majesty's Order in Council, of the fifth of April one thousand eight hundred and five, with respect to vessels arriving from Malta, Ancona, Venice, Messina, Leghorn, Genoa, or Marseilles;

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, His Majesty's Secratary at War, and the Governors or Commanders in Chief for the time being of the Islands of Guernsey, Jersey, Alderney, Sark, and Man, are to give the necessary directions herein as to them may respectively appertain.

HEREAS by an Act passed in the fortysixth year of His Majesty's reign, cap. 98, intituled " An Act for making additional and " further provisions for the effectual performance " of quarantine," it is, amongst other things, enacted; that it shall and may be fawful to and for His Majesty, His heir and successors, by His or Their Order or Orders in Council, notified by Proclamation or published in the London Gazette, to prohibit all porsons, whips, boats, and vessels. whatsoever, from going, under any prentence whatsoever, within the limits of any station, which hy form quarantine, but shall be forthwith admitted His Majesty, His heirs or successors, by His or
