A PROCLAMATION.

GEORGE, P.R.

W HEREAS We have thought fit to order that certain pieces of gold money should be coined, which should be called "half sovereigns or ten shilling pieces," each of which should be of the value of ten shillings, and that each piece should be of the weight of two pennyweights thirteen grains  $\frac{6,370}{10,000}$  troy weight of standard gold, according to the weights approved of and confirmed by Us in Council, in pursuance of an Act made in the fourteenth year of His Majesty's reign, initialed "An Act for regulating and ascertaining the weights, to be made use of in weighing the gold and silver coin of this kingdon;" and We have further thought fit to order that every such piece of gold money, so ordered to be coined as aforesaid, shall have for the obverse impression the head of His Majesty, with the inscription "Georgius III. Dei Gratia :" and the date of the year; and for the reverse the ensigns armorial of the United Kingdom, contained in a shield, with the inscription "Britanniarum Hex. Fid. Def:" with a newly invented graining on

the edge of the piece : and whereas pieces of gold money of the above description have been coined at His Majesty's Mint, and will be coined there, in pursuance of Orders which We have given for that purpose : We have therefore, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, thought fit to issue this Proclamation; and We do hereby, in the name and on the behalf of His Majesty, ordain, declare, and command, that the said pieces of gold money so coined, and to be coined as aforesaid, shall be current and lawful money of the kingdom of Great Britain and Ireland, and shall be called " half sovereigns or ten shilling pieces," and shall pass and be received as current and lawful money of the United Kingdom of Great Britain and Ireland; and every of such pieces, not weighing less than two penny weights, thirteen grains and one quarter, shall pass and be received as of the value of ten shillings of lawful money of Great Britain and Ireland in all payments whatsoever.

provided with warehouses, together with wet docks or basins, or such other securities as shall, in the judgment of the Lord High Treasurer, or of the Lords Commissioners of the Treasury, for the time being, or any three or more of them, in Great Britain and Ireland respectively, be fit and proper for the deposit and safe custody of all such goods, wares, and merchandise, as well as for the collection of all duties payable thereon, and shall have been duly declared so to be, by the Order of His Majesty in Council, in Great Britain, or by the Order of the Lord Lieutenant in Council, in Ireland: And whereas the port of Bristol has been deemed by the Lords Commissioners of His Majesty's Treasury in Great Britain to be fit and proper for the deposit and safe custody of all such goods, wares, and merchandise, as well as for the collection of all duties payable thereon; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, is thereupon pleased to declare, and it is hereby declared, that the port of Bristol is a port fit and proper for the deposit and safe custody of all such goods, wares, and merchandise, as well as for the collection of all duties payable thereon.

And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly.

His Royal Highness the PRINCE REGENT in Council.

**T** is this day ordered by His Royal Highness the Prince Regent, in the name and on the ocaalf of His Majesty, and by and with the advice of His Majesty's Privy Council, that the Order in Council of the twentieth of May one thousand eight hundred and thirteen, permitting vessels trading to the Coast of Africa, to take on board as an assorted part of their cargoes, trading guns, blunderbusses, pistols, and gunpowder, be, and the same is hereby revoked; and it is further ordered, by and with the advice aforesaid, that the Order in Council of the second of January one thousand eight hundred and seventeen, prohibiting the export of arms and ammunition to the places therein specified, be, and the same is hereby also revoked; but whereas it is expedient, that some of the provisions of the said Order in Council of the second of January one thousand eight hundred and seventeen, should be continued; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to com-mence from the date of this Order), presume

to transport any gunpowder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa, or in the West Indies, or on any part of the Continent of America (except to a port or place, or ports or places in His Majesty's territories or possessions on the Continent of North America, or in the territories of the United States of America), or ship or lade any gunpowder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places on the Coast of Africa, or in the West Indies, or on the Continent of America (except as above excepted), without leave or per-mission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, in-tituled "An Act to empower His Majesty to " prohibit the exportation of salt-petre, and to enforce the law for empowering His Majesty " " to prohibit the exportation of gunpowder, or " any sort of arms or ammunition, and also to " empower His Majesty to restrain the carrying " coastwise of salt-petre, gunpowder, or any sort " of arms or ammunition;" and also by an Act, passed in the thirty-third year of His Majesty's reign, cap. 2, initialed "An Act to enable His " Majesty to restrain the exportation of naval " stores, and more effectually to prevent the exportation of salt-petre, arms, and ammunition, " when prohibited by Proclamation or Order in " Council:"

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain. And, as a further encouragement, a reward of FIFTY GUINEAS is hereby offered to any person or persons (except as is before excepted) who shall discover his, her, or their accomplice or accomplices therein, so that he, she, or they may be apprehended and convicted thereof; or to any personor persons who shall apprehend and bring the offenders, or any of them, to conviction, or cause them, or any of them, to conviction, or cause them, or any of them, so to be apprehended and convicted as aforesaid.—Twenty guineas of the above reward to be paid by Mr. W. ## Whitehall, August 26, 1817.

W Hereas it bath been humbly represented unto His Royal Highness the Prince Regent, that on the night of the 30th of July last, some person or persons did most cruelly and maliciously cat, maim, and destroy a backney mare, and on the night of the 1st of August instant, did also cut, maim, and destroy a bullock, the property of George Haskins, and did also on the last mentioned night fire at the said George Haskins, with intent to kill him in his own dwelling house; and that there is reason to suppose that the above-mentioned outrages were committed out of malice and revenge towards the said George Haskins, for having zealously and faithfully discharged his duty as constable of the hamlet of Oldland;

His Royal Highness, for the better apprehending and bringing to justice the person or persons concerned in the outrages above-mentioned, is hereby pleased, in the name and on the behalf of His Majesty, to promise His Majesty's most gracious pardon to any one of them (except the person who actually committed either of the outrages abovementioned), who shall discover his, her, or their accomplice or accomplices therein, so that he, she, or they may be apprehended and convicted thereof.

## BATHURST.

And, as a further encouragement, a reward of TWENTY-FIVE GUINEAS is hereby offered by the Association for the Prosecution of Felons, in and round the neighbourhood of Cockroad, in the parish of Bitton, near Bristol, to any person or persons (except as is before excepted) who shall discover his, her, or their accomplice or accomplices therein, so that he, she, or they may be apprehended and convicted thereof, or to any person or persons who shall apprehend and bring the offenders, or any of them, to conviction, or cause them, or any of them, so to be apprehended and vonvicted as aforesaid.

## Navy-Office, November 1, 1817.

THE Right Honourable the Lords Commissioners of His Majesty's Treasury having appointed money for the payment of half-pay to Sca Officers, from the 1st July to the 30th September 1817, according to His Majesty's establishment in that behalf; these are to give notice, that the several payments will begin to be made at the Pay-Office, by the Treasurer of His Majesty's Navy, at ten o'clock in the morning, on the following days, viz.

On Monday the 10th instant, and two following days, to Admirals, Captains, and their Attornies.

On the 13th, 14th, 17th, and 18th instant, to Lieutenants and Chaplains, and their Attornies.

On the 19th and 20th instant, to Masters, Surgeons, and Pursers, and their Attornies.

After which the lists will be recalled the first and third Wednesday in every month, that all persons may then and there attend to receive what may become payable to them, and not only bring with them the affidavit required, touching their not having enjoyed the benefit of any public employment, either at sea or on shore, during the time they are to be paid their half-pay, but also to produce certificates that they have subscribed to the Test, and taken the 'Oaths of Allegiance required by Act of Parliament, to His present Majesty; and in case any of the said Officers should not be able to attend themselves, but employ Attornies for that purpose, that the said 'Attornies do produce the like certificates and affidavits from the persons they are employed by.

Where Officers are abroad on leave, their agents

are to produce attested copies of such leave, before the half-pay can be paid.

And as by Act of Parliament, passed in the thirty-fifth year of His present Majesty's reign, in-tituled, "An Act for establishing a more easy and " expeditious Method for the Payment of Officers " belonging to His Majesty's Navy," it is enacted by the twentieth clause of the said Act, "that if "any Commissioned or Warrant Naval Officer " who shall be entitled to receive Half-Pay, and "shall be desirous to receive and be paid the " same at or near the place of his residence, " he may apply to the Treasurer of His Majesty's "Navy, in London, to have such Half-Pay paid ' at or near the place of his residence, &c. in the man-"ner pointed out by the said Act;" and by a further Act, passed in the fifty-sixth year of His present Majesty's reign, intituled "An Act for ' enabling the Officers in His Majesty's Navy, " and their representatives, to draw for and re-" ceive their half-pay," it is enacted by the first and third clauses of the said Act, " that if any " Officer in His Majesty's Navy, who shall be en-" titled to receive any sum of money for or on ac-" count of his half-pay, shall be desirous of draw-" ing a bill of exchange for the same upon the "Commissioners of His Majesty's Navy, instead of receiving the same by remittance bill, he " shall signify such desire, by letter, to the Trea-" surer of His Majesty's Navy; and that if any " Officer in His Majesty's Navy, who shall be entitled to receive any sum of money for or on ac-" count of half-pay, shall be desirous of having, " his half-pay paid to him by extract at any of His Majesty's Dock-Yards where Clerks for the payment of wages for the Navy shall reside, in-' stead of receiving the same by remittance bill or " bill of exchange, he is to apply either to the " proper Clerk, at the Navy Pay-Office, in Lon-" don, or at the Pay-Office at such Dock-Yard, " signifying such his desire ;" notice is hereby further given, that the half-pay ending the 30th of September 1817, will commence paying on the 10th instant; and all persons desirous of drawing for or of having their half-pay remitted to them, may apply as above directed.

Each district will be put up at the sum above set opposite thereto. The highest bilder will be declared the farmer, and will be required to pay down immediately, in Bank notes, seven and a halt per cent. upon the annual rent as a deposit; if no sufficient bidding shall be made for any district, it will be withdrawn.
