To his Royal Highness George Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

WE, His Majesty's loyal and dutiful subjects, the Inhabitants of the Town of Oldham, in the County-Palatine of Lancaster, beg leave to approach your Royal Highness to express our sorrowful regret at the melancholy dispensation which has deprived your Royal Highness of a dutiful and beloved daughter, and the nation of the object on which its best hopes were centred, in the lamented death of Her Royal Highness the Princess Charlotte of Wales.

Our sorrows are much increased by this afflictive dispensation, by the reflection that the promising virtues of the late amiable Princess afforded a well-grounded expectation, that her life would have been a comfort to your Royal Highness, and a blessing to the nation she was destined one day to govern.

The dutiful and affectionate Address of the Magistrates and Town Council of Greenock.

*May it please your Royal Highness,*

WE, His Majesty's faithful and loyal subjects, the Magistrates and Town Council of Greenock, in Common Council assembled, request to be permitted, at this melancholy season of national mourning, to approach your Royal Highness, with the expression of our sincerest sympathy on the great and irreparable loss, with which it hath pleased Almighty God, in the death of your illustrious daughter the Princess Charlotte Augusta, to afflict your Royal Highness her beloved Father, His Serene Highness the Prince Leopold of Saxe Cobourg her distinguished Consort, the Royal Family and whole United Kingdom.

In the sad and solemn contemplation of this lamented event, with which our minds are exercised, we receive a striking lesson of the uncertain tenure of all temporal felicity, even in circumstances of the most exalted rank, the most perfect condition of enjoyment and flattering probability of endurance. Little more than a year has elapsed since the universal gratulations of a loyal and happy people, on the auspicious occasion of her marriage, demonstrated their affectionate interest in the welfare of the Princess, whose noble and exalted character they greatly loved and honoured. That union they were eager to hope and to predict as the commencement of a long and perfect happiness to the illustrious parties so affectionately allied, and as a source of augmented satisfaction to your Royal Highness and the Royal Family in domestic and friendly relation ; but this interest became still dearer and more momentous, when the Princess was viewed as the presumptive Heiress to the Throne and the expected Mother of a long posterity, in whom the Crown and Government of the Kingdom might descend in happiness and in security.

At the period, Alas ! when these hopes, brightening in the transition of time were raised to their highest pitch, and seemed most likely to receive their happiest confirmation, it pleased Divine Providence to annul them, and to number their illustrious object with the dead, in the bloom and vigour of youth.

In such painfully afflicting circumstances of national bereavement, when an universal mourning over the memory and the tomb of the beloved Princess, and of those hopes which centered in her and in her offspring, has filled the hearts of all His Majesty's faithful subjects, we beg to commend the Royal and illustrious mourners most nearly and deeply affected, in devout submission to the will of God, to the support and consolations of that Divine Religion, in which the lamented object of their grief lived and died, and of which we trust she now inherits the promises.

That the Divine Protection and Blessing may surround and cheer the Royal Family and this people amid their mourning, and remain with them for ever ; that the Sovereignty of the empire may descend, notwithstanding the present disappointment of our hopes, in the Family of our venerable King, and that those invaluable civil and religious privileges which the nation has so highly and so long enjoyed under the Princes of His house, may be secured and transmitted, unimpaired, to the latest generations, are the earnest prayers, may it please your Royal Highness, of the Magistrates and Town Council of Greenock.

The humble Address of the Presbytery of Hamilton, met at Hamilton, on the 25th day of November 1817.

*May it please your Royal Highness,*

WE, His Majesty's most dutiful and faithful subjects, the Ministers and Elders of the Presbytery of Hamilton, in Presbytery assembled, beg leave to approach your Royal Highness, with feelings of the deepest veneration, and to mingle our sorrows and our condolence with those of the British people.

We bear no breasts insensible to your sufferings: as men, we feel deeply for the parent bereft of his only child. As subjects of the British empire, and members of the Presbyterian Church and establishment, we lament over the loss of our beloved Princess. In this distant province of the realm, we had listened with no common satisfaction, to the tale of her many excellencies; of her vigorous understanding, of her elevated spirit, and of her generous and truly royal heart; we hailed the auspicious alliance which she had formed with a Prince of the Protestant name; our hearts burned within us when we were assured of the holy pleasure which she took in the exercises of religion, and we looked forward to the time, when having at length ascended the throne of this United Kingdom, amidst the gratulations of a free and of a devoted people, she should prove herself the protectress of our rights and privileges, and a nursing mother to the Church; but the glory is departed, and our hopes are perished. We bewail the mournful aggravation of our loss; for the mother and her child are gone down together into the grave. It is the Lord's doing, and it is marvellous in our eyes: how unsearchable are his judgments! and his ways are past finding out.

With deep emotion too, we participate in the sorrows of His Serene Highness the Prince Leopold of Cobourg. We humbly thank him for his

kind and most tender attentions to our departed Princess; and we pray earnestly to Almighty God in his behalf, that He, "who knoweth our frame" and "remembereth that we are dust" may support and comfort him, under the overwhelming weight and afflicting peculiarity of his sufferings.

We join with the people committed to our care, in deploring those multiplied transgressions, which have brought down upon us so signal an indication of the Divine displeasure. We lament over our ingratitude, and especially our ingratitude for the blessings of national peace, and of reviving commerce; and while we humble ourselves, under the mighty hand of God, we most sincerely pray that, for Jesus Christ's sake, these, together with the other invaluable blessings which we enjoy under the benignant and prosperous administration of your Royal Highness, may be continued with us, and go down to our children's children; and above all, we pray that the Father of Mercies may take your Royal Highness into his especial care and heavenly keeping; that he may assuage the bitterness of your grief; that he may guard you from all danger and long preserve you; and that when his inscrutable purposes have been accomplished, he may at last receive you into his eternal kingdom and glory.

**W**Hereas We have taken into consideration the state of the copper coin of this kingdom, and have deemed it expedient, by and with the advice of His Majesty's Privy Council, that all copper monies of this realm commonly called a halfpenny or a farthing, coined at His Majesty's Mint, and current in His Majesty's dominions, by virtue of any Proclamation prior to the twenty-sixth day of July one thousand seven hundred and ninety-seven, should be called in and recoined.

And whereas in pursuance of an Order in Council, dated the twenty-first of January one thousand eight hundred and fourteen, considerable quantities of the said copper monies before-mentioned, have been received and exchanged at His Majesty's Mint, so that only a small portion of such monies now remain in circulation; We do, therefore, by this Our Royal Proclamation, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, think proper to declare and command, and We do declare and command, that no copper monies whatsoever (other than and except such copper monies as are now current, by virtue of His Majesty's Proclamation bearing date the twenty-sixth day of July one thousand seven hundred and ninety-seven, or any Proclamation dated subsequent to the said twenty-sixth day of July one thousand seven hundred and ninety-seven) shall from henceforth be allowed to pass, or be current, in any payment whatsoever, within the United Kingdom of Great Britain and Ireland.

And we do further, in the name and on the behalf of His Majesty, and by and with the advice aforesaid, declare and command that all persons holding any of the copper monies of this realm, commonly called a halfpenny or a farthing, coined at His Majesty's Mint, and current in His Majesty's dominions, by virtue of any Proclamation bearing date prior to the said twenty-sixth day of July one thousand seven hundred and ninety-seven, who shall, on or before the thirty-first day of this instant December, bring the same to the Officers of His Majesty's Mint, in bags, contain-

ing fifty-six pounds weight avoirdupois each, and in quantities not less than three of such bags, and in tale not exceeding fifty-five pieces to the pound, or three thousand and eighty pieces to each bag of fifty-six pounds, shall thereupon receive the amount and value thereof according to the rate hereinafter specified (that is to say) for every such bag of fifty-six pounds weight, averaging fifty-five pieces to the pound, the sum of six pounds eight shillings and fourpence; for every such bag of fifty-six pounds weight, averaging fifty-four pieces to the pound, the sum of six pounds six shillings; for every such bag of fifty-six pounds weight, averaging fifty-three pieces to the pound, the sum of six pounds three shillings and eight pence, and so in proportion for any less average number of Pieces to the pound.

GEORGE, P. R.

**W**HEREAS there unhappily subsists a state of warfare between His Catholic Majesty and divers Provinces or parts of Provinces in Spanish America: and whereas it has been represented to Us, that many of Our subjects have, without Our leave or license enlisted, or entered themselves to serve in the military forces or ships of war raised or set forth or intended to be raised or set forth by the persons, exercising or assuming to exercise the powers of Government in such Provinces or parts of Provinces, and that divers others of Our subjects are about in like manner to enter and enlist themselves: and whereas such practices are highly prejudicial to and tend to endanger the peace and welfare of Our Crown and Dominions, we do therefore hereby, by and with the advice of Our Privy Council, strictly charge and command all and every of our natural-born subjects, of what degree or quality soever, not to serve in any such military forces or ships of war as aforesaid, and not to enlist or enter themselves to serve therein, and not to go beyond the Seas, or embark, in order to serve, or with intent to enter, or enlist themselves to serve in such military forces or ships of war: and it is at the same time Our Royal will and pleasure, and We do, by and with the advice aforesaid, hereby also strictly charge and command all and every of Our said subjects not to serve, or enlist, or enter themselves to serve in any of the military forces or ships of war raised or set forth, or to be raised or set forth, by His Catholic Majesty, and not to go beyond the Seas, or embark, in order, or to the intent to serve, or enter, or enlist themselves to serve in such military forces or ships of war; it is nevertheless Our Royal will and pleasure, that nothing herein contained, shall be deemed or taken to prohibit any of Our subjects, who are engaged at the time of the date of this Our Proclamation, in serving in the military forces of His Catholic Majesty, with Our leave or licence, from continuing to serve therein, provided that such Our said subjects do not serve with the military forces of His Catholic Majesty, when employed in Spanish America: and We do hereby, by and with the

advice aforesaid, strictly require all Our said subjects duly to conform to Our commands herein contained, under pain of Our highest displeasure, and the utmost forfeitures, penalties, and punishments, to which by law they will otherwise be liable.

**W**HEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the thirty-first of May last, for prohibiting the exportation of gunpowder, arms, or ammunition, to the places therein specified, will expire on the thirtieth day of November next; and whereas it is expedient, that the said prohibition should be continued for some time longer; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to commence from the thirtieth day of November next), presume to transport any gunpowder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa, or in the West Indies, or on any part of the Continent of America (except to a port or place, or ports or places in His Majesty's territories or possessions on the Continent of North America, or in the territories of the United States of America), or ship or lade any gunpowder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places on the Coast of Africa, or in the West Indies, or on the Continent of America (except as above excepted), without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled "An Act to empower His Majesty to prohibit the exportation of salt-petre, and to enforce the law for empowering His Majesty to prohibit the exportation of gunpowder, or any sort of arms or ammunition, and also to empower His Majesty to restrain the carrying coastwise of salt-petre, gunpowder, or any sort of arms or ammunition;" and also by an Act, passed in the thirty-third year of His Majesty's reign, cap. 2, intituled "An Act to enable His

Majesty to restrain the exportation of naval stores, and more effectually to prevent the exportation of salt-petre, arms, and ammunition, when prohibited by Proclamation or Order in Council."

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain.
