May it please your Royal Highness,

WE, His Majesty's dutiful and loyal subjects, the Deputies from the several Congregations of Protestant Dissenters, in and about the Cities of London and Westminster, beg leave to approach your Royal Highness to offer the sincere tribute of our unfeigned sorrow and affectionate condolence on that melancholy event, which has so deeply affected every mind which is open to the impressions

of private or of public misfortune.
We cannot but view this heavy affliction as combining in an eminent degree, many of the most poignant aggravations of human calamity. The stroke of death has fallen on a Princess, accomplished and amiable, in the bloom of life, in the possession of heartfelt enjoyments, and with prospects of the highest grandeur and the most extensive usefulness; it has torn asunder the ties of domestic felicity, and has thrown a cloud over those anticipations in which the present age rejoiced to contemplate the happiness of posterity. To you, Sir, and to another illustrious mourner, it more especially appertains to appreciate and to feel your full and painful portion of the general distress; nor would we, even in the expression of our humble sympathy, presume to intrude into the sacred recesses of parental or connubial grief.

But we trust, that while we feel for the sorrows of others, we may be allowed to be sensible of our own: and be permitted to recollect that your Royal

Daughter, Sir, was, in an important and intereting sense, the daughter of England; -presumptively our future Sovereign-in our hopes the parent of future Kings-one towards whom every eye turned with respect, every heart glowed with affection :in whom, from race, from education, from talents and from character, Britons were justified in confiding that, whenever in the course of nature it should please Providence to call her to the Throne, she would tread in the steps of her forefathers, and place her glory in maintaining the laws and the li-berties of the land. We cannot but regret, that hopes so fair should have proved delusive, and that it must long remain in futurity and in uncertainty, how the losses which the country deplores, are to be repaired.

But we will no longer dwell on evils of which we can neither diminish the magnitude, nor mitigatethe impression. As Englishmen we feel and have expressed our feelings in common with our fellow subjects; as Protestant Dissenters, we claim a peculiar interest in the concerns of that Illustrious. THEREAS by an Act, passed in the twentyeighth year of the reign of His present Majesty, intituled "An Act for regulating the "trade between the subjects of His Majesty's jesty, " colonies and plantations in North America and in the West India Islands and the countries be-" longing to the United States of America, and " between His Majesty's said subjects and the Foreign Islands in the West Indies," it is, amongst other things, enacted, that it shall and may be lawful for His Majesty in Council, by Order or Orders to be issued and published from time to time, to authorise, or by Warrant or Warrants under His sign manual, to empower the Governor of Newfoundland for the time being, to authorise, in case of necessity, the importation into Newfoundland of bread, flour, Indian com, and live stock, from any of the territories belonging to the said United States, for the supply of the inhabitants and fishermen of the Island of Newfoundland, for the then ensuing season only; provided always, that such bread, flour, Indian corn, and live stock, so authorised to be imported into the Island of Newfoundland, shall not be imported except in conformity to such rules, regulations, and restrictions as shall be specified in such Order or Orders, Warrant or Warrants respectively, and except by British subjects, and in British-built ships, owned by His Majesty's subjects, and navigated according to law:

And whereas it is expedient and necessary, that provision be made for fully supplying the inhabitants and fishermen of the Island of Newfoundland, for the ensuing season, with bread, flour, Indian corn, and live stock, His Royal Highness the Prince Regent doth thereupon, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, hereby order and declare, that for the supply of the inhabitants and fishermen of the Island of Newfoundland, for the ensuing season only, bread, flour, Indian corn, and live stock, may be imported into the said island from any of the territories belonging to the said United States, by British subjects, and in British-built ships, owned by His Majesty's subjects, and navigated according to law, and which within the space of nine months previous to the time of such importation, have cleared out from some port of the United Kingdom of Great Britain or Ireland, or other His Majesty's dominions in Europe, for which purpose a licence shall have been granted by the Commissioners of His Majesty's Customs in England or Scotland, or the Commissioners of His Majesty's Revenue in Ireland, or any other person or persons who may be duly authorised in that kingdom respectively, in the manner and form herein-after mentioned; which licence shall continue and be in force for nine calendar months from the day of the date upon which such licence is respectively granted, and no longer;

provided that no such licence as aforesaid, granted and contents of each package of bread, flour, Indian after the thirtieth day of September next, shall be corn, and the number of live stock, and shall thereof any force or effect: and His Royal Highness is hereby further pleased to order, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, that the master or person having the charge or command of any ship or vessel to whom such licence shall be granted, shall, upon the arrival of the said ship or vessel at the port, harbour, or place in the said Island of Newfoundland where he shall discharge such bread, flour, Indian corn, and live stock, deliver up the said licence to the Col-lector or other proper Officer of the Customs there, having first indorsed on the back of such licence the marks, numbers, and contents of each package of bread, flour, Indian corn, and the number of live stock, under the penalty of the forfeiture in the said Act mentioned; and the Collector or other proper Officer of the Customs at Newfoundland, is hereby enjoined and required to give a certificate to the master or person having the charge or command of such ship or vessel, of his having received the said licence so indorsed as before directed, and to transmit the same to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland respectively, by whom such licence was granted. upon receive a certificate thereof from the said ollector or other proper Officer of the Customs.

This licence to continue in force for calandar months from the date hereof.

The light to be exhibited will be of a bright colour, on the revolving principle, and will attain its greatest magnitude once in every two minutes.
"Cape Clear Island, on which the Light-house is
