The Speech of the Lords Commissioners to both Houses of Parliament, on Tuesday the 27th day of January 1818.

My Lords, and Gentlemen,

E are commanded by His Royal Highness the Prince Regent to inform you, that it is with great concern that He is obliged to announce to you the continuance of His Majesty's lamented indisposition.

The Prince Regent is persuaded that you will deeply participate in the affliction with which His Royal Highness has been visited, by the calamitous and untimely death of His beloved and only child the Princess Charlotte.

Under this awful dispensation of Providence, it has been a soothing consolation to the Prince Regent's heart, to receive from all descriptions of His Majesty's subjects the most cordial assurances, both of their just sense of the loss which they have sustained and of their sympathy with His parental sorrow: And amidst His own sufferings, His Reyal Highness has not been unmindful of the effect which this sad event must have on the interests and future prospects of the kingdom.

We are commanded to acquaint you, that the Prince Regent continues to receive from Foreign Powers, the strongest assurances of their friendly disposition towards this country, and of their desire to maintain the general tranquillity.

His Royal Highness has the satisfaction of being able to assure you, that the confidence which He has invariably felt in the stability of the great sources of our national prosperity has not been disappointed.

The improvement which has taken place in the course of the last year in almost every branch of our domestic industry, and the present state of public credit, afford abundant proof that the difficulties under which the country was labouring were chiefly to be ascribed to temporary causes.

So important a change could not fail to withdraw from the disaffected, the pricipal means of which they had availed themselves for the purpose of tomenting a spirit of discontent, which unhappily led to acts of insurrection and treason; And His Royal Highness entertains the most confident expectation that the state of peace and tranquillity to which the country is now restored, will be maintained against all attempts to disturb it, by the persevering vigilance of the Magistracy, and by the loyalty and good sense of the People.

Gentlemen of the House of Commons,

The Prince Regent has directed the estimates for the current year to be laid before you.

His Royal Highness recommends to your continued attention the state of the Public income and expenditure of the country; and He is most happy in being able to acquaint you, that since you were last assembled in Parliament the revenue has been in a state of progressive improvement in its most important branches.

My Lords, and Gentlemen,

We are commanded by the Prince Regent to inform you, that He has concluded Treaties with the Courts of Spain and Portugal, on the important subject of the Abolition of the Slave Trade.

His Royal Highness has directed, that a copy of the former Treaty should be immediately laid

before you, and He will order a similar communication to be made of the latter Treaty, as soon as the ratification of it shall have been exchanged.

In these negotiations, it has been His Royal Highness's endeavour as far as circumstances would permit, to give effect to the recommendations contained in the joint Addresses of the two Houses of Parliament, and His Royal Highness has a full reliance on your readiness to adopt such measures as may be necessary for fulfilling the engagements into which He has entered for that purpose.

The Prince Regent has commanded us to direct your particular attention to the deficiency which has so long existed in the number of places of Public worship belonging to the Established Church, when compared with the increased and increasing population of the country.

His. Royal Highness most earnestly recommends this important subject to your early consideration, deeply impressed, as He has no doubt you are, with a just sense of the many blessings which this country, by the favour of Divine Providence, has enjoyed, and with the conviction, that the religious and moral habits of the People are the most sure and firm foundation of National prosperity.

HIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed by the Prince Regent, in the name and on the behalf of His Majesty, for declaring His Majesty's Royal Assent to an Act agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellos of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Act, was read accordingly, and the Royal Assent given to

An Act to repeal an Act, made in the last session of Parliament, intituled "An Act to continue an Act, to empower His Majesty to secure and detain such persons as His Majesty shall suspect are conspiring against His Person and Government.

His Royal Highness the PRINCE REGENT in Council.

HEREAS by an Act, passed in the twentycighth year of the reign of His present Majesty, intituled "An Act for regulating the trade between the subjects of His Majesty's jesty, colonies and plantations in North America and " in the West India Islands and the countries be-" longing to the United States of America, and " between His Majesty's said subjects and the "Foreign Islands in the West Indies," it is, amongst other things, enacted, that it shall and may be lawful for His Majesty in Council, by Order or Orders to be issued and published from time to time, to authorise, or by Warrant or Warrants under His sign manual, to empower the Governor of Newfoundland for the time being, to authorise, in case of necessity, the importation into Newfoundland of bread, flour, Indian corn, and live stock, from any of the territories belonging to the said United States, for the supply of the inhabitants and fishermen of the Island of Newfoundland, for the then ensuing season only; provided always, that such bread, flour, Indian corn, and live stock, so authorised to be imported into the Island of Newfoundland, shall not be imported except in conformity to such rules, regulations, and restrictions as shall be specified in such Order or Orders, Warrant or Warrants respectively, and except by British subjects, and in British-built ships, owned by His Majesty's subjects, and navigated according to law:

And whereas it is expedient and necessary, that provision be made for fully supplying the inhabit-ants and fishermen of the Island of Newfoundland, for the ensuing season, with bread, flour, Indian corn, and live stock, His Royal Highness the Prince Regent doth thereupon, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, hereby order and declare, that for the supply of the inhabitants and fishermen of the Island of Newfoundland, for the ensuing season only, bread, flour, Indian corn, and live stock, may be imported into the said island from any of the territories belonging to the said United States, by British subjects, and in British-built ships, owned by His Majesty's subjects, and navigated according to law, and which within the space of nine months previous to the time of such importation, have cleared out from some port of the United Kingdom of Great Britain or Ireland, or other His Majesty's dominions in Europe, for which purpose a licence shall have been granted by the Commissioners of His Majesty's Customs in England or Scotland, or the Commissioners of His Majesty's Revenue in Ireland, or any other person or persons who may be duly authorised in that kingdom respectively, in the manner and form herein-after mentioned; which licence shall continue and be in force for nine calendar months from the day of the date upon which such licence is respectively granted, and no longer;

sprovided that no such licence as aforesaid, granted | and contents of each package of bread, flour, Indian after the thirtieth day of September next, shall be of any force or effect: and His Royal Highness is hereby further pleased to order, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, that the master or person having the charge or command of any ship or vessel to whom such licence shall be granted, shall, upon the arrival of the said ship or vessel at the port, harbour, or place in the said Island of Newfoundland where he shall discharge such bread, flour, Indian corn, and live stock, deliver up the said licence to the Col-lector or other proper Officer of the Customs there, having first indorsed on the back of such licence the marks, numbers, and contents of each package of bread, flour, Indian corn, and the number of live stock, under the penalty of the forfeiture in the said Act mentioned; and the Collector or other proper Officer of the Customs at Newfoundland, is hereby enjoined and required to give a certificate to the master or person having the charge or command of such ship or vessel, of his having received the said licence so indorsed as before directed, and to transmit the same to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland respectively, by whom such licence was granted. Now he it known, that the said [person's name] bath a licence to lade on board the said ship, [ship's name] at and from any port or place belonging to the United States of America, bread, flour, Indian corn, or live stock, the produce of the said United States, and no other article whatever; and to carry the said bread, flour, Indian corn, and live stock, to some port or place in the Island of Newfoundland; and on the arrival of the said ship at any port, harbour, or place of discharge in Newfoundland, the master or person having the charge or command of the said ship, is required and enjoined to deliver up the said licence to the Collector or other proper Officer of His Majesty's Customs there, and to indorse on the back thereof the marks, numbers, corn, and the number of live stock, and shall thereupon receive a certificate thereof from the said Collector or other proper Officer of the Customs.
