HEREAS by an Act passed in the present session of Parliament, intituled "An Act allow for three years, and until six weeks after the commencement of the then next session of Parliament, the importation into ports specially appointed by His Majesty within the provinces of Nova Scotia and New Branswick, of the articles therein enumerated, and the remember exportation thereof from such ports," it is enacted, that it shall and may be lawful, in any British-built ship or vessel, owned and navigated according to law, or in any ship or vessel belonging to the subjects of any Sovereign or State in amity with His Majesty, to import into, and export from, such ports within the provinces of Nova Scotia or New Brunswick, as shall be specially

said Act enumerated, any thing in any law to the contrary notwithstanding; His Royal Highness the Prince Regent, by virtue of the powers vested in His Majesty by the above-recited Act, is pleased, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, to order, and it is hereby ordered, that from and after the date of this Order, and during the centinuance of the Act above recited, until further order made thereon, it shall be lawful, in any British-built ship or vessel, owned and navigated according to law, or in any ship or vessel belonging to the subjects of any Sovereign or State in amity with His Majesty, to import into the port of Halifax, in Nova Scotia, and the port of Saint John, in New Brunswick, any scantling, planks, staves, heading-boards, shingles, hoops, horses, neat cattle, sheep, hogs, poultry, or live stock of any sort, bread, biscuit, flour, peas, beans, potatoes, wheat, rice, oats, barley, or grain of any sort, pitch, tar, turpentine, fruits, seeds, and tobacco; provided that such articles shall, in all cases where the same shall be imported in foreign vessels, be of the growth, produce, or manufacture of the country to which the vessels importing the same shall belong; and that it shall be lawful; in any British-built ship or vessel, owned and navigated according to law, to export from the said ports any of the said articles either to the United Kingdom or to any other of His Majesty's possessions :

And it is hereby further ordered, that it shall and may be lawful, in any British-built ship or vessel, owned and navigated according to law, or in any ship or vessel belonging to the subjects of any Sovereign or State in amity with His Majesty, to export from the ports of Halifax, in Nova Scotia, and Saint John, in New Brunswick, any gypsum, grind-stones, or other produce or manufacture of the said provinces, and also any produce or manufacture of the United Kingdom, or of His Majesty's colonies or plantations in the West Indies, or any goods whatever, which shall have been legally imported into the said provinces; provided that none of the said articles shall be

exported from the ports above-named, to any foreign country or place, in any foreign vessel, unless such foreign vessel shall belong to the country to which the said articles shall be exported:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary directions herein accordingly.

A T the Court at Carlton-House, the 13th of May 1918,

PRESENT,

His Royal Highness the PRINCE REGENT in Council.

WHEREAS the time limited by the Order of His Royal Highness the Prince Regent in Council of the tenth of October last, for prohibiting the exportation of gunpowder, arms, or ammunition, to the places therein specified, will expire on the thirtieth day of this instant May; and whereas it is expedient, that the said prohibition should be continued for some time longer; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to commence from the thirtieth of this instant May), presume to transport any gunpowder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa, or in the West Indies, or on any part of the Continent of America (except to a port or place, or ports or places in His Majesty's territories or possessions on the Continent of North America, or in the territories of the United States of America), or ship or lade any gunpowder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places on the Coast of Africa, or in the West Indies, or on the Continent of America (except as above excepted), without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled "An Act to empower His Majesty to prohibit the exportation of salt-petre, and to enforce the law for empowering His Majesty " to prohibit the exportation of gunpowder, or " any sort of arms or ammunition, and also to " empower His Majesty to restrain the carrying constwise of salt-petre, gunpowder, or any sort of arms or ammunition;" and also by an Act, passed in the thirty-third year of His Majesty's reign, cap. 2, intituled "An Act to enable His " Majesty to restrain the exportation of naval stores, and more effectually to prevent the ex-

" portation of salt-petre, arms, and ammunition, when prohibited by Proclamation or Order in Council:"

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain.

A T the Court at Brighton, the 30th day of December 1817,

His Royal Highness the PRINCE REGENT in Council.

HEREAS by an Act, passed in the twentycighth year of the reign of His present Ma-jesty, intituled "An Act for regulating the "trade between the subjects of His Majesty's "colonies and plantations in North America and " in the West India Islands and the countries be-" longing to the United States of America, and between His Majesty's said subjects and the " Foreign Islands in the West Indies," it is, amongst other things, enacted, that it shall and may be lawful for His Majesty in Council, by Order or Orders to be issued and published from time to time, to authorise, or by Warrant or Warrants under His sign manual, to empower the Governor of Newfoundland for the time being, to authorise, in case of necessity, the importation into Newfoundland of bread, flour, Indian corn, and live stock, from any of the territories belonging to the said United States, for the supply of the inhabitants and fishermen of the Island of Newfoundland, for the then ensuing season only; provided always, that such bread, flour, Indian corn, and live stock, so authorised to be imported into the Island of Newfoundland, shall not be imported except in conformity to such rules, regulations, and restrictions as shall be specified in such Order or Orders, Warrant or Warrants respectively, and except by British subjects, and in British-built ships, owned by His Majesty's subjects, and navigated according to law:

And whereas it is expedient and necessary, that provision be made for fully supplying the inhabitants and fishermen of the Islaud of Newfoundland, for the ensuing season, with bread, flour, Indian corn, and live stock, His Royal Highness the Prince Regent doth thereupon, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, hereby order and declare, that for the supply of the inhabitants and fishermen of the Islaud of Newfoundland, for the ensuing season only, bread, flour, Indian corn, and live stock, may be imported into the said island from any of the territories belonging to the said United States, by British subjects, and in British-built ships, owned.

by His Majesty's subjects, and navigated according to law, and which within the space of nine months previous to the time of such importation, have cleared out from some port of the United Kingdom of Great Britain or Ireland, or other His Majesty's dominions in Europe, for which purpose a licence shall have been granted by the Commissioners of His Majesty's Customs in England or Scotland, or the Commissioners of His Majesty's Revenue in Ireland, or any other person or persons who may be duly authorised in that kingdom respectively, in the manner and form herein-after mentioned; which licence shall continue and be in force for nine calendar months from the day of the date upon which such licence is respectively granted, and no longer; provided that no such licence as aforesaid, granted after the thirtieth day of September next, shall be of any force or effect: and His Royal Highness is hereby further pleased to order, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, that the master or person having the charge or command of any ship or vessel to whom such licence shall be granted, shall, upon the arrival of the said ship or vessel at the port, harbour, or place in the said Island of Newfoundland where he shall discharge such bread, flour, Indian corn, and live stock, deliver up the said licence to the Col-lector or other proper Officer of the Customs there, having first indorsed on the back of such licence the marks, numbers, and contents of each package of bread, flour, Indian corn, and the number of live stock, under the penalty of the forfeiture in the said Act mentioned; and the Collector or other proper Officer of the Customs at Newfoundland, is hereby enjoined and required to give a certificate to the master or person having the charge or command of such ship or vessel, of his having received the said licence so indorsed as before directed, and to transmit the same to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland respectively, by whom such licence was granted. Now be it known, that the said [person's name] hath a licence to lade on board the said ship, [ship's name] at and from any port or place belonging to the United States of America, bread, flour, Indian corn, or live stock, the produce of the said United States, and no other article whatever; and to carry the said bread, flour, Indian corn, and live stock, to some port or place in the Island of Newfoundland; and on the arrival of the said ship at any port, harbour, or place of discharge in Newfoundland. the master or person having the charge or command of the said ship, is required and enjoined to deliver up the said licence to the Collector or other proper Officer of His Majesty's Customs there, and to indorse on the back thereof the marks, numbers, and contents of each package of bread, flour, Indian corn, and the number of live stock, and shall thereupon receive a certificate thereof from the said Collector or other proper Officer of the Customs.

To His Royal Highness George Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland, &c. &c.

WE, the Presbyterian Ministers and Elders, distinguished by the name Seceders, cordially embrace the opportunity of our annual meeting, to lay before the Throne the sincere expressions of our inviolable attachment and gratitude to His Majesty's Person, Family, and Government, under which we are happily blessed with the undisturbed enjoyment of civil and religious liberty, and have increased in number and respectability.

In the domestic afflictions of the Royal Family, we feel a lively sympathy and anxious solicitude; with the deepest concern we have heard of the much lamented and long continued indisposition of our venerable Monarch, from whose liberality we have received repeated proofs of paternal affection.

In the joy and the triumphs excited by the grand events that have occurred under your Royal Highness's administration, we have participated with no ordinary emotions of gratitude to the Giver of all Good. Events for which past times can scarcely produce a paralel, and which have elevated the British empire to a pinuacle of glory, unrivalled among the nations of the world; and while we have recorded with thanksgivings the victories

which have been achieved by sea and land, we have beheld with astonishment and transport the extraordinary exertions which are made to communicate the light of Christianity to the regions which have long lain in the shadow of death. Thus exhibiting the British empire in the singular attitude of wielding with one hand the thunderbolts of war, and holding forth in the other the word of God and the olive branch of peace to the different nations of the earth.

As unmingled prosperity is not the lot of man, it has pleased Providence, after our victories and triumphs, to visit us with famine and with a pestilential disease, attended with unusual mortality; we have felt some of the bitter effects of a long protracted war, but we are happy to state that judgments have been accompanied with mercy, and a brighter prospect is now opened to our view, in the revival of trade, and the promising abundance with which the fields are covered.

Our prayers for your Royal Highness are, that you may be long spared; that your administration may be peaceful and prosperous; and that when you cease to reign on earth, you may be elevated to a throne on which no anxiety is felt, and from

which there is no removal.


