A T the Court at Carlton-House, the 19th of March 1819,

#### PRESENT,

His Royal Highness the PRINCE REGENT in Council.

WHEREAS there was this day read at the Board a Memorial from the Commissioners appointed by Act of Parliament for more effectually discovering the Longitude at Sea, dated the 4th of last month, in the words following, viz:

"Whereas by an Act of the fifty-eighth year of His present Majesty, initialed "An "Act for more effectually discovering the "Longitude at Sea, and encouraging attempts "to find a Northern Passage between the "Atlantic and Pacific Oceans, and to approach "the Northern Pole," it is provided, that, "for the encourgement of persons who may attempt the said Passage, or approach to the Northern Pole, but not wholly accomplish the same; the said Commissioners may, by their Memorial, propose to His Majesty in Council, to direct and establish proportionate rewards to be paid to such person as aforesaid, 'who shall first have accomplished certain proportions of the said Passage or Approach:"

And whereas it appears that the progress of discovery has already advanced on the Eastern Coast of America, and within the Arctic Circle, as far as 90 degrees West Longitude, or thereabouts, from Greenwich; and Northwards has not yet arrived, according to any well authenticated accounts, so far as 81° of North Latitude:

We, your Memorialists, beg leave most humbly to represent these particulars for your Royal Highness's consideration, and to submit, with all humility, whether your Royal Highness may not be graciously pleased to establish the following scale of rewards, to be allotted according to the intentions of the Act:

1.—To the first ship belonging to any of His Majesty's subjects, or to His Majesty, that shall reach the Longitude of 110° West from Greenwich, or the Mouth of Hearne's or Coppermine River, by sailing within the Arctic Circle

To the first ship, as aforesaid, that shall reach the Longitude of 130° West from Greenwich, or the Whale Island of Mackenzie, by sailing within the Arctic Circle

THE following Address has been presented to His Royal Highness the Prince Regent; which Address His Royal Highness was pleased to receive very graciously:

To His Royal Highness the PRINCE REGENT.

The humble Address of the Archbishop, Bishops, and other Clergy of the Province of Canterbury, in Convocation assembled.

#### May it please your Royal Highness,

WE, His Majesty's dutiful and loyal subjects, the Archbishop, Bishops, and other Clergy of the Province of Canterbury, in Convocation assembled, approach your Royal Highness with profound respect and humility.

It is our duty, Sir, and however painful the frequent repetition of it may be, it is still our duty, to express to your Royal Highness our sincere grief for the death of your Royal Mother, the Queen.

The illustrious example which Her Majesty, for more than half a century, held out to the people of this country, in religion and in morals, cannot be brought back to our recollection without suggesting to us the deepest regret for the loss we have sustained.

Our national character has in some sort fashioned itself after the great models which the Throne for so many years has afforded to both sexes. We have full confidence, Sir, that the same character will be maintained under your Royal Highness's countenance and protection. For assuredly it is upon this basis, that the greatness of a people is founded. Conquests may be achieved and nations aggrandised, by sudden violent and irregular exertions; but empires are consolidated and held together by principles of a very different description, by a steady and firm attachment to the constitutional government of the country, by respect and veneration for its laws and ordinances, by sincerity of manners and purity of morals, and above all, by a just sense of what is due from man to the revealed will of God.

The earnestness with which your Royal Highness was pleased to direct the attention of the late Parliament in its last session, to the deficiency of places of public worship belonging to the Established Church, affords ample proof of the importance your Royal Highness attaches to the religious institutions of the country.

Your Royal Highness's recommendation was cheerfully adopted, and notwithstanding the pressure that existed at that time upon the public finance, a large and liberal grant for building, and promoting the building of churches in populous parishes, was voted with an unanimity that rarely belongs to questions of public expenditure.

When, Sir, the primary object, of this grantshall be accomplished, it will be our duty to carry into effect, as far as we are able, the ultimate purposes of it, and to being back to the Church those whom the want of room may have hitherto excluded from it.

During the period, Sir, if which your Royhl Highness has directed the affairs of this great nation, a period alike distinguished by its difficulties and its successes, we have observed with equal admiration and gratitude, not only the height to which your Royal Highness has raised the military glory of the country, but also the steady and firm hand with which your Royal Highness has upheld the constitutional government of it in Church and State. Whatever dangers, Sir, may hereafter threaten either, and if either be seriously threatened both are in danger, we have full confidence in your Royal Highness's vigilance to discover, and firmness to resist them in their earliest approaches. We pray God to bless and protect you.
