His Royal Highness the Prince Regent has been pleased, in the name and on the behalf of His Majesty, to give and grant unto Edmund Heagren, of Quarles, near Holkham, and of Thorpland, near Fakenham, in the county of Norfolk, Esq. only son and heir of Edmund Heagren, of Quarles aforesaid, Esq. deceased, and grandson of Edmund Heagren, of Crabs Castle, in the parish of Wighton, in the said county, Gent. deceased, by Mary his wife, the only daughter of Ralph Gibbs, of Quarles, and sister to Rice Gibbs, also of Quarles aforesaid, Gent. deceased, His Majesty's royal licence and authority, that he and his issue may take and use the surname of Gibbs, in addition to and before his surname of Heagren, and bear the arms of Gibbs quarterly with the arms of Heagren, Gibbs in the first quarter, in compliance with the request of his said late father, and out of grateful respect to the family of Gibbs; such arms being first duly exemplified according to the laws of arms, and recorded in the Herald's Office, otherwise the said royal licence and permission to be void and of none effect:

And also to order, that the said royal concession and declaration be registered in His Majesty's College of Arms.
