A PROCLAMATION.

GEORGE, P. R.

WHEREAS the Parliament stands prorogued to Tuesday the second day of November next, We, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, do hereby publish and declare, that the said Parliament shall be further prorogued on the said second day of November to Tuesday the twenty-third day of said month; and We have given order to the Lord High Chancellor of that part of the United Kingdom of Great Britain and Ireland called Great Britain, to prepare a Commission for proroguing the same accordingly. And We do further hereby, in the name and on the behalf of His Majesty, and by and with the advice aforesaid, publish and declare, that the said Parliament shall, on the twenty-third day of November next, be held and sit for the dispatch of divers urgent and important affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly, at Westminster, on the said twenty-third day of November next.

Given at the Court at Carlton-House, the eleventh day of October one thousand eight hundred and nineteen, in the fifty-ninth year of His Majesty's reign.

THEREAS by an Act, passed in the last session of Parliament, intituled "An Act to " enable His Majesty to direct the distribution of any reward awarded by the Commissioners of "the Customs or Excise to the Officers of the Army, Navy, or Marines, for apprehending sugglers, in such manner as His Majesty shall " be pleased to appoint," reciting, that by the laws now in force for the prevention of smuggling, it is lawful for the Commissioners of Customs or Excise in England, Scotland, and Ireland respectively, and they are thereby required, in certain cases, to award, to every Officer or other person arresting any person for breach of those laws, so that he shall be convicted or committed to prison on account thereof, any sum not exceeding twentypounds for each man so convicted or committed to prison; and that it is expedient that His Majesty should be empowered, in certain cases, to direct the distribution of such reward, by His Order or Orders-in Council, or by His Royal Proclamation in that behalf, in such manner as He shall be pleased thereby to appoint; and, therefore, enacting that in all cases wherein the Commissioners of the Customs or Excise of England, Scotland, and Ireland respectively, shall award any sum not exceeding twenty pounds as aforesaid to any Officer or Officers, non-commissioned Officers, petty Officers, seamen or privates of His Majesty's Army, Navy, or Marines, or acting under the Orders of the Lord High Admiral, or of the Commissioners for executing the office of the Lord High Admiral of the United Kingdom of Great Britain and Ireland, for any person so arrested, convicted, or committed to prison as aforesaid, the same shall be divided and distributed in such proportions, and according to such rules, regulations, and Orders as His Majesty shall, by His Order or Orders in Council, or by His Royal Proclamation in that behalf, be pleased to direct and appoint.

In pursuance of the powers so vested in His Majesty, His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, is pleased to Order, and it is hereby Ordered, that the bounty money, awarded for the arrest of any person or persons, arrested, convicted, and committed to prison, according to the provisions of the laws above recited, by any Officer or Officers, noncommissioned Officers, petty Officers, seamen or privates of His Majesty's Army, Navy, or Marines, or acting under the Orders of the Lord High Admiral, or of the Commissioners for executing the office of Lord High Admiral of the United Kingdom of Great Britain and Ireland, shall be divided and distributed amongst such Officers, non-commissioned Officers, petty Officers, seamen or privates of His Majesty's Army, Navy, or Marines, or acting under the Orders of the Lord High Admiral, or of the Commissioners for executing the office of the Lord High Admiral of the United Kingdom of Great Britain and Ireland as aforesaid, according to the rules and regulations directed and provided by His Majesty's Order in Council of the fourteenth of October one thousand eight hundred and sixteen, for the distribution of the shares of any such seizures, as are or shall, by virtue of any Acts relating to the trade and revenues of His Majesty's dominions, be payable to and amongst the Commanders, Officers and crews of any of His Majesty's ships or vessels of war.

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to cause His Royal Highness's pleasure, hereby signified, to be Jas. Buller.

WHEREAS it is deemed expedient, that the Order in Council of the twenty-eighth May last, prohibiting the export of any gun-powder or saltpetre, or of any sort of arms or ammunition from the ports of this kingdom to the places therein specified, should be extended to all the ports within the dominion of the King of Spain; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, doth therefore hereby order, require, and command, that the prohibition laid by the aforesaid Order, of the twenty-eighth May last, be, and the same is hereby, extended to all ports within the dominion of the King of Spain, and made subject to all the conditions, regulations, and restrictions specified in the said Order of the twenty-eighth May last:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest, of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain.

THEREAS by an Act, passed in the fiftyseventh year of His present Majesty, inti-" An Act to continue and extend the provisions of an Act of His present Majesty " for regulating the trade and commerce to and " from the Cape of Good Hope, until the fifth day of July one thousand eight hundred and twenty; and also for regulating the trade of the Island of Mauritius;" His Majesty is authorised, by and with the advice of His Privy Council, by any Order or Orders to be issued from time to time, to give such directions, and to make such regulations touching the trade and commerce to and from all islands, colonies, or places, and the terri-tories and dependencies thereof, to His Majesty belonging or in His possession, in Africa, or Asia to the eastward of the Cape of Good Hope (excepting only the possessions of the East India Company), as to His Majesty, in Council, shall appear most expedient and salutary, any thing contained in an Act, passed in the twelfth year of the reign of His Majesty King Charles the Second, intituled "An Act for the encouraging and increas-" ing of shipping and navigation," or in an Act, passed in the seventh and eighth years of the reign of His Majesty King William the Third, intituled "An Act for preventing frauds, and regulating abuses in the plantation trade," or any other Act or Acts of Parliament now in force, relating to His Majesty's colonies and plantations, or any other Act or Acts of Parliament, law, usage or custom to the contrary in any wise notwithstanding; His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, is pleased to order, and it is hereby ordered, that from and after the date of this present Order, British vessels arriving at any port of the Island of Mauritius, or its dependencies, from any country in amity with His Majesty, laden with any articles. of the growth, production, or manufacture of such country (excepting all articles composed of cotton, iron, steel, or wool of foreign manufacture), shall be permitted to enter and land their cargoes, and dispose of the same in the said ports, subject to such duties as may be payable thereon:

And it is further ordered, that every such British vessel, arriving as aforesaid, shall be permitted to export to any such foreign country in amity with His Majesty, a cargo consisting of any articles of the growth, produce, or manufacture of the Island of Mauritius, or its dependencies, or of any other articles which shall have been legally imported there, on payment of such duties as may be payable thereon:

And it is hereby further ordered, that vessels belonging to the subjects of any foreign state in amity with His Majesty, which foreign state shall allow British vessels to carry on trade as aforesaid Cheiwynd. between the ports of such state and the Island of Mauritius, on the same terms as in vessels of such foreign state, shall be permitted in like manner to import into the ports of the Island of Mauritius, or its dependencies, from any port of the country to which such vessel shall belong, any articles of the growth, production, or manufacture of such country (excepting all articles composed of cotton, iron, steel, or wool of foreign manufacture), and to dispose of the same in the ports of the said Island and its dependencies, on payment of the same duties as shall be payable on the like articles when imported from such foreign port in British vessels; and that every such foreign vessel shall be permitted to export a cargo consisting of any articles of the growth, produce, or manufacture of the Island of Mauritius, or its dependencies, or of any other articles which shall have been legally imported there, on payment of the same duties as shall be payable on similar articles when exported to such foreign ports in British vessels:

It is, however, hereby further ordered and declared, that no foreign vessel, allowed by the terms of this Order to export a cargo from the Island of Mauritius, or its dependencies, shall be permitted to export such cargo to any of His Majesty's possessions, or to any other place than a port or place belonging to the state or power to which the vessel itself shall belong:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary directions herein as to them may respectively appertain.

THE following Addresses, having been transmitted to Viscount Sidmouth, one of His Majesty's Principal Secretaries of State, by the several persons whose names are respectively subjoined to each Address, have been presented by His Lordship to His Royal Highness the Prince Regent, who was pleased to receive the same very graciously:

To His Royal Highness the Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

May it please your Royal Highness,

IT is with sentiments of the deepest concern, that we, His Majesty's loyal and dutiful subjects, the Master, Wardens, and Commonalty of Merchant Venturers of the City of Bristol, feel ourselves again called on by the present alarming state of the country, to renew to your Royal Highness the assurances of our inviolable attachment to the Constitution of these realms, as established in Church and State, and our fixed determination to defend it, by every means in our power, against the perils with which it is assailed.

We have observed with the utmost indignation, the continuance of that formidable system of operations, by which a set of evil-disposed persons, few we hope in number, but most dangerous in their principles, are endeavouring to seduce the lower orders of the people from their obedience to the laws, and to drive them, under the pretence of

petitioning for reform, into a state of actual rebellion.

Aware that to the accomplishment of their traitorous designs, the influence of religion opposed the strongest obstacle, these shameless impostors have not hesitated to attack Christianity itself. In aid of the seditious effusions of the weekly and daily press, publications, fraught with impiety and blasphemy, have, with the most industrious activity, and in every variety of form best adapted to the understandings of the lower class of society, been circulated throughout the land.

The effects produced by this fearful combination of atheism and treason, as exhibited in the seditious assemblings of the people, in their previous inilitary trainings, in the appointment of delegates to represent them in Parliament, and in the studied and systematic insults offered to all civil authorities, are of too formidable a nature to be viewed without alarm.

Relying, however, on the paternal care of your Royal Highness, under whose auspicious Government we have enjoyed so much prosperity, and on the vigilance and vigour of His Majesty's counsels, we feel assured that every measure will be adopted in the present crisis for the salvation of the country, whether by the enforcement of the existing laws, or if insufficient, by the enactment of new, that wisdom can devise or patriotism suggest.

The dutiful Address of the Provincial Synod of Fife.

May it please your Royal Highness, WE, His Majesty's dutiful and loyal subjects, the Ministers and Elders of the Provincial Synod of Fife, assembled at our ordinary autumnal meeting, feeling it to be the duty of all well-disposed subjects of His Majesty to stand forward at this important juncture, to resist the attempts which wicked and designing individuals are making in different parts of the kingdom to corrupt the minds of the lower orders of the people by disseminating amongst them seditious and blasphemous publications, with a view of alienating them from their duty to their Sovereign, their respect for the laws, and their veneration for our holy religion, beg leave to express our abhorrence of such proceedings, and to offer to your Royal Highness the assurances of our determination to exert our utmost endea-vours to defeat such views, and to counteract such principles by inculcating within our respective parishes a due regard for His Majesty's Person and Family and for the Government of your Royal Highness, and a pious submission to the wise dispensations of Providence.

We lament that so much distress should exist among the labouring classes in the populous manufacturing districts of the country, and are ready to contribute in any way that may be found most expedient for their relief. At the same time we are convinced that these distresses, which we hope

will prove but temporary, do not arise from the causes to which the unfortunate sufferers are taught to ascribe them, but from circumstances not under the immediate controul of any human agency, and that they can never be remedied, but on the contrary, must be increased by tumult and insurrection.

That Divine Providence may alleviate the affliction of our venerable Sovereign, and bless your Royal Highness's Person and Government, and protect your illustrious House to latest ages, is our

sincere prayer.

To His Royal Highness the PRINCE REGENT.

WE, the Magistrates, Clergy, Citizeus, and Inhabitants of the City and County of Norwich, taking into consideration the critical state in which the security and welfare of the kingdom continue to be placed by the designs and riotous practices of the seditions and the disaffected, regard it as a duty incumbent on us to make a public declaration of our sentiments of devoted and unshaken loyalty to His Majesty's Person and Government, and our principles of firm and ardent attachment to the Constitution of these Realms.

A duty we feel the more imperiously called upon to discharge, in consequence of an Address voted by a meeting held in Saint Andrew's Hall on the 16th instant. This meeting justified on the ground, neither of collective strength nor of individual consequence, in its attempt to identify with the tenor of its own resolutions the general opinion of the inhabitants of Norwich, has proceded to the unwarrantable length of prejudging and condemning the Prince Regent's Ministers and the Magistrates

of Manchester.

With the temper of a proceeding so harsh and ill-timed, we disavow the remotest feeling of congeniality: in the spirit of a decision so prema-ture and injurious we disclaim all participation; yielding to none in the disposition to value, or in the determination to guard the chartered right of the people to meet and to petition; opposed to no rational plan of public benefit and advantage; we are at the same time decidedly of opinion that neither reformation of abuses nor remedy of grievances can be obtained, nor the temporary distresses which press alike upon this empire and the world at large can be removed, by means of tumultuous assemblages, brought together by artful and factious appeals, to prejudice and passion, and excited to the extreme of discontent and irritation by the inflammatory harangues of delegates and missionaries, who under the delusive pretext of radical reform, inculcate disrespect to the constituted powers of the State, and disseminate doctrines that tend to overthrow the salutary distinctions of civilized life, to undermine and destroy the sacred influences of Religion, and to subvert the established Government of the Nation.

As friends of humanity, as lovers of peace, we and used by his issue; provided the said armorial sincerely deplore the unfortunate occurrences of ensigns be first duly exemplified according to the

the 16th of August; yet it is to our minds a source of most consolatory reflection to known that the tribunals of the land have already taken cognizance of the circumstances of that occasion. Impressed therefore with a well founded confidence in the upright administration of the laws, we feel equally assured of their adequacy to maintain right and to redress wrong for a people persevering in a due obedience to them, and honestly appreciating those social and moral blessings of which they are the safeguard. Nor can we view the efforts which in this city and elsewhere have been made, in the absence of every thing like complete and authentic information, to affix guilt of the blackest dye on the local authorities of a large and populous district, and on those who have acted under their direction, at a moment when the case involving their character and conduct may be considered to be in a course of trial, in any other light than as an improper and dangerous experiment on popular feelings as an indecorous infringement on the rights and functions of juries, and as directly hostile to the principles of real Euglish liberty and to the cause of impartial justice.
