THE following Addresses, having been transmitted to Viscount Sidmouth, one of His Majesty's Principal Secretaries of State, by the several persons whose names are respectively subjoined to each Address, have been presented by His Lordship to His Royal Highness the Prince Regent, who was pleased to receive the same very graciously:

To His Royal Highness George Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

The dutiful and loyal Address of the Noblemen, Freeholders, Justices of the Peace, and Commissioners of Supply of the County of Linlithgow.

May it please your Royal Highness,

WE, the Noblemen, Freeholders, Justices of the Peace, and Commissioners of Supply of the County of Linlithgow, consider it to be our duty, on the present occasion, to approach the Throne, through the medium of your Royal Highness, not only with the usual expressions of loyalty and fidelity, but with a firm, an explicit, and we trust a temperate, declaration of the sentiments we entertain on the state of public affairs.

We are firmly convinced that the British Constitution as by law established, has been productive of more practical good, and of more real freedom, than has resulted from any other system by which

Nations have been governed

We are persuaded that under its benign influence, this Country has attained to a height of prosperity, of power, and of national glory, to which no other circumstance in our situation, could have carried us.

That Constitution we venerate and cherish, as the glorious inheritance that has descended to us from our Ancestors, and we are determined, as far

as in us lies, to transmit it unimpaired to our pos-

terity.
We have therefore observed with unmingled detestation, the systematic endeavours that have lately been made, to bring into contempt Institutions, which have been productive of so much happiness and prosperity to this Empire.

The efforts of turbulent and disaffected men tomislead the ignorant and unwary, to foster all the bad passions of the idle and the profligate, and to employ them for the purposes of their own ambition, if not checked by seasonable vigour, will, we are persuaded, sap the foundations of our liberty. and overthrow all that is most dear to us as men

and as subjects.

Happily indeed the objects of these turbulent men are no longer disguised .- Emboldened by the popular applause of some districts, where the usual resources of industry have suddenly, and unexpectedly failed, and where the people are consequently more open to seduction, they have thrown off the mask.---They have openly avowed the most blasphemous and most seditious sentiments. effort has been made to corrupt the moral and religious feeling, and to shake and extirpate the loyalty of the people; and it is no longer doubtful that the existence of our Religion, of our Government, the security of our property, and the order of Civil Society itself, are placed in the most imminent danger.

We have the happiness indeed to believe, that in the district which we inhabit, these poxious principles have hitherto made little or no progress. We rejoice to think that the population around us continues hitherto uncontaminated. We rejoice to think that in this corner of our Island, the God of our fathers is worshipped in simplicity, and in sincerity; that the truths of our holy religion are held in universal respect by all sects and denominations of men; that loyalty to the Throne, is a principle deeply rooted in the minds of all; that confidence in the equity, and in the just administration of the laws is unshaken; and that veneration for the great Council of the Nation, and attachment to the Government, as vested in King, Lords and Commons, pervade all ranks among us.

But we lament that in some other districts, a far different spirit appears to prevail. We cannot disguise from ourselves that the growing influence of example is always to be feared; and that if the voice of loyalty is not heard, if the friends of the peace, the order, and the happiness of their Country do not stand forward to meet the danger and to counteract its baneful influence, the torrent may speedily overflow the land, sweep away in its fury the Institutions under which we live, annihilate the invaluable privileges we enjoy, and overwhelm the glory and the prosperity of the British Empire.

Strongly impressed with these sentiments, and acting under a deep sense of public duty, we desire to offer to your Royal Highness, the expression of our unshaken loyalty to the King our Sovereign, and of our dutiful attachment to the Person and Government of your Royal Highness as the Regent

of these Realms.

We request your Royal Highness to be persuaded that our utmost efforts shall be used for the maintenance of order and tranquillity, and that by our influence and example, we shall endeavour to counteract the progress of infidelity and of disaffection. We desire to assure your Royal Highness, that we entertain the most perfect confidence that the wisdom of Parliament will devise the means best calculated to allay or to subdue the ferment that exists. We trust that the sound sense and the energy of the Nation will be called forth, in proportion to the exigency of the times, and be powerfully exerted to aid the efforts of the Legislature, and which we trust will be the means, under Providence, of maintaining inviolate, the peace, the security, and the liberty of this great Empire.

To His Royal Highness the PRINCE REGENT.

AT a time when the spirit of loyalty throughout His Majesty's dominions is peculiarly called into action by the tumultuous and dangerous assemblies which have recently and widely been convened, it would ill become the Inhabitants of a place, so long and so eminently distinguished for its loyalty, to be the last in approaching your Royal Highness with those demonstrations of attachment, which their genuine feelings suggest, and the important crisis demands.

We witness with feelings of grief and indignation the artful attempts of factious and designing men to inculcate, under the specious but delusive pretext of radical reform, doctrines subversive of all existing Authorities, and directly tending to destroy our invaluable and unrivalled Constitution.

We view with still more lively abhorrence the infamous attempts which have been made by blasphemous publications to sap the foundations of re-

ligion, and to bring into contempt the Holy Scriptures.

And we pledge ourselves to use our most active exertions in defending all that is dear to us as Englishmen, and in apposing all attempts to overawe the constituted authorities, under a full reliance on the efficacy of the laws, on their power to maintain right and to redress wrong, on the purity of their administration, and on the wisdom of His Majesty's Councils for securing to us a continuance of those invaluable blessings which are enjoyed by all His Majesty's subjects in this great and free Country.

We contemplate too, with detestation, the daring and impious attacks of infidels against the Christian Religion, founded as it is and confirmed by divine interposition and authority, and embraced and sauctioned by the wisest and best human institutions.

Although far remote from the districts in which such a spirit of disloyalty and discontent prevails, we conceive it a duty we owe to our Prince, and to our Country, to avow to your Royal Highness the principles which actuate our conduct, and to assure you of our uniform and unshaken determination to support, on every emergency, that invaluable Constitution by which the lives, the liberties and the property of all British subjects have been so admirably secured and protected.

To His Royal Highness the PRINCE REGENT.

The loyal and dutiful Address of the Magistrates and Town Council of the Burgh of Musselburgh.

May it please your Royal Highness,

WE His Majesty's most loyal and dutiful Subjects, the Magistrates and Town Council of the Burgh of Musselburgh, anxiously approach your Royal Highness, at the present crisis, with sentiments of the warmest veneration and attachment to our beloved Sovereign and His illustrious House, and of the deepest love and admiration for that Constitution under which we enjoy the best system of rational liberty which the wisdom of man has yet devised.

We deplore in common with the great majority of the nation the existence of that spirit of insubordination, which has risen to such an alarming height in certain districts of the country. We humbly trust it may not extend beyond those limits within which it has hitherto been chiefly confined; and that the causes which have produced it, as they are sufficiently understood, may speedily be removed or ameliorated by the salutary measures of His Ma-

jesty's Government.

We confidently anticipate the return of order and subordination throughout the land; and did their restoration depend on the voice of the people at large, uninfluenced by those who at present delude so large a portion of our manufacturing population, we are firmly persuaded that few indeed would be found whose hearts and hands would not unite to guard the Throne from faction, and the Constitution from the attacks of the designing. But it is with feelings of no common indignation that we observe the efforts of Government frustrated, and the lower orders themselves deluded and seduced from their allegiance by men of abandoned principles.

Our liberty and our laws have been invaded; above all, our religion has been openly attacked. Publications of a blasphemous and atheistical tendency have been disseminated abroad to corrupt the general mind, and to wound in a peculiar manner the understandings of the rising generation.

Under these circumstances of danger and distress we are desirous of approaching the Throne to express our abhorrence of these evils, and our earnest hope and belief that they will last but for a season, and to assure your Royal Highness of our devont attachment to our King and Constitution. It shall ever be our determined resolution to stand by the Throne, and to assist in defending to the uttermost the Constitution of Great Britain, against every attempt that may be made to undermine its excellent fabric. Whatever measures may conduce to the peace and the comfort of those within our Jurisdiction shall be zealously adopted, that the people under our charge, as they have hitherto proved themselves loyal and peaceable subjects, may continue to abound in every patriotic virtue,

We beg your Royal Highness will be graciously pleased to accept of these our imperfect expressions of devotion to your Illustrious Family, and of inviolable attachment to the religion, liberty and laws, which we enjoy, under this blessed Consti-

tution.

We rely with confidence on the wisdom of your Royal Highness, and the other branches of the legislature to supply all the means in your power towards alleviating the sufferings of the people; whilst at the same time we confidently expect that you will take such measures as may be deemed necessary for frustrating the machinations of the disaffected who are anxiously endeavouring to subvert our happy constitution. And we beg to assure your Royal Highness that we shall feel it incambent on us to check by example and influence all attempts towards irreligion and sedition, and to manifest that spirit of loyalty which has at all periods of our history been the peculiar characteristic of the inhabitants of the County of Cornwall.

Trusting that Britain will long continue to be, protected by Providence, and to be defended by all right-hearted men, we beg leave to assure your Royal Highness that we will use every endeavour in our respective situations to preserve those sentiusents of attachment to the Royal Family, and of submission to the laws, by which all classes of the Inhabitants of Leith have been uniformly distin-

guished.

WE, His Majesty's loyal and most dutiful subjects, the Faculty of Physicians and Surgeons at Glasgow, beg leave in the present juncture, humbly to approach the Throne with a renewed expression of our firm and unshaken attachment to the Constitution of the Country as by law established. We have never ceased to venerate the wise and sa-Intary institutions, which were handed down to us by our forefathers, and have ever been grateful to Divine Providence for the many important blessings which Britons have enjoyed under the mild parental sway of the House of Brunswick. In the exercise of our profession we have peculiar opportunities to be fully aware of the distress to which the labouring part of the community are reduced during the present stagnation of trade, and we have joined with our fellow-citizens in giving them both our sympathy and our aid; but with deep regret we perceive that the factions and the ill-disposed have been too successful in taking advantage of their present distress to exasperate the minds of many against the Institutions of the country, and to prompt them to seek after objects which are wild and chimerical in themselves, and which can have no effect in relieving the depressed state of manufactures and commerce. WE, His Majesty's dutiful and loyal subjects, the Freeholders and Householders of the County of Hertford, in County Hall assembled, beg leave

We beg leave to express to your Royal Highness our warm attachment to your Royal Highness's Illustrious Family, and our ardent veneration for the laws of our country, and for those sacred institutions which have been established equally for the security of the throne, and the protection of the subject. At the same time, we feel it to be our duty, most humbly, but most earnestly, to represent to your Royal Highness, that the occurrences which took place at Manchestor, on the 16th of August last, seem to us to demand the most strict and solemn Investigation, as having an appearance of being an infringement

ne at the most important rights of the subject, and a violation of the most essential principles of the Constitution. We beg leave further to represent to your Royal Highness, that the obstacles which have been opposed to an inquiry into those occurrences; the extraordinary, if not illegal adjournment of the Coroner's Inquest at Oldham; the sanction which your Royal Highness has been advised, by your Royal Highness's confidential servants, to give to the interference of a Military Force, attended with such fatal consequences, to the lives of his Majesty's subjects; all these circumstances afford us too much reason to apprehend, that without the interference of Parliament, and the express recommendation of your Royal Highness, that strict investigation, which the nature of the case and the feelings of the country require, will not be instituted. We therefore most respectfully beseech your Royal Highness to recommend to the immediate care and attention of Parliament, a full and solemn inquiry into these transactions.

May it please your Royal Highness,

WE, His Majesty's most dutiful and loyal subjects, the Ministers and Elders of the Presbytery of Glasgow, moved with serious alarm by the circulation of irreligious and seditions Writings, and by the tunultuous Meetings which have taken place for some time past in various parts of the Kingdom, beg permission to approach the Throne with expressions of profound respect for His Majesty's Person, of estcem for your Royal Highness, of nnalterable attachment to our happy Constitution, and of perfect confidence in the wisdom and energy of your Royal Highness's Councils.

While we fament the severe distress which the figuration of trade has occasioned, while we sin-

cerely sympathize with the operative classes who have been thrown out of employment by this calamity, and are earnestly desirous to exert every endeavour, in our sphere, to afford them relief, we cannot but view with indignation the insidlous attempts of the evil affected and seditious, to make these disasters a pretext for vilifying the Government, and spreading discontent through the land, thereby aggravating, in an incalculable degree, the

very evils of which they complain.

We behold with horror the effrontery of the profligate in disseminating the most dreadful impieties and blasphemies, with the evident design of corrupting the public mind, of unhinging the religious and moral principles of the less informed classes of society, thus preparing them for desperate deeds. We particularly bewail the artful and malignant attempts that are now making to render the rising generation totally unprincipled and vicious. Deeply deploring these melancholy features of the times, and convinced that nothing but Deeply deploring these melancholy feathe influence of true religion can effectually stop their growth, we shall not cease to preach the trnth as it is in Christ Jesus, under the firm persuasion that the monstrous doctrines of these emissaries of darkness will, under the Divine blessing, disappear before the general light of the glorious Gospel of the Son of God.

Entertaining the warmest affection for our country and the most cordial wishes for the happiness of our countrymen, we bewail the facility with which so many of the labouring classes are deluded into practices, which directly oppose their own best interests, keep the whole community in a state of most uneasy perturbation, and hinder the very steps which might be taken to alleviate their privations. To arrest the progress of this deplorable infatuation, and to save the people from the fatal effects of their own folly, we confidently rely on the vigilance and firmness of your Royal Highness's Administration, and trust that the Wisdom of Parliament will devise the most effectual means for extending and securing the benefits of moral and religious instruction to all classes of his Majesty's subjects, for preserving our excellent Constitution inviolate, and, at the same time, for completely repressing the turbulence of profligate and evil-designing men.

Feeling the sacred obligations which lie upon us to watch for the welfare of the people under ourcharge, we shall not fail diligently to warn them of the machinations which are at work to produce insubordination and violence, and we shall endeayour to cultivate in their minds piety towards God, loyalty to the King, reverence for the laws, and

steady attachment to the Constitution.

That Almighty God may impart his Divine consolations to the mind of our most gracious Sovereign, that He may obundantly bless your Royal Highness with every temporal and spiritual blessing; that He may direct your councils with wisdom from above, and enable you to maintain the United Kingdom in the high attitude among surrounding nations, to which, under the auspices of your Royal Highness, it has been raised; and that our invaluable Constitution in Church and State, may be transmitted unimpaired to latest posterity under princes of the illustrious House of Hanover,

The respectful and loyal Address of the Mayor, Aldermen, Common Council, and Burgesses of the Town of Cambridge in Common Hall assembled.

Most Gracious Prince,

WE, his Majesty's faithful subjects, the Mayor, Aldernien, Common Council, and Burgesses of the Town of Cambridge, deeply impressed with a sense of that duty which we owe to our Sovereign, our Country, and ourselves, anxiously press forward at this crisis of danger, renewing the solemn pledge of our loyalty, and rallying around the Throne and the Constitution.

We behold, with detestation and horror, but (relying under the blessing of Providence upon the sound loyalty, the moral and religious feeling of tho great mass of our fellow subjects) without dismay, the daring machinations of desperate and abandoned men, who under the maddening impulse of their infidel and revolutionary frenzy, stop not to undermine, but openly avow their flagitious design to overthrow, with the altars of our religion, the venerable fabric of our Constitution, and to plunge this hitherto favoured country into all the miseries of anarchy and desolation.

Imbibing their principles from the licentiousness and Atheism of the French school, they are sensible that the impression of the hopes and fears which Chsistianity holds out to us in a future state of reward and punishment, must first be eradicated from the mind; hence their object has been to ridicule, to vilify, and to degrade the doctrine, the morality, and the credibility of the Gospel; and thus, (having weakened, if not removed, the conviction of the awful responsibility of a world to come, and inculcated the necessary consequence that death is an eternal sleep) they render their frantic votaries fit instruments of that demoniacal ambition, which seeks only to delude and to destroy.

We devoutly trust, however, that this country has not been hitherto so mercifully and so signally preserved from the contagion of infidelity, and the horrors of revolution, to become in its turn a prey to the destructive machinations of the scoffers and biasphemers of religion; but that all ranks and classes, laying aside every minor political difference or religious distinction, will array themselves under the banners of social order and Christianity against the frantic enemies of both; prepared to second, with their utmost energy, those exertions which your Royal Highness, aided by the collective wisdom of the great Council of the Nation, may

May it please your Royal Highness,

WE, His Majesty's most loyal and dutiful subjects, the Provost, Magistrates, and Town Council of the Royal Burgh of Dunfermline, beg leave to approach your Royal Highness, to express to your Royal Highness our firm and undeviating attachment to your Royal Person and Government.

At a time like the present, when we perceive the most audacious and undisguised attempts resorted to by disaffected and unprincipled demagogues to poison the minds of the lower classes of his Majesty's subjects, through the industrious circulation of impious, and blasphemous publications, whose evident tendency is to bring into ridicule and contempt the sacred Scriptures, and even to brand the Divine Author of our Holy Religion, as "An enthusiast and impostor," to rend asunder the bonds of civil society, by holding out to the unthinking multitude, with the most appalling abuse of every sacred principle of religion, dogmas of Government equally absurd as they are impracticable, and so obviously calculated to alienate the affections of his Majesty's subjects. from the Government, and consequently to undermine and to destroy our happy and enviable Constitution. At such a time we conceive it to be our bounden duty, as loyal subjects to our revered andvenerable Sovereign, not only to express to your Royal Highness our firm attachment to your Royal-Person and Government, and our utter abhorrence of the infamous and desperate attempts of these insidious incendiaries, but to declare our firm adherence to the Constitution of our Country, and our determination, by every means in our power, to support that Government from whose determined, persevering, and gloriously succe-sful exertions, this kingdom and Europe have been rescued from an unrelenting and unexampled tyranny, restored to the blessings of peace, and continue to enjoy the exercise of a mild and Constitutional Administration of the Government.

We observe, with feelings of astonishment and detestation, the insidious arts resorted to, by hold and unfounded assertions, to prejudge and vilify the conduct and character of Magistrates acting in very critical circumstances, by the circulation of shameless fabrications, and the most palpable misrepresentations of facts, the prominent feature of a system which can have but one only object, to, deceive and to mislead.

We have unfeigned satisfaction, however, in ob-

serving, that in this populous manufacturing town, no symptom of disloyalty or discontent has hitherto appeared.
