By His Royal Highness the PRINCE of WALES, REGENT of the United Kingdom of Great Britain and Ireland, in the Name and on the Behalf of His Majesty,

A PROCLAMATION,

Requiring Passes, formerly granted to Ships and Vessels trading in the way of the Cruizers belonging to the Governments on the Coast of Barbary, to be returned into the Office of the Admiralty of Great Britain, and other Passes of different Forms to be issued.

THEREAS by Our Royal Proclamation, bearing date the third day of November, in the forty-third year of Our reign, We did charge and command all Our loving subjects who then were, or should be, possessed of any passes for ships and vessels belonging to Our subjects trading to Portugal, the Canaries, Guinea, the Indies, into the Mediterranean, or elsewhere, in the way of the cruizers belonging to the Governments on the Coast of Barbary (except such passes as had been granted to ships gone or going to the East Indies, or other remote voyages where they could not be timely furnished with new passes), that they should, before the thirty-first day of December one thousand eight hundred and three, return the same and furnish themselves with passes of a new form, under the hands and seals of the Commissioners for executing the office of High Admiral of Great Britain and Ireland, in lieu thereof, for their several ships and vessels, in such manner as by the said recited Proclamation was directed: and whereas it hath been humbly represented unto Us, that there is the greatest reason to believe that many of Our passes may, either by accident or undue means have fallen into the hands of foreigners, who by the clandestine use of such passes may carry on their trade; We, taking the premises into Our Royal consideration, and judging it necessary to put a speedy stop to all such indirect practices, which do not only tend to the prejudice of Our trading subjects, but may oceasion a misunder-

standing between Us and the Governments on the Coast of Barbary, for preventing thereof have thought fit, by the advice of Our Privy Council, to publish this Our Royal Proclamation, and do hereby declare, that the passes of the present form shall continue in force for all vessels sailing from the ports of Our United Kingdom of Great Britain and Ireland during the present year, in order to give sufficient time to Our trade to be furnished with passes of the new form, and that after the expiration of that time, no passes but those of the new form shall be considered as valid, except in the case of vessels returning from foreign voyages, where they cannot be timely furnished with new passes; and We do hereby further declare, that in the case of vessels returning from foreign voyages, passes of the present form shall continue in force during the terms hereinatter mentioned, that is to say,

For vessels returning from the ports to the northward of the Streights of Gibraltar, or from the ports within the Mediterraneau, to the thirty-first of March one thousand eight hundred and twenty.

For vessels returning from the West Indies, North America, and the western coasts of Africa, to the thirtieth of June one thousand eight hundred and twenty.

For vessels returning from the East Indies and all other distant parts, to the thirtieth of June one thousand eight hundred and twenty-one.

And We do hereby strictly charge and command all Our loving subjects, who are, or shall be possessed of any such passes, that they do, on or before the expiration of the periods herein before mentioned respectively, return the same into the office of the Admiralty of Great Britain, or to the respective Collectors of Our Customs at the out ports of Our United Kingdom of Great Britain and Ireland, or to the Governors of some of Our foreign plantations or dominions, in order to their being cancelled; and that they do furnish themselves with passes of the new form, under the hands and scals of Our Commissioners for executing the office of High Admiral of Our United Kingdom of Great Britain and Ireland, in licu thereof, for their

several ships and vessels, according to the Treaties | and as woon after in this Majesty's colonies, as the subsisting between Us and the said Governments on the Coast of Barbary, and the regulations made by Our Royal predecessor King George the First, by Order in His Privy Council on the fourteenth day of June in the year one thousand seven hundred and twenty-two, so far as the same remains unaltered, by the regulations made by Us by Our Orders in Conneil, bearing date respectively on the twentyeight day of August one thousand seven hundred and seventy-six, on the thirty-first day of December one thousand seven hundred and eighty-three, and the third day of November one thousand eight hundred and two, or Our Order in Council of this day's date, and according to the further regulations then there made, and our instructions given to Our said Commissioners for executing the office of High. Admiral of Great Britain and Ireland touching the same: and whereas many ships and vessels belonging to Our loving subjects continue several years trading from port to port in the Mediterranean without returning home, whereby they cannot so conveniently procure their passes to be exchanged: We do hereby, for the ease of Our trading subjects, publish and declare, Our pleasure, that upon the application of any owner of any ship or vessel, or other substantial merchant, to the office of the Admiralty of Great Britain, and oath made by him of the property of such ship or vessel, and that three fourths of the company are our subjects, ac-cording to an Act made in the twelfth year of the reign of Our Royal predecessor King Charles the Second (intituled "An Act for encouraging and "increasing of shipping and navigation)," or such other proportion as may be authorised by Act of Parliament, and upon entering into a bond for the return of such pass at the end of the period therein specified: it shall and may be lawful for Our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, or Our High Admiral of Our United Kingdom of Great Britain and Ireland for the time being, and they are respectively empowered to make out a new pass for such ship or vessel, and send the same to such of Our Consuls in the Mediterranean as the said owner or merchant shall desire, with directions to such Consul, that, upon application to him from the master of the ship, for which the pass is made out, and sur-rendering up his old pass, and entering into bond for the return of such new pass, he shall deliver out the said new pass to such hiaster, and transmit the old one with the bond to the office of the Admi-ralty of Great Britain.

And in order more effectually to hinder, for the withre, any abuses that may be attempted by foreigners, relating to the new passes to be issued as aforesaid, we do hereby further declare Our Royal will and pleasure, that the new form of passes, marked A, as recommended to Us by Our Comm'ssioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, in their memorial, bearing date the eighth day of September last, and approved by Us by Our Order in Council, of this day's date, shall be issued from and after the first day of January next, within

same may be received at each colony respectively; and that passes issued in the United Kingdom of Great Britain and Ireland, of the above-mentioned form, shall be in force during the voyage for which the said passes shall be taken out, and no longer, and shall be returned, at the termination of such voyage, to the Commissioners of our Customs, or to their Chief Officer at one of the outports, provided such voyage shall terminate in the United Kingdom of Great and Treland, or to the Governor or Lieutenant-Governor in any of the islands of Jersey, Guernsey, Alderney, or Man; and in case such woyage shall terminate in any of our possessions abroad, then that such passes shall be delivered up to the Governor or other person having chief authority there; but if such voyage shall terminate at any place out of our dominions, then such pass shall be delivered up to our Consul or his Deputy at such place, or who may be nearest thereto; and that passes to be issued in our colonies or possessions abroad shall, in like manner, be in force during the woyage or voyages for which they shall be taken out respectively, and no longer, and shall be returned at the termination of such voyage or voyages respectively, the manner hereinbefore directed, according to the port or place in which such voyage or voyages shall terminate respectively,; and that in all cases whatever of passes to be issued, such surety, by way of bond, shall be given to secure the due return of the passes, and to guard against any fraudulent or improper use of them, as hath been usual, or as our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, or Our High Admiral of Our United Kingdom of Great Britain and Ireland for the time being, may deem necessary to require according to the circumstances of the case.

And whereas it thas been recommended to Us, by our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, that for the more effectual prevention of abuses, and for the diminution of expence it may be convenient, in certain cases, that passes to the granted for the purposes aforesaid should be united with the ship's certificate of registry, Our will and pleasure is, that if any person shall be desirous of having the Mediterranean pass annexed to the certificate of registry of his ship, such pass so annexed may be issued agreeably to the form B, recommended to Us by Our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland in their memorial as aforesaid ; and that such pass shall not be separated from such certificate of registry, but shall be returned tat the same time when such certificate of registry shall be delivered up to be cancelled, and as ofren as any new certificate of registry shall be granted, an sannexed pass shall also be granted under the same conditions, if the party shall be desirous

tar and Malta, and whereas it is empedient that | Britain and Ireland for the time being, and they passes granted to the ships of the said places should be accompanied by some document proving that they belong to His Majesty's subjects in His Majesty's said possessions respectively, it is Our further will and pleasure, that the Governors or Deputy-Governors of the said possessions respectively, who shall be authorised to issue passes, shall issue them only in the form marked C, as recommended to us by Our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland in their memorial as aforesaid, and that the said Governors or Deputy Governors shall issue them only to such ships as shall be certified (in such manner as We shall be pleased by any Order or Orders in Council to direct), to belong to Our subjects, and to the possessions under their respective Governments, except that when any ship having a pass issued in the United Kingdom, or in any of His Majesty's Colonies, the time of which pass shall have expired, and which by these regulations ought to be returned, or where the owner or master of a ship having a British certificate of registry shall be desirous of obtaining a Mediterranean pass; the Governors or Deputy Governors as aforesaid may grant for such ship a pass of the form aforesaid marked C. to be in force to the end of the ships then voyage, and no longer, and to be returned to be cancelled at the end of such voyage as hereinbefore directed in other cases respectively; and the said Governors or Deputy Governors shall sign their names in the margin of all passes issued by them respectively as specified in the said form; and in all cases the Governors or Deputy Governors issuing such passes shall take a bond (as above directed), for the delivery up of such pass on the first ensuing arrival of such ship in any port of the United Kingdom, or of a British possession, of which the Governor or Deputy Governor may be authorised to issue passes.

It is Our rurther will and pleasure, that for the more convenient issue of such passes, Our Com-missioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, or Our High Admiral of Our United, Kingdom of Great Britain and Ireland for the time being, shall be authorised to furnish to the Commissioners of Our Customs in London, Edinburgh, and Dublin, and to the Governors of Our Colonies, and of Gibraltar and Malta, passes of the necessary forms signed and executed by Our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, or Our High Admiral of Our United Kingdom of Great Britain and Ireland for the time being, in blank as to the names of the ship, which passes the Commissioners of Our Customs as aforesaid or their Officers; and the said Governors shall be authorised to fill up and issue on the receipt of the bond required to be taken for the same.

And it is Our further will and pleasure, that it shall be lawful for Our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, or Our

are hereby empowered to lodge Mediterraneau passes of the same form with the new passes for ships and vessels belonging to Gibraltar and Malta, in the hands of Our Lord High Commissioner of the Ionian Islands, and to empower our said Lord High Commissioner of the Ionian Islands to issue and deliver out such passes to any of the inhabitants of the said Islands, to be applied to ships actually belonging to the said Islands, and none other, provided the person or persons applying for the same do comply with and conform to the several rules and regulations now in use, or that may be required to be observed by Our subjects, or that may be directed to be observed by the said inhabitants of the Ionian Islands by Our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, or Our High Admiral of Our United Kingdom of Great Britain and Ireland for the time being.

And We do hereby order, that the Commissioners of Our Customs in Great Britain and Ireland do cause to be carried into execution such parts of the said Order of Council, of the fourteenth day of June one thousand seven hundred and tweety-two, concerning passes as relate to themselves, and the proper Officers under them, so far as the same remains now in force, and of Our Orders aforesaid made in Council on the twenty-eighth day of August one thousand seven hundred and seventy-six, on the thirty-first day of December one thousand seven hundred and eighty-three, and the third day of November one thousand eight bundred and two. or Our Order in Council of this day's flate, that they do direct their Officers in the several parts of Our United Kingdom of Great Britain and Ireland to demand of the masters of all morchant ships, so soon as they shall return into port from a foreign voyage, all passes granted as aforesaid which shall be in their possession to be produced to the said respective Officers of Our Customs; and if the same shall appear to be of an older date than the periods herein before severally and respectively mentioned for the return of the passes of the present form, then such passes shall be delivered up to the said respective Officers of Our Customs, and be by them returned to the Office of the Admiralty of Great Britain. And in case the master of any such ship or vessel shall refuse to produce or deliver up such passes according to the true intent of Our said Order, then the said Officer shall certify the name of every such master, and of the ship or vessel, to Our Commissioners for executing the office of Lord High Admiral of Our United Kingdom of Great Britain and Ireland, or to Our High Admiral of Qur United Kingdom of Great Britaid and Ireland for the time being, to the end that directions may be given for putting the bond entered into on the granting any such pass, in suit. HEREAS other time, limited by the Orders of His Royal Highness the Prince Regent in Council of the twenty-eighth May and the twelfth July last, for prohibiting the exportation of gunpowder, arms, or ammunition, to the places therein specified, willyexpire on the thirtieth day of this instant November, hand, whereas, it is, expedient, that, the said prohibition should be continued for some time longery. His Royal Highness the Prince, Regent, in the name and on the behalf of His Majesty, and by and with the advice of His Majestyla Privy Council; doth hereby orden, gequire, prohibit; and command, that no person or persons whatsoever (except in the Master-General, of the Ordnance for His Majesty's service) do at any time during the space of six months (to commence from the !thirtieth.day of this instant; November), presume to transport any gunpowder or salt-petre, or many wort of arms or hammunition, to any port or place within the dominions of the King of Spain, or to any port or place on the Coast of Africa, or in the West Indies, couldn any part of the Continent of America (except to acport or place, or ports or places in His Majesty's territories or possessions on the Continent of North America, or in the territories of the Upited States of America), or ship or lade any gunpowder or asalt-petre, or any sort of arms or ammunition; on board any ship or vessel, in order to transporting the same into any such ports or places within the dominions of the King of Spain, or into any such ports or places on the Coast of Africa; or in the West Indies, or on the Continent of America' (except as above excepted), without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of His late Majesty's reign, intituled "An Act to empower " His Majesty to prohibit the exportation of salt-" petre, and to enforce the law for empowering " His Majesty to prohibit the exportation of gun-" powder, or any sort of arms or ammunition, and also to empower His Majesty to restrain "the carrying coastwise of salt-petre, gunpowder, " or any sort of arms or ammunition;" and also by an Act, passed in the thirty-third year of His Majesty's reign, cap. 2, intituled "An Act to " enable His Majesty to restrain the exportation

the exportation of salt-petre, arms, and ammu-nition, when prohibited by Proclamation or " Order in Council:"

And the Right Honourable the Lords Com-missioners of His Majesty's Treasury, the Com-missioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may Chetwynd. respectively appertain.

THE following Addresses, having been transmitted to Viscount Sidmouth, one of His Majesty's Principal Secretaries of State, by the several persons whose names are respectively subjoined to each Address, have been presented by His Lordship to His Royal Highness the Prince Regent, who was pleased to receive the same very graciously:

To His Royal Highness George Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland, &c. &c. &c.

The humble, dutiful and loyal Address of the Mayor, Aldermen, and Capital Burgesses of the Borough of Harwich, in the County of Essex, and other Inhabitants of the same Borough.

When provoked by the tumultuary and dangerous meetings of malicious, or misguided men, so large a portion of the subjects of our beloved and venerable Sovereign are zealously expressing their unshaken attachment to their Constitutional Laws, we, the Mayor, Aldermen, Capital Burgesses and other loyal Inhabitants of the Borough and Town of Harwich, intreat permission of your Royal Highness, to be graciously reckoned among those, who are most sensibly grateful for the blessing of that excellent Government they enjoy, and who are determined with their lives and fortunes to make every loyal exertion necessary for its lasting preservation and support.

Placed, as we are, at the extremity of a peaceable maritime and agricultural County, we learn only by public report the existence of those meetings, that seditious spirits have organized to disturb the

public peace.

Happily, as yet, we have had in this loyal and tranquil town, no itinerant orators, moving revolutionary resolutions, and operating upon poverty and distress to produce discontent and disaffection to the State.

We have however, though not immediately exposed to the contagion, perceived its pernicious effects upon other less fortunate parts of this Kingdom, with indignation and abhorrence. Nor have we failed to observe the intimate sympathy between those mischievous men that incessantly labour to disturb our mild and paternal Government, and those who impiously attempt to destroy our Christian Faith; and are forcibly warned against all the deceitful delusions of the seditious Reformer, when

we behold him counselling and abetting the cause of the Infidel.

Whatever important questions may arise between the legal protectors of the public peace, and its dangerous disturbers, we can with the most perfect confidence leave to the just decision of our established tribunals; and we as confidently trust, that under the guidance and protection of the Almighty Disposer of all events, who has so triumphantly conducted us through all the dangers and difficulties of a most perilous war, our Constitutional Parliament, now so wisely assembled by your Royal Highness, in the name and on the behalf of His Majesty, at this eventful period, will adopt such prompt and salutary measures, as, with the assent of your Royal Highness,-whilst they preserve to a free and loyal people, the sacred right of petition lawfully exercised,-will effectually prevent all those menacing meetings, which, under the mask of pretended petitions, give publicity to the most revolutionary principles, and strike at the root of all that affords life and vigour to the wealth, virtue, and happiness of our native land.

To His Royal Highness, the Prince of Wales, REGENT of the United Kingdom.

May it please your Royal Highness,

WE, His Majesty's most dutiful subjects, the Nobility, Magistrates, Gentry, Clergy and Freeholders of the County of Cumberland, contem-plating with deep anxiety the situation of the Country, feel it our duty thus humbly to tender to your Royal Highness, together with every sentiment of respectful affection towards his Majesty and your Royal Highness, the assurance of our constant and zealous devotion to the Constitution in Church and State, as by law happily established within these Realms. Superfluous as such an assurance might be justly deemed, under ordinary circumstances, we trust it will not appear unbe-coming at a period marked by efforts openly employed with an activity, a perseverance and a boldness unknown but in the worst times of our history; to mislead to the ruin of themselves and their Country, a great portion of his Majesty's Subjects, and under the specious pretence of reform, and the restoration of the constitution, to inculcate principles of the most dangerous innovation, tending only to its inevitable subversion, while the treasonable intention of insuring by force the effect and success of these principles, is hardly disguised. - Unworthy indeed should we be of the name of Englishmen, unworthy the eminent blessings we enjoy, if, at such a moment, we did not avow and proclaim at every hazard our determination to defend and preserve the sacred Institutions from which they are all derived.

The public distress first artfully turned to excite popular passion, since kept up and exasperated in assemblages of the people, frequent and numerous almost beyond example, the character of those

the circumstances peculiarly distinguishing them and the doctrines promulgated and insisted upon, the audacious abuse of the liberty of the press, flagitiously perverted to root from the minds of Englishmen every sentiment of respect for the laws, of reverence for religion, of duty to the Sovereign, and of allegiance to the State, can leave to no unprejudiced man a doubt of the ultimate purpose to which the machinations of disaffection are systemacically directed, or any other duty to a loyal subject than that of devoting all his powers to render it abortive.

Confiding in the sound reason and uncorrupted hearts of a great majority of our countrymen, we entertain no apprehensions of the result of a contest (come when it may), between the friends and enemies of the Constitution; at the same time we are forced to regret the encouragement and advantage the disaffected cannot fail to derive from the proceedings of some who, we are willing to believe, have far other intentions, which, by their obvious tendency to augment the existing irritation on the public feeling, incalculably aggravate the danger and difficulty of the Country.

While we lament, with a sincerity equal to those who have been loudest in their declamations on the subject, the lives lost at Manchester, and yield to none in the estimation in which we hold as one of the best safeguards of our liberties, the invaluable and undoubted right of petition, we confidently leave it to the regular Tribunals, which we believe fully competent to decide on the merits of transactions which have recently occurred, and to fix on those to whom it justly belongs, the heavy responsibility of having insulted the laws, and invaded the real rights of the people. In doing this, however, we cannot overlook or abstain from reprobating the attempts to mirepresent and exaggerate the circumstances that took place, evidently designed to anticipate the judgment of the case, and to preclude the Magistracy from every chance of justice, by exhibiting them as objects of popular indignation, which, in proportion as they are successful, raust have the effect of suppressing in other instances all zeal in the discharge of the magisterial functions, from which the Country has derived so much advantage, and to which it is indebted for so great a

portion of its internal peace and safety. We beg limibly to express our satisfaction at the determination your Royal Highness has announced of speedily resorting to the advice of your Parlinkment. On your Royal Highness's wisdom, assisted by that advice, and the proceedings emanating therefrom, we place under Providence our firmess hope, and to them we cheerfully commit ourselves and our interests; not doubting that the measures adopted will be the means of guarding and long preserving to us against all the attacks of impiety and treason, the laws, the religion and the estimable blessings of our free and happy Constitution. "

To his Royal Highness the PRINCE REGENT.

May it please your Royal Highness,

WE, the Nobility, Magistrates, Gentry, Clercy and Frecholders of the County of Westmorland, assemblies, the resolutions issuing from them, feel it our peculiar duty, at this period, to offer to your Royal Highness every assurance of loyalty to the Throne and the Laws, for the preservation of the Crown, and attachment to the Constitution of all that is dear to man. this Kingdom

The Government established in our Country has been, under Providence, the source of so much happiness and prosperity, that we cannot but regard with the deepest abhorrence any attempt to weaken ar subvert it.

Reflecting with gratitude that we have been preserved, and that we have been the honoured instruments of resching others from the anarchy and despotism which to long desolated a large portion of the world, we cannot silently behold the nugrafeful and mischievous restlessness of those who would take advantage of the circumstances attendant upon returning peace, to undermine that goodly fabric which weathered the tempest, and still excites the admiration of surrounding states.

We feel for the poor, and for others whom the increase of population and the fluctuations of commerce have involved in difficulties and distress; but we rely on the wisdom and paternal care of the legislature, for the adoption and judicious application of every practicable remedy.

The free expression of opinion, whether through the press or otherwise, is the privilege of a Briton: and far be it from us to desire that it should be restrained, so long as it keeps within the bounds of religion and good order. But we wish not to forget, that if our advantages be great, so is our responsibility. In this matter we have not only the deepest personal interest, but we are intrusted with a sacred deposit to preserve for those who come We would guard as a precious jewel that after us. liberty which has never shone, with a purer lustre than in our favoured country: we deprecate the li-centiousness which is its counterfeit. True freedom is in peril when blasphemy and tunnel are defying the laws of God and man; when the necessary decorum of our courts of justice is pertinaciously violated; when opportunities are eagerly seized or cunningly contrived, to vilify in the eyes of the lower classes all that is respectable in the ranks above them, and to undo every sacred tie by which society is holden together. In the crowded Meet ings to which the unthinking multitude are invited, reform is the pretence, but sedition the object: discussion is professed, but all freedem of speech is put down by groans and clamour; the only thing permitted, is an obsequious listening to the railings and theories of some demagogue or his minions; and ingenuity chiefly displays itself in trying how much mischief may be done without overstepping the line which separates this new kind of audacity from actual treason.

If the loyal and the good have been less conspicuous and obtrusive than those whose conduct we thus deplore, yet they have not been inattentive observers; and their experience is well calculated to convince them that the times require a faithful expression of their principles, and a steady exertion of their influence. Thus may they reclaim many who for a while have been misled by the artifices of the designing, and we trust there will now, as in the best days of our history, be one powerful union, under the blessing of the Almighty, round the Altar,

WE, the Inhabitants of the Town and Neighbourhood of Blackburn, in the County of Lancaster, beg leave to approach your Royal Highness with sentiments of unfeigned regret, for the unhappy and groundless Disturbances which now prevail in this part of the kingdom.

We behold with indignation the delusions which have prevailed on the minds of great multitudes among the lower orders of our Countrymen, by which their better natures have been wholly perverted and misled, through the instrumentality of artful and wicked men, from the duty which they owe to God, the King, and the Laws of the Land.

We regret that a licentious and profligate press, the principal cause of these alarming evils, has so long been permitted, almost with impunity, to disseminate political and religious poisons at once so quick in their operation, and so permanent and abiding in their effects, upon the moral and religious Constitution of those who have unhappily imbibed them. We do most sincerely and deeply lament the temporary stagnation, which, from causes wholly unconnected with the representation of the country in the Commons House of Parliament, has confessedly taken place in the Trade and Manufactures of this country, but we believe and know the distresses which that stagnation has occasioned, to be greatly and mischieviously exaggerated, for the purpose of exciting sedition, while we acknow-ledge with gratitude to Providence, that these evils have been, in a great degree, counteracted by a most plentiful harvest, and by an unusual cheapness

and abundance of all the necessaries of life.

In the operation of those diabolical principles, by which the present discontents, with all their dreaded consequences, have been occasioned, we clearly discern the spirit of revived jacobinism, a principle which by the united operation of irreligion and rebellion, tends to dissolve all the rela-tions of civilized life, to the extinction of all the feelings of social order, to the decomposition of all the ties of humanity, and in its progress would de-grade, as it has once already degraded, the best informed, and most highly refined portion of the human race, into bands of ruffians and savages. What then must be its effects, when united, as at present, with every mode of inflammatory exag-In the mean time, that He, by whom Kings reign geration and falsehood, on natures undisciplined and Princes decree judgment, will support your and ferocious, on the half-instructed, half-reasonand mechanics, confessedly suffering, to a certain extent, under privations and disappointments.

These are the evils which we dread, as hastily advancing on this once happy country, but, with all which we feel, and all which we apprehend, we are fully aware, that it is not for us to prescribe remedies even for evils, in the operation of which, ourselves are so deeply involved; nevertheless we do presume, with the most profound respect for every branch of the legislature, to implore, as they value the interests, the virtue, or the happiness of this or of succeeding generations, that the measures and enactments, by which they purpose to counteract principles and practices so destructive, may be directed by promptitude and vigour, that extinct statutes, were obviously needful, may be reenacted, that existing ones may be revised and adapted to exigences, and that powers may be conferred on those who are entrusted to execute the laws adequate to the novel evils which they have to encounter, and to the difficult and arduous duties which they have to discharge.

For ourselves, we frankly declare, that in co-operating with every legal exertion of authority to this effect, we will shrink from no perils, we will decline no expence, if, by so doing, ourselves, our country, and our posterity, can be protected from the mischief and desolation threatened by an illiterate and audacious rabble, on the point of employing a formidable, though ill directed force, to overturn all that we have been taught to hold dear, all that we have been wont to respect as venerable; a rabble composed at once of the meanest and most mischievous elements, of all that is either cowardly or cruel, fraudulent or rapacious in an overcharged and corrupted population.

With the best opportunities of information from actual residence in a district, so circumstanced, these are our sentiments-on this alarming subject, qualified, however, to a very considerable extent, by a full assurance, that in these districts, numbers alone (armed numbers indeed) are formidable, but that with a very few exceptions, all the powerful weight of property, all the generous feelings of rank, education and profession, are zealously devoted to the support of our existing Constitution, in Church and State.
