THE following Addresses, having been transmitted to Viscount Sidmouth, one of His Majesty's Principal Secretaries of State, by the several persons whose names are respectively subjoined to each Address, were presented by His Lordship to His Majesty, who was pleased to reeeive the same very graciously:

To the KING's Most Excellent Majesty.

May it please your Majesty,

WE, your Majesty's subjects, residing in the Hundreds of Blackheath and Little and Lessness, in which are included the several Towns and Parishes which are included the several Towns and Parisino of Greenwich, Deptford, and Woolwich, and of Lewisham, Lee, Eltham, Charlton, Plumstead, Crayforth, Erith, and East Wickham, in the County of Kent, humbly approach your Majesty's Throne with sentiments of firm and unfeigned attachment to your Majesty's Royal Person and Go-vernment; grateful for the invaluable blessings which we enjoy, under the protection of our free and admirable Constitution, rejoicing in the mild and equitable administration of those laws by which this country is pre-eminently distinguished, we cannot contemplate without indignation and abhorrence that seditious and blasphemous spirit, which, under the delusive pretext of Parliamentary Reform, and liberality in religious sentiment, stimulated likewise by a corrupt and licentious press, is meditatiag the annihilation of whatever is valuable to man, as a political, moral, and religious being.

Notwithstanding, however, the shameless acts which are practised to delude and inflame the ignorant; notwithstanding the tumultuous and seditious clamours of factious and designing men, we are firmly persuaded that the intelligent and virtuous of our fellow-countrymen, on whose fidelity must ultimately rest the stability of the British empire, are zealously devoted to your Majesty, and will ardently unite in the hour of danger to protect the Constitution of their country.

Animated with this conviction, and stimulated by a sense both of duty and of interest, we solemnly pledge ourselves, as far as our exertions may avail,

that neither shall the traitor with impunity assail the Throne, nor the infidel insult the Altar.

That your Majesty may long reign over a free, loyal, and united people, and that the British Constitution may continue to triumph over every toreign and domestic enemy, is the fervent wish of the undersigned, your Majesty's dutiful and loyal subjects.

WE, your Majesty's most dutiful and loyal subjects, the undersigned Inhabitants of the ancient Town and Parish of Barking, in the County of Essex, beg leave at this important crisis to approach your Majesty with the assurance of our inviolable fidelity to your Majesty's sacred Person, and of our unalterable attachment to the Constitution of the country as by law established.

Sire, to express the fullest confidence, that, in adopting every necessary measure for the protection of the dignity and the constitutional prerogatives of the Throne, your Majesty's paternal solicitude will be extended to the preservation of those rights and privileges which we inherit from our forefathers, and which we are anxious to transmit unimpaired to our posterity.

Whilst we unite with our loyal fellow countrymen in wishing your Majesty a long and prosperous reign, we carnestly implore the Divine Disposer of events, that the delusion under which a portion of your Majesty's subjects have been led away from their duty to their God, and their allegiance to their Sovereign, may be quickly dispelled, and that they may be deeply impressed with a conviction, that the prosperity of the country and their own personal happiness are essentially dependant on the observance of that precept of our holy religion, "fear God and honour the King."

The determination of that august tribunal has been exultingly hailed by the factious as a triumph, not depending upon the innocence of the party accused, but achieved by external interference; and the judges who dared to pronounce an opinion unbiassed by popular clamour, have been stigmatised with every degrading epithet which malignity could bestow. While these proceedings were pending, we felt it due to the impartial administration of justice to abstain from any public declaration or even animadversion upon the shameless conduct of the self-sfiled friends of that high individual. But now that the enquiry is concluded, we hasten to unite with the loyal and patriotic of the nation, to protest against such interference with our revered tribunals, such appalling violations of the eternal principles of justice; and we lament that prostitution of the freedom of the press, which taking advantage of the credulity of ignorance, has with such malignant industry circulated the most gross delusions. Such a state of things involving the most essential interests of mankind, imperiously requires before the poison has sank to deep into the vitals of the state, that a wholesome vigour of the law should be applied with intrepid firmness, to bring it back to utility and decorum.

We beg most confidently to assert, that notwithstanding the many atrocious misrepresentations with which we have to contend; notwithstanding the deafening clamour of infidel liberality and seditious anarchy, that in this land, comfort is more universally diffused, and the laws more impartially administered than in any other within the record of history; that the benevolence of the rich attends to every want; that property is protected, and that freedom, both civil and religions, is secured upon the firmest basis. And we are firmly resolved, with God's assistance, to use our best endeavours by obedience to our laws, and by devotion to our holy, religion, to preserve these blessings, and to transmit them unimpaired to our posterity.

We pray God to grant to your Majesty's councils a continuance of that wisdom and firmness, by which this nation has triumphed over a world in arms; and that amidst the arts of peace, your Majesty may long uphold your Throne in righteousness, and in the love, confidence, and prosperity of a free and loyal people.
