To the KING's Most Excellent Majesty, ,
Most Gracious Sovereign,

WE, your Majesty's most loyal and dutiful subjects, the Master, Wardens and Brethren of the Corporation of Cooks and Vintners of the City of Dublin, presume to approach the Throne with a declaration of unfeigned devotion to your Majesty's Person, and to the happy form of Government under which this empire has attained its present towering height of prosperity and glory.

In ordinary times, we should deem it, if not insulting, at least unnecessary to call upon any of the Corporations of a City so famed for loyalty as Dublin, to come forward and testify their allegiance. But at a crisis when revolutionary and blasphemous doctrines are circulated with restless activity amongst our fellow-subjects of Great Britain, by a disaffected and desperate faction, intent upon sapping all our civil and religious institutions, and leaving even the Monarchy but a name, we feel it an imperative duty to rally round the Altar and the Throne to proclaim our abhorrence of those agitating perturbed spirits, to declare our firm determination to stem the progress of infidelity and treason, and to renew our assurances of inflexible attachment to our mild and beneficent Sovereign, and to our inimitable Constitution, the happy source of our well tempered liberty and the admiration of the civilized world.

We beg to assure your Majesty that such pestilential doctrines have but few advocates in Ireland, and that in approaching the pure and untainted shores of our island, they lose their virulent quality, and innoxiously expire.

With the characteristic zeal and loyalty of our country, we unite with every well affected subject in fervently praying that our beloved King, rising above the malignant machinations of infidels and revolutionists, and emulating the magnanimity and numerous virtues of his excellent Father, may long

continue to reign in the hearts of a prosperous, free, and contented people.

WE, the undersigned Nobility, Gentry, Clergy, and Freeholders of the County of Kent, beg to approach your Majesty's Throne with the homage of affection to your Majesty's Person and Government, which has alway shewn pre-eminent in the bosoms of men of Kent.

Attached as well by duty as principle to a Constitution founded on religion and loyalty, a Constitution which has flourished for ages the pride of our own and the imitation of other countries, we have lived to see open blasphemy attempt to sap the foundations of the one, whilst efforts have been made to bring contempt upon the other, by a press licentious beyond example.

But, Sire; God for our guide, the machinations of evil men then shall not prevail. We will not exchange the wholesome Laws and Constitution of England, cemented by the blood of our forefathers, formed in wisdom, and perfected by the experience of ages, for the wild chimeras, and visionary projects of political speculators, desperate alike in fortune, in character, and reputation.

The specious pretexts and dangerous talents of such men may for a time mislead the multitude, but the loyalty, the patriotism, the good sense of Englishmen will ultimately prevail, and destroy the ambitious hopes of those whose only aim is the elevation of themselves, even upon the ruins of the Altar and the Throne.

Most Gracious Sovereign,

WE, the undersigned, your Majesty's loyal and dutiful subjects of Ketterington, in the County of Northampton, beg leave to approach your Majesty on this day, the anniversary of your Majesty's accession to the Throne, with the expressions of our zealous attachment to your Majesty's sacred Person, and veneration for the Constitution of these realms.

We feel it to be our imperious duty in times like the present, to make a manly and open avowal of these principles, when strenuous efforts are daily made to spread sedition and disaffection through the land. We witness with perfect abhorrence, endeavours to disparage the truth of our holy religion, and our concern is greatly increased, when we perceive this is attempted by the abuse of that which constitutes a part of our national glory: the unexampled licentiousness of the press we must consider as one prolific source of the blasphemy and insubordination (principles uniformly found to have a close and near alliance), which we are fearful have been for some years regularly and rapidly increasing.

These we consider the sources of real danger, but it is with profound affliction we see also the successful attempts of evil-minded men, who, taking advantage of the delusions they despise, and of the vices which they reprobate, seduce the lower classes of the community from their allegiance, by reviling and misrepresenting the measures of your Majesty's paternal Government, under whose happy auspices this country has been conducted through a period the most perilous to its present high pre-eminence among the nations of Europe.

At this important crisis then, as loyal and dutiful subjects, we respectfully approach your Majesty to express our unalterable resolve to support the

Throne and Constitution of this country, and to oppose that torrent of infidelity and sedition which threatens to deluge our land, and we are led to make this pledge (in defiance of all clamour, and unappalled by violence), from a conviction that we are called upon now more especially so to act, in strict compliance with that injunction which commands us to "fear God and to honour the King."

A PROCLAMATION.

GEORGE, R.

WHEREAS His Royal Highness the Prince Regent, in the name and on the behalf of His late Majesty King George the Third, was pleased, by His Royal Proclamation, bearing date the twentieth day of November one thousand eight hundred and nineteen, to declare His Royal will and pleasure, that the Governors or Deputy Governors of Gibraltar and Malta should be authorised to issue Mediterranean Passes for the protection of ships belonging to His said late Majesty's subjects in those possessions, according to a certain form therein referred to, marked (C), under and subject to certain regulations and sureties therein set forth; and whereas doubts have arisen as to the term during which it was intended that the said Passes should remain in force; We taking the premises into Our Royal consideration, and judging it necessary to remove such doubts, have thought fit, by and with the advice of Our Privy Council, to publish this Our Royal Proclamation, and We do hereby declare, that the Passes to be issued by Our Governors or Deputy Governors of Our said possessions of Gibraltar and Malta for the protection of ships or vessels belonging to Our subjects in Our said possessions, according to the form (C), and under the conditions set forth in the before-mentioned Proclamation of the twentieth of November one thousand eight hundred and nineteen, shall be and continue in force for one year from the day on which the same shall respectively be issued, and no longer; and that at the expiration of that term, the said Passes shall be delivered up to the said Governors or Deputy Governors for the purpose of being cancelled, as required by the said Proclamation of the twentieth of November one thousand eight hundred and nineteen.

GOD save the KING.

AT the Court at *Carlton-House*, the 22d of November 1820,

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the time limited by His Majesty's Order in Council of the twenty-ninth of May last, for prohibiting the exportation of gun-powder, arms, or ammunition, to the places therein specified, will expire on the thirtieth day of this instant November; and whereas it is expedient, that the said prohibition should be continued for some time longer; His Majesty, by and with the advice of His Privy Council, doth hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to commence from the thirtieth day of this instant November), presume to transport any gun-powder or salt-petre, or any sort of arms or ammunition, to any port or place within the dominions of the King of Spain, or to any port or place on the Coast of Africa, or in the West Indies, or on any part of the Continent of America (except to a port or place, or ports or places in His Majesty's territories or possessions on the Continent of North America, or in the territories of the United States of America), or ship or lade any gun-powder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places within the dominions of the King of Spain, or into any such ports or places on the Coast of Africa, or in the West Indies, or on the Continent of America (except as above excepted), without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of the reign of His Majesty King George the Second, intituled "An Act to empower His Majesty to prohibit the exportation of gun-powder, or any sort of arms or ammunition, and also to empower His Majesty to restrain the carrying coastwise of salt-petre, gun-powder, or any sort of arms or ammunition;" and also by an Act, passed in the thirty-third year of His late Majesty's reign, cap. 2, intituled "An Act to enable His Majesty to restrain the exportation of naval stores, and more effectually to prevent the exportation of salt-petre, arms, and ammunition, when prohibited by Proclamation or Order in Council:"

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of

the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain. *Chetwynd.*

AT the Court at *Carlton-House*, the 12th of July 1820,

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the first year of the reign of His present Majesty, intituled "An Act to continue until the fifth day of July one thousand eight hundred and twenty-five, an Act of the fifty-seventh year of His late Majesty, for regulating the trade and commerce to and from the Cape of Good Hope, and for regulating the trade of the Island of Mauritius;" His Majesty is authorised, by and with the advice of His Privy Council, by any Order or Orders to be issued from time to time, to give such directions, and to make such regulations touching the trade and commerce to and from all islands, colonies, or places, and the territories and dependencies thereof, to His Majesty belonging, or in His possession, in Africa, or Asia to the eastward of the Cape of Good Hope (excepting only the possessions of the East India Company), as to His Majesty in Council, shall appear most expedient and salutary, any thing contained in an Act, passed in the twelfth year of the reign of His Majesty King Charles the Second, intituled "An Act for the encouraging and increasing of shipping and navigation," or in an Act, passed in the seventh and eighth years of the reign of His Majesty King William the Third, intituled "An Act for preventing frauds, and regulating abuses in the plantation trade," or any other Act or Acts of Parliament now in force, relating to His Majesty's colonies and plantations, or any other Act or Acts of Parliament, law, usage or custom to the contrary in any wise notwithstanding; and whereas by virtue of the powers granted by the above recited Act of the fifty-seventh year of His late Majesty, an Order in Council was passed on the twenty-eighth of May one thousand eight hundred and nineteen, for regulating the trade of the Island of Mauritius, with states in amity with His Majesty, on the conditions therein set forth; His Majesty is pleased to direct that the said Order be and the same is hereby revoked; and His Majesty is further pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that from and after the date of this present Order, British vessels arriving at any port of the Island of Mauritius, or its dependencies, from any country in amity with His Majesty, laden with any articles of the growth, production, or manufacture of such country (excepting all articles composed of cotton, iron, steel, or wool of foreign manufacture), shall be permitted to enter and land their cargoes, and dispose of the same in the said ports, subject to such duties as may be there payable thereon:

And it is further ordered, that British vessels arriving as aforesaid, shall be permitted to export to any such foreign country in amity with His Majesty, cargoes consisting of any articles of the growth, production, or manufacture of the Island of Mauritius, or its dependencies, or of any other articles which shall have been legally imported there, on payment of such duties as may be payable thereon:

And it is hereby further ordered, that vessels belonging to the subjects of any foreign state in amity with His Majesty, which foreign state shall allow British vessels to carry on trade as aforesaid between the ports of such state and the Island of Mauritius, shall be permitted in like manner to import into the ports of the Island of Mauritius, or its dependencies, from any port of the state to which such vessel shall belong, any articles of the growth, production, or manufacture of such foreign state (excepting all articles composed of cotton, iron, steel, or wool of foreign manufacture), and to dispose of the same in the ports of the said Island and its dependencies, on payment of the same duties as shall be payable on the like articles when imported from such foreign state in British vessels: provided, however, that if higher duties are charged on the export of such goods from any such foreign state, to the Island of Mauritius in British vessels, than are charged on the export of similar articles to the said Island in ships of such foreign state, a countervailing duty of equal amount shall be charged on the said articles when imported into the Island of Mauritius, or its dependencies, in vessels of such foreign state, over and above the duties payable on the like articles when imported from such state in British vessels:

And it is hereby further ordered, that every such foreign vessel shall be permitted to export a cargo consisting of any articles of the growth, production or manufacture of the Island of Mauritius, or its dependencies, or of any other articles which shall have been legally imported there, on payment of a duty of eight per cent. ad valorem, over and above the duties charged on the like goods when exported from the Island of Mauritius, or its dependencies, to such foreign state in a British vessel; provided, however, that in cases where satisfactory proof shall be given that the said articles, when imported into such foreign state from the Island of Mauritius in British vessels, are charged with no higher duties than are charged on the like articles when imported in vessels of such foreign state; and that such articles when imported in British vessels are entitled to the same privileges and advantages with respect to warehousing and internal consumption or otherwise, as when imported in vessels of such state, then and in such case no higher duties shall be charged on the export of such articles from the Island of Mauritius, or its dependencies, in vessels of such foreign state, than shall be charged on the export of the like articles in British vessels to such foreign state:

It is, however, hereby further ordered and declared, that no foreign vessel, allowed by the terms of this Order to export a cargo from the Island of Mauritius, or its dependencies, shall be permitted to export such cargo to any of His Ma-

jesty's possessions, or to any other place than a port or place belonging to the state or power to which the vessel itself shall belong.

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary directions herein as to them may respectively appertain. *Chetwynd.*
