THE following Addresses, having been transmitted to Viscount Sidmouth, one of His Majesty's Principal Secretaries of State, by the several persons whose names are respectively subjoined to each Address, were presented by His Lordship to His Majesty, who was pleased to receive the same very graciously:

To the KING's Most Excellent Majesty.

WE, your Majesty's dutiful and faithful subjects, the Rector, Churchwardens, Vestrymen, and other Inhabitants of the Parish of Saint George, Hanover-Square, in the County of Middlesex, under a deep conviction that the present conjuncture calls imperiously upon every loyal man publicly to declare his principles and sentiments, beg leave to renew, in the most explicit terms, the assurance of our uushaken attachment to your Majesty's sacred Person, and to your illustrious House; and at the same time our fixed resolution to maintain, to the utmost of our power, the many blessings we enjoy under our excellent form of Government, and your Majesty's mild and paternal sway.

It has been the inestimable privilege of this kingdom to possess, during a long series of years, the purest religion, and a system of civil policy founded on laws established in wisdom and justice, and sanctioned by the experience of their protection and equity. These are benefits which we have enjoyed in a greater degree than any other nation, and by which we have lived a free and happy people. It is not therefore without the utmost indignation and disgust that we have witnessed the attempts which have been made, and are still making, to spread discontent and disaffection through the lower ranks of the community, to unfix and loosen every principle of subordination and order, to cradicate all respect for rank and station, and, as the surest means of effecting these purposes, to excite, by the most licentious publications, an open and contemptuous disregard of all moral restraint, and all religious obligation; in a wordy to deliver us up to all the horrors of a wild revolution.

In conjunction therefore with a large proportion

of your Majesty's subjects, we feel it to be our duty to make, at the present crisis, this avowal of our sentiments, and to assure your Majesty that, so far as depends upon us, our most strenuous exertions shall not be wanting to uphold the dignity of the Throne, to preserve inviolate our incomparable Constitution, and to promote, in every way, the peace, the security, and the credit of the British empire.

To the KING's Most Excellent Majesty.

A loyal Declaration of the Inhabitant Householders of the Parish of St. Mary, Rotherhithe, Surrey.

WE should have deemed it sufficient to yield due allegiance to our Sovereign the King, and submission to the laws of our country, had not the perilous and obtrusive spirit of sedition demanded of every true friend to the State a public and fearless avowal of his attachments. Nor are we deterred from this disclosure by the clamours or even menaces of those who, loud and zealous in asserting their own right and ground of complaint, scruple not to calumniate the motives of others more loyal than themselves.

Ever anxious to uphold the popular part of a Constitution, the glory of England and the envy of Europe, we cannot at the same time witness, without disgust and reprobation, the attempts that are daily made, by active and shameless demagogues and by a licentious and sophistical press, to poison and alienate the minds of the lower classes of the community, by inculcating contempt for the person of the Sovereign, and for the constituted Authorities and Laws of the land; we behold with increased abhorrence these doctrines of anarchy and rehellion, accompanied and abetted by derision and hlasphemy of our Holy Religion, and contumely and hostility towards its Ministers.

Against these portentous designs of treason and infidelity as Christians and as Englishmen we protest. We augur nothing from the triumph of such factions (however plausible their pretences may be) but the downfal of morality, liberty and social order, and with them the ruin of our country.

Timely therefore to avert such evils, we think ourselves imperatively summoned to declare our firm and united determination to support both Church and State to the utmost of our power, and as far as we are able to deliver down inviolate to posterity that mild and equitable form of Government under which we have lived in happiness and freedom, fearing God and honouring the King.

Impressed with those feelings, and with the strongest conviction that the true interests of the people and the Crown are inseparable, we claim your Majesty's utmost confidence when we beg your gracious acceptance of an assurance that we shall ever be ready to rally round the Constitution formed by our ancestors, under which, by the blessings of Divine Providence, we have long enjoyed that civil and religious liberty which has been the pride of this country and the admiration of surrounding nations.

To maintain this Constitution against any factious and unprincipled innovation, and to transmit it unimpaired to posterity, is our firm determination, and that your Majesty may have a happy and glorious reign over a free and loyal people is our ardent prayer.

The humble and dutiful Address of the Mayor, Aldermen, Common Council Men, Bailiffs, Burgesses and other Inhabitants of the Borough of Pembroke.

WE, the Mayor, Aldermen, Common Council Men, Bailiffs, Burgesses and other Inhabitants of the Town and Borough of Pembroke, in the Town. Hall assembled, duly sensible of the necessity of all loyal subjects at the present moment avowing their attachment to the King and Constitution, beg

our unshaken allegiance and respectful regard for your Majesty's most sacred Person and Government, we have contemplated with concern and indignation the many and infamous artifices practised by the disloyal and disaffected to mislead the most numerous order of society, and to pervert their judgment from a due estimation of the Royal Character and Functions, and to give it a factious. bias to vilify and degrade the Throue and all constituted Authorities; in the prosecution of their sedition they have attempted, by blasphemy and by a dissolution or rejection of all religious principles, to prepare the minds of the people to dissolve every. bond of established Government. The spirit of turbulence and dissatisfaction which thus actuates the seditious to model new systems of government, to the subversion of that just, temperate and happy Constitution, endeared to us by the sanction of time, of wisdom and experience, impels us to express to your Majesty our sentiments of loyal and faithful veneration for our Sovereign, and that estimable Constitution by which crimes are repressed by law, and the stability of all property, public and private, and personal protection and security, are confirmed and upheld.

Whatever terror may attend the operation of the infatuated measures of the seditious, we trust, under the favouring superintendance of Providence, by a vigorous exposure of their devices, and by a formidable and patriotic opposition to their machina-tions, their delusions will soon gease to misguide any of your Majesty's subjects, or induce them either to treat revelation with contumely, or to attempt innovation in the existing form of Government and Laws,

We cannot therefore but declare our unaltered determination, in our respective situations in society, of supporting the Laws and constituted Authorities of the realm. And we earnestly hope that your Majesty, surrounded by the impregnable barrier of loyalty and affection of your subjects, will long continue to find your Throne secured to you for the enjoyment of your own personal dignity, splendour and happiness, and for the glory and prosperity of your people in every part of your dominions.

WE, your Majesty's faithful subjects, beg leave to approach the Throne at the present period, when we deem it expedient that every man possessing loyal attachment to your august Person, steady adherence to our unrivalled form of Government, and honest patriotic feelings for the welfare of your kingdoms, should boldly profess his sentiments, and by an open declaration of them, proclaim his determination to support and maintain your illustrious House, and the Laws and Constitution of the realm pure and unimpaired.

A PROCLAMATION.

GEORGE, R.

WHEREAS His Royal Highness the Prince Regent, in the name and on the behalf of His late Majesty King George the Third, was pleased, by His Royal Proclamation, bearing date the twentieth day of November one thousand eight hundred and nineteen, to declare His Royal will and pleasure, that the Governors or Deputy Governors of Gibraltar and Malta should be authorised to issue Mediterranean Passes for the protection of ships belonging to His said late Majesty's subjects in those possessions, according to a certain form therein referred to, marked (C), under and subject to certain regulations and sureties therein set forth; and whereas doubts have arisen as to the term during which it was intended that the said Passes should remain in force; We taking the premises into Our Royal consideration, and judging it necessary to remove such doubts, have thought fit, by and with the advice of Our Privy Council, to publish this Our Royal Proclamation, and We do hereby declare, that the Passes to be issued by Our Governors or Deputy Governors of Our said possessions of Gibraltar and Malta for the protection of ships or vessels belonging to Our subjects in Our said possessions, according to the form (C), and under the conditions set forth in the beforementioned Proclamation of the twentieth of November one thousand eight hundred and nineteen, shall be and continue in force for one year from the day on which the same shall respectively be issued, and no louger; and that at the expiration of that term, the said Passes shall be delivered up to the said Governors or Deputy Governors for the purpose of being cancelled, as required by the said Proclamation of the twentieth of November one ; mousand eight hundred and nineteen.

HEREAS the time limited by His Majesty's Order in Council of the twenty-ninth of May last, for prohibiting the exportation of gun-powder, arms, or ammunition, to the places therein specified, will expire on the thirtieth day of this instant November; and whereas it is expedient, that the said prohibition should be continued for some time longer; His Majesty, by and with the advice of His Privy Council, doth hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to commence from the thirtieth day of this instant November), presume to transport any gun-powder or salt-petre, or any sort of arms or animunition, to any port or place within the dominions of the King of Spain, or to any port or place on the Coast of Africa, or in the West Indies, or on any part of the Continent of America (except to a port or place, or ports or places in His Majesty's territories or possessions on the Continent of North America, or in the cerritories of the United States of America), or ship ir lade any gun-powder or salt-petre, or any ort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places within the dominions of the King of Spain, or into any such ports or places on the Coast of Africa, or in the West Indies, or on the Continent of America (except as above excepted), without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of the reign of His Majesty King George the Second, intituled "An Act to empower His " Majesty to prohibit the exportation of gun-" powder, or any sort of arms or ammunition, " and also to empower His Majesty to restrain " the carrying coastwise of salt-petre, gun-powder, or any sort of arms or ammunition;" and also by an Act, passed in the thirty-third year of His late Majesty's reign, cap. 2, intituled "An Act to " enable His Majesty to restrain the exportation " of naval stores; and more effectually to prevent " the exportation of salt-petre, arms, and ammu-" nition, when prohibited by Proclamation or " Order in Council:"
