A PROCLAMATION.

GEORGE, R.

THEREAS Our Parliament stands prorogued to Thursday the third day of January next; We, with the advice of Our Privy Council, do hereby publish and declare, that the said Parliament shall be further prorogued, on the said third day of January next, to Tuesday the fifth day of February next; and We have given order to Our Chancellor of that part of Our United Kingdom called Great Britain, to prepare a commission for proroguing the same accordingly; and We do further hereby, with the advice aforesaid, declare Our Royal Will and Pleasure, that the said Parliament shall, on the said fifth day of February next, be held and sit for the dispatch of divers urgent and important affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly, at Westminster, on the said fifth day of February next.

Given at Our Court at Brighton, the tenth day of December one thousand eight hundred and twenty-one, and in the second year of Our reign.

The KING's Most Excellent Majesty in Council.

IS Majesty in Council was this day pleased to declare Richard Marquess Wellesley, Knight of the Most Noble Order of the Garter, Lieutenant-General and General Governor of that part of the United Kingdom called Ireland.

This day His Grace Charles Duke of Dorset, Henry Marquess Conyngham, and the Right Honourable Henry Goulburn, were, by command of His Majesty, sworn of His Majesty's Most Honourable Privy Council, and took their respective places at the Board accordingly.

To the KING's Most Excellent Majesty.

The humble Address of the Mayor, Aldermen, and Burgesses of the Borough of Reading, in the County of Berks, in Common Hall assembled.

May it please your Majesty,

WE, your Majesty's most dutiful and loyal subjects, the Mayor, Aldermen, and Burgesses of the Borough of Reading, humbly beg leave to present to your Majesty our congratulations upon your accession to the Throne of these kingdoms, as also on your happy return to your native country, after a visit to the more remote parts of your extensive dominions. We have noticed with peculiar gratification, the effusions of loyalty, the strongest marks of attachment to your sacred Person, which have uniformly attended your Majesty's late progress, being ourselves animated with the same sentiments, and feeling with confidence that a similar spirit pervades the great body of your Majesty's subjects.
