HEREAS by an Act, passed in the present session of Parliament, intituled "An Act to regulate the trade between His Majesty's pos-" sessions in America and the West Indies, and " other places in America and the West Indies," it is enacted, that if His Majesty shall deem it expedient to extend the provisions of the said Act to any port or ports not enumerated in the schedule marked A, annexed to the said Act, it shall be lawful for His Majesty, by Order in Council, to extend the provisions of the said Act to such port or ports; His Majesty is thereupon pleased, by and with the advice of His Privy Council, to order, that from and after the passing of this Order, all articles permitted by the said Act to be imported into and exported from the ports enumerated in schedule A annexed to the said Act, shall and may be in like manner imported into and exported from the port of Annotto Bay, in the island of Jamaica, on payment of the duties, and subject to the rules, regulations, penalties, and forfeitures enacted by the said Act: And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly.

#### PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the fifty-sixth year of His late Majesty's reign, cap. 38, intituled "An Act to empower His Majesty to suspend the ballot or enrolment for the local militia," it is enacted, that it shall be lawful for His Majesty, by any Order in Council, to direct that no ballot or enrolment for the local militia shall take place; but that such ballot and enrolment shall remain and continue suspended for the period specified in any such Order of Council, and from time to time, by any like Order or Orders in Council, to continue such suspension so long as His Majesty shall deem the same expedient, any thing in any Act or Acts of Parliament to the contrary notwithstanding: and whereas it is deemed expedient that the ballot and enrolment for the local militia should be suspended for the space of one year; it is, therefore, ordered by His Majesty, by and with the advice of His Privy Council, that no ballot or enrolment for the local militia do take place for the space of one year from and after the date hereof, but that the ballot and enrolment for the local militia be suspended for the space of one year from the date of this Order.

The KING's Most Excellent Majesty in Council.

WHEREAS the time limited by His Majesty's Order in Council of the fourteenth of November last, for prohibiting the exportation of gun-powder, arms, or ammunition, to the places therein specified, will expire on the thirtieth day of this instant May; and whereas it is expedient, that the said prohibition should be continued for some time longer; His Majesty, by and with the advice of His Privy Council, doth hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the whatsoever (except the Master-General of the Ordnance for His Majesty's service) do, at any time during the space of six months (to commence from the thirtieth day of this instant May), presume to transport any gun-powder or salt-petre, or any sort of arms or ammunition, to salt-petre, or place within the dominions of the King of Spain, or to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar), or in the West Indies, or on any part of the Continent of America (except to a port or place, or ports or places in His Majesty's territories or possessions on the Continent of North America, or in the territories of the United States of America), or ship or lade any gun-powder or salt-petre, or any sort of arms or annunition, on board any ship or vessel, in order to transporting the same into any such ports or places within the dominions of the King of Spain, or into any such ports or places on the Coast of Africa (except as above excepted), or in the West Indies, or on the Continent of America (except as above excepted), without leave or permission in that behalf first obtained from His Majesty, or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of the reign of His Majesty King George the Second, intituled An Act to empower His Majesty to prohibit the exportation of gun-" powder, or any sort of arms or ammunition, and also to empower His Majesty to restrain the carrying coastwise of salt-petre, gun-powder, or any sort of arms or ammunition;" and also by an Act, passed in the thirty-third year of His late Majesty's reign, cap. 2; intituled "An Act to " enable His Majesty to restrain the exportation of naval stores, and more effectually to prevent the exportation of salt-petre, arms, and ammuonition, when prohibited by Proclamation or order in Council:"
