A PROCLAMATION.

GEORGE, R.

7 HEREAS William Marquis of Lothian was duly elected and returned to be one of the sixteen Peers of Scotland, to sit in the House of Peers in the present Parliament of the United Kingdom of Great Britain and Ireland, and is since deceased; in order to the electing another Peer of Scotland to sit in his room, We do, by and with the advice of Our Privy Council, issue forth this Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at Holyrood-House, in Edinburgh, on Thursday the eighth day of July next, between the hours of twelve and two in the afternoon, to nominate and choose another Peer of Scotland, to sit and vote in the House of Peers of this present Parliament of the United Kingdom of Great Britain and Ireland, in the room of the said William Marquis of Lothian, deceased, by open election and plurality of voices of the Peers that shall then be present, and of the proxies of such as shall be absent (such proxies being Peers, and producing a mandate in writing, duly signed before witnesses, and both constituent and proxy being qualified according to law), and the Lord Clerk Register, or such two of the Principal Clerks of the Session as shall be appointed by him to officiate in his name, are hereby respectively required to attend such meeting, and to administer the oaths required by

law to be taken there by the said Peers, and to take their votes; and immediately after such election made and duly examined, to certify the name of the Peer so elected, and sign and attest the same in the presence of the said Peers the electors, and return such certificate into the High Court of Chancery of Great Britain. And We strictly charge and command that this Proclamation be duly published at the Market-Cross at Edinburgh, and in all the county towns in Scotland, twenty-five days, at least, before the time hereby appointed for the meeting of the said Peers to proceed on such election.

HEREAS by an Act, passed in the fourth year of His present Majesty's reign, intituled "An Act to authorise His Majesty, under cer"tain circumstances, to regulate the duties and "drawbacks on goods imported or exported in "foreign vessels, and to exempt certain foreign "vessels from pilotage," His Majesty is authorised, by and with the advice of His Privy Council, or by any Order or Orders in Council, in all cases in which British vessels, of less burthen than sixty tons, are not required by law to take pilots, to exempt foreign vessels, being of less burthen than

sixty tons, from taking on board a pilot to conduct | them into or from any of the ports of the United Kingdom, any law, custom, or usage to the con-trary notwithstanding; His Majesty, by virtue of the power vested in him by the said Act, and by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that from and after the date of this Order, all vessels belonging to the inhabitants of Lubeck, and being of less burthen than sixty tons, which shall enter in or clear out from any of the ports of the United Kingdom, shall be, and they are hereby exempted from taking on board a pilot to conduct them into or from any such port, in all cases where British vessels, being of less burthen than sixty tons, are not required by law to take pilots, any law, custom, or usage to the contrary notwithstanding:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly.

granting relief in certain cases.

An Act to authorise the issuing of Exchequer Bills for the payment of the proprietors of Four Pounds per Centum Annuities in England and Ireland, who have not signified their assents under the Acts passed in this session, for transferring such Annuities into Reduced Annuities of Three Pounds Ten Shillings per Centum.

An Act to permit the mutual transfer of capital, in certain public stock or funds, transferable at the Banks of England and Ireland respectively.

An Act to alter the laws relating to the duties on the importation and the prohibitions on the exportation of wool and of hare and coney skins.

An Act to enable the Commissioners of His Ma-

now standing in their names, and to apply the produce thereof in part payment of a loan of three hundred thousand pounds due to the Royal Exchange Assurance Company, and to facilitate the sales of fee farm rents and of small portions of the land revenue of the Crown, and for other purposes.
