AT the Court at Carlton-House, the 2d of February 1825,

PRESENT.

The KING's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the fourth year of His Majesty's reign, intituled "An "Act to repeal certain duties of Customs in Great " Britain, and to grant other duties in lieu thereof; " to grant certain bounties on salted provisions and silk manufactures exported; and to make more effectual regulations for collecting the duties " of Customs;" and by another Act, passed in the same session of Parliament, intituled "And Act to repeal the several duties and drawbacks of " Customs chargeable and allowable in Ireland, on "the importation and exportation of certain foreign and colonial goods, wares, and mer-" chandise, and to grant other duties and draw-" backs in lieu thereof, equal to the duties and " drawbacks chargeable and allowable thereon in Great Britain;" His Majesty is empowered, by His Order in Council, to be published in the London and Dublin Gazettes, to direct, for the convenience of trade, and for the more economical collection of the revenue, that the management of all import duties should be placed wholly under the Commissioners of Customs, or wholly under the Commissioners of Excise; and whereas it is deemed expedient, that from and after the fifth of April next, the import duties upon the following articles, namely, coffee, cocoa, tobacco and snuff, pepper, spirits, wine, and all other foreign goods now subject upon importation, to duties collected by the Excise, except tea, should be placed wholly under the management of the Commissioners of Customs; His Majesty having taken the same into consideration is pleased, by and with the advice of His Privy Council, to declare and direct that all

such duties upon the articles above enumerated shall be placed, and shall be under the sole management and authority of the Commissioners of His Majesty's Customs, according to the provisions and directions of the said Acts, from and after the fifth day of April next, during the time that the aforesaid duties shall continue to be payable: And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly.

HEREAS by an Act, passed in the fourth year of His present Majesty's reign, intituled " An Act to authorise His Majesty, under certain " circumstances, to regulate the duties and draw-" backs on goods imported or exported in foreign "vessels, and to exempt certain foreign vessels from pilotage," His Majesty is authorised, by and with the advice of His Privy Council, or by His Majesty's Order or Orders in Council, to be published from time to time in the London Gazette, to authorise the importation into or exportation from the United Kingdom, or from any other of His Majesty's dominions, of anyigoods, wares, or merchandise which may be legally imported or exported in foreign vessels, supon payment of such and the like duties only, and with the like drawbacks, bounties, and allowances as are charged or granted upon similar goods, wares, for merchandise when imported or exported in British vessels; provided always, that before any such Order or Orders shall be issued, satisfactory proof shall have been

laid before His Majesty and His Privy Council, that goods, wares, and merchandise imported into or exported from the foreign country in whose tayour such remission of duties, or such drawbacks, bounties, or allowances shall be granted, are charged with the same duties, and are allowed the same drawbacks, bounties, or allowances when imported into or exported from such foreign country in British vessels, as are levied or allowed on similar goods, wares, and merchandise when imported or exported in vessels of such country. And whereas by an Act, passed in the last session of Parliament, intituled "An Act to indemnify all persons concerned in advising, issuing, or acting under a certain Order in Council, for regulating the er tonnage duțies on certain foreign vessels; and to amend an Act of the last session of Parliament, for authorising His Majesty, under certain circumstances, to regulate the duties and drawbacks on goods imported or exported in any foreign vessels," His Majesty is authorised (in certain cases), by and with the advice of His Privy Council, or by His Majesty's Order or Orders in Council, to be published from time to time in the London Gazette, to permit and authorise the entry into any port or ports of the United Kingdom of Great Britain and Ireland, or of any other of His Majesty's dominions, of any foreign vessels, upon payment of such and the like duties of tonnage only as are or may be charged or granted npon or in respect of British vessels: And whereas satisfactory proof has been laid before His Ma-jesty and His Privy Council, that goods, wares, and merchandise imported into or exported from the ports of His Serene Highness the Duke of Oldenburgh, are charged with the same duties, and are allowed the same drawbacks, bounties, or allowances when imported or exported in British vessels as are levied or allowed on similar goods, wares, and merchandise when imported into or exported from the said ports in Oldenburgh vessels; and that British vessels are charged with no other or higher tonnage duties on their entrance into the ports of Oldenburgh, than are levied on Olden-burgh vessels; His Majesty, by virtue of the powers vested in him by the Acts above recited, and by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that, from and after the date of this Order, Oldenburgh vessels entering the ports of the United Kingdom of Great Britain and Ireland, in ballast or laden, direct from any of the ports of Oldenburgh, or departing from the ports of the said United Kingdom, together with the cargoes on board the same, such cargoes consisting of articles which may be legally imported or exported, shall not be subject to any other or higher duties or charges whatever than are or shall be levied on British vessels entering or departing from such ports, or on similar articles when imported into or exported from such ports in British vessels; and also that such articles when exported from the said ports in Oldenburgh vessels, shall be entitled to the same bounties, drawbacks, and allowances, that are granted on similar articles when exported in British vessels:

His Majesty is authorised, by and with the advice of His Privy Council. or by any Order or Orders in Council, in all cases in which British vessels, of less burthen than sixty tons, are not required by law to take pilots, to exempt foreign vessels, being of less burthen than sixty tons, from taking on board a pilot to conduct: them into or from any of the ports of the United Kingdom, any law, custom, or usage to the contrary notwithstanding; His Majesty, by virtue of the power vested in him by the said Act, and by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that from and after the date of this Order, all vessels belonging to the inhabitants of Bremen, and being of less burthen than sixty tons, which shall enter in or. clear out from any of the ports of the United-Kingdom, shall be, and they are hereby exempted from taking on board a pilot to conduct them into or from any such port, in all cases where British vessels, being of less burthen than sixty tons, are not required by law to take pilots, any law, custom, or usage to the contrary notwithstanding:

And the Right Honourable the Lord's Commissioners of His Majesty's Treasury are to give the necessary directions berein accordingly.

N pursuance of an Act of Parliament, made and passed in the fourth year of the reign of His present Majesty King George the Fourth, intituled An Act for altering and amending two Acts, passed in the eleventh and thirty-third years of His late Majesty King George the Third, for consolidating, extending, and rendering more effectual the powers granted by several Acts of Parliament for making, enlarging, amending, and cleansing the vaults, drains, and sewers within the city of London, and liberties thereof, and for paving, cleansing, and lighting the streets, lanes, squares, yards, courts, alleys, passages, and places, and preventing and removing observations and annoy-ances within the same," this Court doth hereby appoint the places within the said city of London, and liberties thereof, for carts, wains, or waggons to stand and ply for hire, and doth, in pursuance of the said Act of Parliament, make orders to regulate the number of such carts, wains, or waggons to stand in the aforesaid places respectively, and extends southward from Crosby-square to Thread-

And this Court doth hereby further order and direct, that no cart, wain, or waggon whatever, other than the four hundred and twenty carts, wains, or waggons licenced by the Mayor and Commonalty and Citizens of the said city, or by the Governors of Christ's Hospital, London, under the authority of the said Mayor and Commonalty and Citizens, to be worked for hire within the said city and liberties by the Members of the Fellowship of Carmen of the city of London, shall stand or ply for hire at or upon any of the places or stands hereinbefore appointed by this Court for that purpose, nor in any other part of the said city of London or liberties thereof.

And this Court doth hereby further order and direct, that no cart, wain, or waggon shall stand or ply for hire, or be or remain at any wharf or other place heretofore allowed for the purpose of turn-keeping, or shall be entitled to the preference of employment by reason of such cart, wain, or waggon being the first in point of time or standing upon any of the places or stands hereinbefore appointed by this Court for such places of standing or plying for hire, but that every merchant or other person having occasion to employ any cart, wain, or waggon, notwithstanding any former rule or regulation in respect to turn-keeping or preference of employment by reason of any cart, wain, or waggon being first in point of time or standing upon any such stand, shall be at liberty to hire or employ any other cart, wain, or waggon which may be standing or plying for hire at or upon any of the atoresaid places or stands hereinbefore appointed by this Court.

And this Court doth hereby further order and direct, that no carman or other person shall come

with any cart, wain, or waggon to or upon any of] the places or stands hereinbefore appointed by this Court, before six of the clock in the morning, nor remain, continue, or be upon such stand after nine of the clock in the evening, in the Summer time; or before seven of the clock in the morning, or remain, continue, or be upon such stand after seven of the clock in the evening, in Winter time; the months of November, December, January, and February, being accounted Winter, and all the other months, Summer, for the purposes of this order.

And this Court doth hereby further order and

direct, that no carman or other person shall come with any cart, wain, or waggon to or upon any of the places or stands hereinbefore appointed between the west end of the Custom house and Freshwharf, in Lower Thames-street, before nine of the clock in the morning, at any time of the year.
