A T the Court at Carlton-House, the 28d of March 1825,

PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS the time limited by His Majesty's Order in Council, of the fourteenth of August last, for prohibiting the exportation of gunpowder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar), has expired; and whereas it is judged expedient that the said prohibition should be continued for some time longer, His Majesty, by and with the advice of His Privy Council, doth therefore hereby order, require, prohibit, and command, that no person or persons whatsoever (except the Master-General of the Ordnance for His Majesty's Service), do, at any time during the space of six months (to commence from the date of this Order), presume to transport any gun-powder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of . Africa (except to any ports or places within the Streights of Gibraltar) or ship or lade any gunpowder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places on the Coast of Africa (except as above excepted), without leave or permission in that behalf, first obtained from His Majesty or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of the reign of His Majesty King George the Second, intituled "An Act to empower His Majesty to prohibit the expor-" tution of gun-powder, or any sort of arms or " ammunition, and also to empower His Majesty of to restrain the carrying coastwise of salt-petre,

"gun-powder, or any sort of arms or ammunition;" and also by an Act, passed in the thirtythird year of His late Majesty's reign, cap. 2,
intituled "An Act to enable His Majesty to
restrain the exportation of naval stores, and
more effectually to prevent the exportation of
salt-petre, arms, and ammunition, when prohibited by Proclamation or Order in Council:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain.

HEREAS by an Act, passed in the fourth year of His Majesty's reign, intituled "An" Act to repeal certain duties of Customs in Great Britain, and to grant other duties in lieu thereof; to grant certain bounties on salted provisions and silk manufactures exported; and to make more effectual regulations for collecting the duties of Customs;" and by another Act, passed in the same session of Parliament, intituled "An Act to repeal the several duties and drawbacks. Of Customs chargeable and allowable in Ireland, on the importation and exportation of certain

" foreign and colonial goods, wares, and merchandise, and to grant other duties and draw-" backs in lieu thereof, equal to the duties and " drawbacks chargeable and allowable thereon in " Great Britain;" His Majesty is empowered, by His Order in Council, to be published in the London and Dublin Gazettes, to direct, for the convenience of trade, and for the more economical collection of the revenue, that the management of all import duties should be placed wholly under the Commissioners of Customs, or wholly under the Commissioners of Excise; and whereas it is deemed expedient, that from and after the fifth of April next, the import duties upon the following articles, namely, coffee, cocoa, tobacco and snuff, pepper, spirits, wine, and all other foreign goods now subject upon importation, to duties collected by the Excise, except tea, should be placed wholly under the management of the Commissioners of Customs; His Majesty having taken the same into consideration is pleased, by and with the advice of His Privy Council, to declare and direct, that all such duties upon the articles above enumerated shall be placed, and shall be under the sole management and authority of the Commissioners of. His Majesty's Customs, according to the provisions and directions of the said Acts, from and after the fifth day of April next, during the time that the aforesaid duties shall continue to be payable: And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary Jas. Office of Church Commissioners, 13, Great George- ther accommodation of the numerous and distant Street, 22d March 1825.

THE following is the copy of an Order of His Majesty in Council, approving of a district being assigned to a new Chapel built in the parish of Bitton, in the county of Gloucester:

At the Court at Brighton, the 10th of December 1321, present, the King's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fifty-eighth wear of His late Majesty's reign, intituled, Act for building and promoting the building of additional Churches in populous parishes," it is amongst other things enacted, "that in any case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into complete separate and distinct parishes for all ecclesiastical purposes whatever, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the Bishop, signified under his hand and seal, may deem necessary for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches and chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels, to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall pepresent such opinion to His Majesty in Conneil, and shall state in such representation the bounds by which such districts are proposed to be described, and if thereupon His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be walid and good in law for the purpose of effecting such division "-And whereas a representation has been made by the said Commissioners to His Majesty in Council, stating that in the month of January 1819, a petition of the Curate, Church-wardens and several of the Inhabitants of the parish of Bitton, in the county and diocese of Gloucester, was presented to the said Commissioners; and that, amongst other things, the said petition set forth, that the said parish of Bitton was in its greatest extent about forty-eight furlongs long, and thirty-seven wide; that it comprehended the villages of Swinford, Upton, Beach Willbridge, Hanham, Old Land, Kingswood, Cockroad, and other villages; that the number of inhabitants, according to the census taken in the year 1811, was 6061; that the parish church was incapable of accommodating more than 372 persons, and that the accommodation could not be extended for more than 186 persons; that there were two consecrated chapels in the parish, one capable of accommodating 206 persons, and the other 219; and that for the fur-

inhabitants, who were precluded from attending divine worship, the inhabitants were desirous that a church or chapel for the accommodation of 1000 persons, should be erected in the hamlet of Old-Land, the population of which amounted to 3641. persons, and that of that number 2000 were dismnt from twenty-four to thirty-two furlongs from the parish church, and from eight to sixteen furlongs from any chapel; that the parish were willing to provide a site, and also to raise by subscription as much as their small means would allow towards defraying the expence of the building.-That the said Commissioners having taken the petition, and all the circumstances of the parish, with reference to its spiritual wants, into consideration, deemed it expedient that a new chapel should be built in the hamlet of Old-Land, capable of accommodating 1000 persons, and that four-fifths of such accommodation should be in free seats, to be appropriated to the use of the poor, and that it was expedient to grant in His Majesty's name, out of the Parliamentary fund, the sum of £2143 towards the expence of erecting the same. That a chapel has since been erected in the said hamlet of Old-Land. for the accommodation of 1000 persons, according to a plan and an estimate approved by the said Commissioners, and the same has been consecrated; that it has since been represented to the said Com. missioners, that in consequence of the large population in the said hamlet of Old-Land, and the great distance which a considerable proportion of the inhabitants reside from the mother church, or from any chapel of the established church, it would be highly, advantageous if a part of the parish was divided into an ecclesiastical district, under the provisions of the Act of Parliament above mentioned; and that the Commissioners, having taken the said representation into consideration, are of opinion that it will be expedient so to divide the said parish, for the purpose of affording accommodation, for attending divine worship according to the rites of the United Church of England and Ireland, to persons residing within the proposed districts, and for enabling the spiritual persons who may serve the new chapel, to perform all the ecclesiastical daties which may be attached thereto, and for the preservation and improvement of the religious and moral habits of the inhabitrnts; and the Commissioners accordingly caused a map shewing the proposed lines of division to be laid before them, and having approved the same, they applied to the Lord Bishop of the diocese for his consent, which his Lordship has signified under his hand and seal, as required by the said Act; and the Commissioners beg leave, therefore, to lay before His Majesty the before mentioned circumstances, and a map (which is hereunto annexed) in which the proposed division is marked with red, and humbly pray, that His Majesty will be graciously pleased to take the premises into his royal conside. ration, and make such order in respect thereto as to His Majesty in his wisdom shall seem meet.

His Majesty having taken the said representation of the said Commissioners into consideration, is thereupon pleased, by and with the advice of His Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed division be accordingly made and effected, agreeably to the provisions of the said Act.

DESCRIPTION OF THE DISTRICT.

The district is bounded by other parishes on all sides, exceptions as follow; commencing at what is commonly called the Stroud brook, where is set up a meer stone No. 1, inscribed Trinity district, you proceed eastward along the Bitton turnpikeroad until you come to the stone No. 2, from which you go about a mile along the same road till you come to the stone No 3, opposite the Longwell-green pound, where, turning to the left, you take a north easterly direction along the road leading from Warmley, and passing No. 4, opposite what is commonly called Dodd's-lane, you proceed along the Park-wall side of Barr's-court, this brings you directly down to No. 5, Warmley-brook.

Majesty in Council, approving of Districts being assigned to the four new Churches built, building, or to be built in the parish of St. Maryle-bone, in the county of Middlesen:

At the Court of Carlton-House, the 7th of April 1824, present the King's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the 58th year of His late Majesty's reign, intituled "An Act for building and promoting the building of additional churches in populous parishes," it is amongst other things enacted, "that in any case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that it is not expedient to divide any populous parish or extra parochial place, into complete separate and distinct parishes for all ecclesiastical purposes whatever, but that it is expedient to divide the same into such ecclesiastical district as they with the consent of the Bishop signified under his hand and seal may deem necessary, for the purpose of affording accommodation for attending divine service, according to the rites of the United Church of England and Ireland to persons residing therein, in the churches and parochial chapels already built, or in additional churches and chapels to be built therein, and as may appear to such Commissioners to be convenient, for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties, within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described, and if thereupon His Majesty in Council shall think fit to direct such division to be made, such order of His Majesty in Council shall be valid

and good in law for the purpose of effecting suchi division."-And whereas by another Act of Parliament, made and passed in the first and second years of His present Majesty's reign, intituled "An Act: to enable the Vestrymen of the parish of St. Maryle-bone, in the county of Middlesex, to effectuate the building of four district churches in the said parish, and for other purposes relating thereto;" it is cuacted "that it shall and may be lawful for the said Commissioners with the consent of the Patron and the Lord Bishop of London, for thetime being, to assign a particular district to each of the four district churches, by the said! Acts directed to be built in the said parish of St. Maryle-bone, such assignment of district to be laid? before His Majesty in Council, and if thereupon His Majesty in Council shall think fit to direct such; division or district to be made, such Order of His-Majesty in Council shall be valid and good in law for the purpose of effecting such division."-And whereas His Majesty was pleased by His Order in Council, of the 16th of July last, to approve of a representation of the said Commissioners submitting the divisions or districts to be assigned to the said four churches.—And whereas a further representation has been made by the said Commissioners. to His Majesty in Council stating, that the Surveyor employed by the parish to prepare a description of the boundaries of such districts had not sufficiently described the boundaries of one of the said districts, and also that in consequence of the very large scale on which the map describing the boundaries of the said districts had been prepared,. the expence of enrolling the same in His Majesty's. High Court of Chancery, would amount to a very. considerable sum: that the said Commissioners. have since caused a new map on a much smaller: scale, and a new and more perfect description of the boundaries, to be prepared which exactly accordwith each other, and also with the former map, and they humbly pray that His Majesty will be graciously pleased to approve of the boundaries set forth. in the papers annexed to their said representation, marked 1, 2, 3, and 4, (copies of which papers are also hereunto annexed), and according to the map accompanying the same, which is hereunto annexed, and that His Majesty will be pleased to make such Order in respect thereto, as to His Majesty. in his wisdom shall seem meet.

His Majesty having taken the said representations of the said Commissioners into consideration, is thereupon pleased, by and with the advice of His Privy Council to approve thereof and to Order, assit is hereby ordered, that the proposed divisions assmore fully set forth and described in the papers 1, 2, 3, and 4, and in the map now exhibited, be accordingly made and effected agreeably to the provisions of the said Acts,

No. 1.

The south eastern district, being bounded on the south and east, by the boundary of the parish, on the north by the middle of Upper Mary-le-bone-street, New Cavendish-street, and part of Great Mary-le-bone-street; and on the west by the middle of Wimpole-street, to the middle of Henrietta-street, then westward along the middle of: Henrietta-street to the middle of Vere-street, and

then bounded westward by the middle of Vere-street, and which district is particularly delineated in the plan hercunto annexed, and is therein coloured red.

No. 2.

The north eastern district, bounded on the south. by the middle of Upper Mary-le-bone-street, New Cavendish-street, and part of Grent Mary-le-bonestreet, on the east by the boundary of the parish, on the north by the middle of the road in the Regent's-park, leading to the inner circle, and round the south east quarter of the said circle, and on the west by the middle of the road running across the bridge in the Regent's-park, to the road in front of York-terrace, and running eastward along the said road 485 feet being the frontage of eighteen houses in York-terrace, and thence crossing a piece of ground and along the Eastern front of a dwelling house, now in the occupation of Fairfax Best, Esquire, being the freehold property of the Duke of Portland, leased to the late John White, Esquire, in a straight line to the New-road, then turning westward 25 feet opposite to the middle of Devonshire-place, and through the middle of Devoushire-place, and Upper Wimpole-street, and part of Wimpole-street, to the point where it meets Great Mary-le-bone-street, and which district is particularly delineated in the same plan, and therein coloured green.

No. 3.

The south western district, bounded on the south and west by the boundary of the parish, on the east by the middle of Orchard-street, running along the east side of Portman-square, and the middle of Baker-street and York-place, and on the north by the middle of the New-road, and which district is particularly delineated in the same plan, and therein coloured yellow. No. 4.

The north western district, bounded on the south by the middle of the New-road, on the east by Upper Baker-street, and the middle of the Parkroad, continuing along the middle of Primrose-hillroad, which forms the northern boundary line of the Regent's park, to the parish boundary line on the east, and from thence to the north east, north and west by the boundary of the parish, and which district is particularly delineated in the same plan, and therein coloured brown.

HE following is the copy of an Order of His Majesty in Council, approving of districts being assigned to the four new Churches built and building in the parish of St. Mary, Lambeth, in the county of Surrey:

At the Court at Carlton-House, the 20th of November 1824, present, the King's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the 58th year of His late Majesty's reign, intituled " An Act for

Churches in populous parishes," it is amongst other, things enacted, "that in any case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that is is not expedient to divide any populous parish, or extra parochial place, into complete, separate, and distinct parishes, for all ecclesiastical purposes whatever, but that it is expedient to divide the same into such ecclesiastical districts, as they, with the consent of the Bishop, signified under his hand and seal, may deem necessary for the purpose of affording accommodation for the attending divine service according to the rites of the United. Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches and chapels. to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels, to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds which such districts are proposed to be described, and if thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law, for the purpose of affecting such division:" and whereas a representation has been made by the said Commissioners to His Majesty in Council, stating that the parish of St. Mary, Lambeth, in the county of Surrey, and diocese of Winchester, contains a population of upwards of 50,000 persons, that the parish church, which is the only consecrated place of worship in the said parish, will not accommodate more than about 1,600 persons; that the said Commissioners, taking into consideration the extent of population, and the great want of church accommodation in the said parish, have caused to be erected four new churches therein, one in the Waterloo-road, near Waterloo-bridge, one at Kennington, one at Brixton, and one at Norwood; that accommodation will be provided in such churches for 3,891 persons in pews, and tor 3,495 poor persons in free seats, the total accommodation being for 7,386 persons; that the churches at Kennington, Brixton, and in the Waterlooroad, have been consecrated, and divine service is regularly performed therein; that the said Commissioners, for the better carrying into effect the objects which they had in view, in causing these churches to be erected, have deemed it expedient that districts should be assigned to each of them, and it is proposed to describe them as follows:

The Waterloo District. The Kennington District. The Brixton District. The Norwood District.

THE WATERLOO DISTRICT. - This district is bounded on the west and north west, by an imaginary line passing along the middle of the River building and promoting the building of additional Thames, on the east and north east by the parish of Christchurch, on the south east by the parish of St. George the Martyr, Southwark, and on the south west and south by the remaining district of the said parish, and in which the original parish church of St. Mary, Lambeth, is situated; as the same is more particularly described as under:

Commencing at the middle of Westminsterbridge, on the south side thereof, the boundary line passes along the middle of the River Thames through the middle of Waterloo-bridge, and thence to a place opposite to the corner of the soap-house of Messrs. Hawe's manufactory, in the Commer--cial-road; thence it makes a right angle, passing along an imaginary line, direct to the corner of the soap-house aforesaid, thence along the west wall of the said soap-house to the middle of the Commercial-road, and thence in an easterly direction to a parish post, in a line with the common sewer; at then turns to the south and passes along the middle of the said common sewer, which runs at the back of houses in Broad-wall, crossing Great Charlotte-street, and passing at the back of Christchurch Work-house to a diverging sewer which divides the parishes of Christchurch and St. George the Martyr, Southwark, thence, turning to the south west, it passes along the middle of the said common sewer, dividing this district from the parish of St. George the Martyr, Southwark, which said sewer crosses the Waterloo-bridge-road, and, continuing nearly in the direction, passes under Gilbert's-buildings into the Westminster-bridge-road, and thence obliquely across the said road to near the north east corner of Mead-place; it then turns to the north west and west, and passes along the south side of the Westminster-bridge-road (excluding the foot-path all the way), to the middle of Westminster-bridge, on the south side thereof, as the same is more particularly described and delineated in the ground plan hereunto annexed to the said representation.

THE KENNINGTON DISTRICT—This district is bounded on the north by the last before-mentioned district, and, generally, on the east by the parishes of Newington and Camberwell, on the south by the Brixton district and the parish of Clapham, and on the north west by the parish of Battersea, as the same is more particularly described as under:

Commencing at the middle of Vauxhall-bridge, on the south side thereof, it passes along the south side of the said bridge, and thence along the south side of Kennington-lane (including the foot-path all the way), to the outer edge of the foot-path on the north west side of Kennington-road, near the Plough and Harrow public-house; thence, turning to the south west, it passes along the outer edge of the foot-path on the north west side of the Kennington-road, and crosses the said road, obliquely, to the north corner of Kenningtoncommon; thence, turning to the south east, it follows along the middle of the ditch, wholly on the north east side of the said common, and it then turns to the south west and continues, partly, on the south east side thereof to a D. C. landmark, a little beyond the angle of Mr. Farmer's Vitroilworks; thence, turning square to the south east, it proceeds along the middle of the ditch on the south west side of a foot-path leading to Camber-

well, to a parish mark opposite the rear of gardens and paddocks belonging to houses in Bowyer-lane; thence it turns nearly square to the north east, and, crossing the said foot-path, passes along a ditch to the east side of a street, called Pitt-street, where if makes an acute angle and passes to a parish mark on the south east side of Bowyer-lane; thence, turning to the south west, at an angle nearly square, it proceeds along the south east side of the said lane, and nearly in the same direction, across the new road leading to Camberwell, and two fields on the south west side thereof, to a parish mark in the hedge; thence, forming nearly a right angle, it passes south south east along the hedge which divides the land of this district from that of Camberwell, to the south west angle of the field; thence, turning eastwardly a few yards along the ditch on the south side of the same field, it there forms nearly a square angle, and passes southwards to a parish mark in the adjoining field; thence, taking a direction south west and south, in a curved line, by three parish marks, to the north east corner of Loughborough-house garden; thence, proceeding south along the ditch, on the east side thereof, it crosses a toot-way leading from Stockwell to Camberwell, and, in the same direction, continues to an angle formed by a hedge which divides this district from the parish of Camberwell, thence it turns to the east, and passes along the said hedge until it quits the same opposite the angle of a row of houses in a new street leading into Cold Harbour-lane, whence it passes in a north easterly direction, by several parish posts, to a parish stone by the side of a gateway, and thence takes a northerly direction to the corner of an old lane, where it makes an acute angle, and passes, nearly east, to the end of a wall at the back of houses in Camberwellgreen, and passes the end of the said wall, a few yards, to a parish post, it turns north a few yards along a ditch to the corner of a carpenter's shop, where there is a parish post; thence it makes nearly a right angle to the east, and passes through the yard and house now occupied by Mr. Mayhew, a carpenter, to a LP, cut in the cill of the entrance gate, and thence to the edge of the foot-path opposite the Father Red Cap public-house; thence it turns south, and, including the foot-path, proceeds to the north east end of Cold Harbour-lane, it then passes along the south east side of Cold Harbour-lane East, the west side of Green Manlane, and the south side of Loughborough-houselane, to the Croydon-road, at North Brixton; thence it passes, obliquely, across the said road to the south east corner of Robert-street, and thence along the south side thereof, and of Lovelane, to Stockwell village, whence it crosses the road, obliquely, proceeds along the north west side of Stockwell-green, including the road, and continues on the south east side of Bedford private road to Clapham Work-house, whence it passes, in a northerly direction, along the east side of the Clapham-road, excluding the foot-path, to a LP. stone in the wall of the fore-court to Mr. Willmot's house; thence it crosses the said road to a parish stone in an opposite paddock, from which it takes an oblique direction north north west to a bridge in Union-road, and thence along the middle of a common sewer all the way to Nine Elms, in the

parish of Battersea, which sewer runs for a short | little beyond the angle of Cassino-house; it there distance northwards to a parish mark, and thence, nearly west, crossing Lark-hall-lane, and, continuing nearly in the same direction, to the front of houses in Chichester-place, situate in the turnpikeroad from London to Wandsworth; thence, passing under the same, it takes a curved direction to the south west, and thence continues westward, by the side of a garden belonging to the southernmost house in Chichester-place aforesaid, until it unites with another common sewer, along the middle of which the boundary line passes in a north easterly direction all the way to Nine Elms aforesaid, to a parish post over the said sewer; thence it continues, obliquely, across the road to a parish mark on the foot-path, about three yards from the corner of Belmont-row, and thence, passing at the same distance, parallel, along the west side of the garden belonging to Belmont-house, and thence, by an imaginary line, to the middle of the River. Thames, and, by another imaginary line, along the middle of the same to the centre of Vauxhallbridge aforesaid, as the same is more particularly described and delineated in the ground plan annexed to the said representation.

THE BRIXTON DISTRICT.—This district is bounded on the north by the Kennington district, on the east, generally, by the parish of Camberwell and manor of Dulwich, on the south by the district of Norwood and the parish of Streatham, and on the west by the parish of Clapham, as the same is more particularly described as under:

Commencing at Clapham Work-house the boundary line passes along the south east side of Bedford private road, the north west side of Stockwellgreen, the south east side of Love-lane and Robertstreet, until it crosses the Croydon-road, obliquely to the right, whence it passes along the south side of Loughborough-house-lane, the west side of Green Man-lane, and the south east side of Cold Harbour-lane East, to the north east end thereof, at the onter hedge of the foot-path on the west side of the road through Camberwell village; the boundary thence, turning to the south, passes on the west side of Denmark-hill-road, including the foot-path, to a parish mark, whence it crosses the said road, obliquely, and passes, in the same direcrion, through a triangular paddock, opposite Denmark-hill, thence by the side of the said hill, in the same direction, to a parish stone in a paddock in the rear of the same, where it turns square to the east, and proceeds a short distance until it joins the west side of the road to Champion-hill; it there makes another square angle, and passes south east by the side of the said road to a parish mark adjoining the wall of a messuage on Championhill; it then turns square, nearly west, and, following the said wall, crosses to the west side of a private road leading to Dulwich, whence it passes, nearly in the same direction, through certain pleasure grounds belonging to houses on the south east side of Denmark-hill, to within a tew yards northward of a double lodge, where there is a parish mark, and thence to another parish mark, near the the red post at the corner of the road to Dulwich ; thence, passing along the south east side of the

leaves the road, nearly at a right angle, for a few yards, and passes on to a parish mark in the pleasure ground belonging to the said house, and thence, making an obtuse angle, proceeds, in a parallel direction with the road, to a parish mark in the fore-court of the north easternmost house on the property of Thomas Lett, Esq.; it then takes a south easterly direction, following the park pailing on the north east side of the said property, to the corner of the orchard; thence, making nearly a square angle, and turning east, it follows the same pailing until it joins the road from Red Post-hill to Dulwich, and, turning south, it continues to follow the same pailing, on the south west side of the said road, to a parish mark at the east corner of Mr. Lett's property; thence, turning westward by the fence on the north west side of a foot-path which separates Mr. Lett's property from a triangular paddock belonging to Dulwich-college, it proceeds until it joins the road from the Half Moonbridge to Dulwich; thence, continuing in front of Mr. Lett's lodge, and gradually diverging a few yards distant from the road, it passes through the kitchen-garden, and thence to the back of certain cottages fronting the Half Moon-road, and thence by a line of trees to a fence on the north east side of a toot-path which separates Mr. Lett's property, on the south west, from a certain other triangular paddock belonging to Dulwich-college, formerly called Ireland-green; thence, following the said fence, it joins the parish highway upon Hearnhill, and then turns nearly square, and, passing in a south west direction along the south east and east side of the said highway, it crosses another highway, belonging to the hamlet of Dulwich, to an old hedge-row a few yards east of the Half Moonbridge; thence it continues, in a southward direction, to follow the irregular line of the said hedgerow to a parish mark in Croxted-lane, a few yards distant from Norwood-lane, from which point it passes south west, and gradually approaches Nor-wood-lane, along a water course, until it joins the said lane, nearly opposite the pond of Brockwellhall, it there follows the same water course, on the south east side of Norwood-lane, to a bridge-way, where it crosses the same, nearly opposite the northern boundary of the Norwood district; the boundary then passes to the west, along a hedgerow between Brockwell-hall and Page's-nelds, and thence, in a line square, from Tulse-hill Lowerroad, along which said road, on the east side thereof, it passes south for a few yards, and thence, turning square to the west, it passes along the south side of Upper Tulse-hill-road to a small water course, in which there is a parish mark, a few feet from the road; thence it turns south to the said parish mark, and again, turning nearly at a square angle, it passes westward along an old hedge-row to a parish mark at an obtuse angle of the same, whence it takes a northerly direction, nearly parallel with Upper Tolse-hill-road, along the same old hedge, until it unites with the said road, and a parish mark at the circular turn of the same, into the Brixton-road; it then follows the south side of the said road a few yards to another parish mark, whence it diverges from the road and and road, to a parish mark within the fence, to a passes, by an irregular line, in front of certain

houses lately erected on Brixton hill, and follows where there is a LP post, whence it turns nearly an old hedge until it approaches to within a few yards of the turnpike-road from London to Streatham, where there is a parish mark; thence, making an acute angle, it passes, obliquely, across the said turnpike-road, and proceds through a lane opposite, following a water course in the middle of the same for some distance, and then passing near a windmill, on the north east side of the lane, until it crosses the lane to Streatham-common, near Bleakhall, where there is a parish post; thence it passes along the north west side of Streathamlane, and the west side of Bleakhall-lane and Bedford New-road, all the way to Clapham Work-house aforesaid, as the same is more particularly delineated and described on the ground plan annexed to the said representation.

THE NORWOOD DISTRICT.—This district is bounded on the north by the Brixton district, on the east partly by Knights hill, in the parish of Streatham, but on the greater part by the manor of Dulwich, on the south by the parishes of Croydon and Streatham, and on the west by the parish of Streatham, which is more particularly described as under:

Commencing at a small water course, and a parish post about ten feet from Tulse-hill Upperroad, the boundary line passes eastward along the south side of the said road, until it crosses Tulsehill Lower-road, thence it continues northward about one hundred yards on the side of the said road, and then makes a square angle east to the north west corner of Page's-fields, and continues nearly in the same direction along the hedge on the north side of those fields to the water course and bridge which crosses Norwood-lane, thence turning to the south, along the east side of Norwood-lane to a parish mark, it takes a south east direction along the ruins of an old hedge row, where there are several parish marks, then turning nearly square to the east it passes along to the ruins of another old hedge row in a curved line to its junction with the water course running from the vicinity of the house of industry, which continues nearly in the same direction to its junction with another water course running from Hall-lane; thence, making an acute angle to the south, the boundary line passes along the last-mentioned water course to Hall-lane, and along the east side thereof to a LP post at the corner of Hall-green; thence it makes an obtuse angle south east, and proceeds along an old hedge row crossing the parish highway leading to Dulwich, to a LP post on the south east side thereof, thence following the hedge on the east side of Beaulieu-road to a LP post at the spot from whence the road diverges from the said hedge, and continuing along an old hedge and passing several parish, posts up to the Vicar's Oak; thence it makes an acute angle, and passes along the north side of the Vicar's Oakroad all the way to the corner of Elder-road, where it crosses Vicar's Oak-road to the south side thereof, and where there are several parish marks; and thence making a square angle, it passes along the south side of the Vicar's Oak-road and Streathamlane to the corner of Streatham-common, thence it

square to the westward, and passes along an old hedge to a LP post near a house belonging to Penoyer, Esq. from which place the boundary line turns square to the north, and passes along a hedge row through three fields to a LP post; thence, making rather an acute angle, it passes eastward along a hedge row to the corner of a field in the parish of Streatham, thence turning northward it follows an old hedge row by an irregular line to Leigham-lane, and, crossing the same, continues along the said hedge row, in the same direction, to an obtuse angle formed by the same, thence in a north east direction along the said hedge until it turns to the north west, whence it continues to follow the said hedge to the parish mark in the small water course about ten feet from Tulse-hill Upper-road as before mentioned, the same being more particularly described and delineated in the ground plan annexed to the said representation.


