

places. From Hungary we have advice, That 30000 Turks are Encamped near *Newborsel*; and that a strong Party belonging to that place has been defeated by Major General *Schurz*; and 700 of the Turks slain upon the place. Count *Teckelej's* Secretary remains still here, but without any business that appears. From *Poland* they tell us, That that King has appointed the Troops he has now on Foot to Rendezvous on the 14th of the next Month in the Neighbourhood of *Cracaw*.

Rathbonne, May 10. The Director of the Colledge of Princes has desired the Bishop of *Mecklenburg*, the Emperor's Commissioner, to use his Authority with the Electoral Colledge, in order to the reconciling the difference between the two Colledges, which is so prejudicial to the whole Empire, seeing the important Points concerning the publick Security, and the Treaty with *France*, are thereby obstructed. The Emperor and the King of *Poland* are sending Ambassadors to *Moscow*, to invite the Czar to enter into the Alliance concluded between them against the Turks.

Brussels, May 18. On Friday our Governour, the Marquis de *Grana*, went from hence for *England*, where after Midnight he was privately married with Mademoiselle d'*Arenberg*, by the Archbishop of *Malines*. On Saturday in the Evening their Excellencies returned hither, and the next day his Excellency received the Compliments of all the Nobility, and the General Officers, &c. and on Thursday next her Excellency will receive her first Visits. On Saturday arrived here the Count de *Roye* from *Paris*, and parted again this Morning for *Antwerp*, where he will spend the next three days, and then continue his Journey for *Denmark*, being to command that King's Army. From the new Conquests they write, That the Marshal d'*Humieres* is expected at *Lille* the 22 of this Month; That Monsieur *Montbrun* and Monsieur de *Sourdis* are to meet him there and that soon after the Troops will march to the Camps designed, between *Marienburg* and *Philippville*, and between *Ipres* and *Warneton*; the first will be commanded by Monsieur *Montbrun*, and the other by Monsieur de *Sourdis*. We have advice, That some French Men of War, meeting with two Ships belonging to *Genova*, have taken one (which had on Board 200000 Crowns in Money) and sunk the other.

Brussels, May 21. Last Night there was a great Court, her Excellency receiving the Compliments of all the Nobility and other Persons of Quality, who were afterwards entertained with a Banquet; the Magistrates of this City have made her a Present of 6000 Crowns, and it's believed the other Towns will follow the Example. To-morrow his Excellency goes for *Antwerp*, to meet the Prince of *Orange*, who will be there on Sunday. Monsieur de *Fuen Mayor*, the Spanish Minister at the *Hague*, is arrived here, but the occasion of this sudden Journey is not yet publickly known.

Hague, May 21. To-morrow the Prince of *Orange* parts from hence for *Breda*, and before he returns, his Highness will have an Interview with the Governor of the Spanish Netherlands at *Antwerp*. The States-General have, as we are informed, sent Orders to their Ambassador at *Madrid*, to represent to the King of *Spain* and his Ministers the great prejudice which the Subjects of this State

are like to receive in their Trade by the Letting of the King's Customs in the Spanish Netherlands to Farm, and therefore to desire that the same may be raised, as formerly by the King's Officers. We are told, That Monsieur *Bierman*, the Danish Minister, is parted from *Berlin* very well satisfied with the Success of his Negotiation.

Paris, May 22. The Genouef Ship, taken by the Marquis d'*Amfreville*, and by him brought to *Toulon*, was bound from *Genova* to *Cadix*, and is said to be worth 200 thousand Piccas of Eight. All things are preparing for the King's Journey. Our Spanish Letters of the 29th last give us an account, That Count *Mansfeld* the Imperial Ambassador was arrived at *Madrid*.

Portsmouth, May 20. On Wednesday in the Afternoon. Sailed from *Spitsbaad* the *Dover* Frigate, with several Merchant Ships to the Westward. The same day Sailed the *Pearl* Frigate.

Plimouth, May 22. This Evening arrived here His Majesty's Ship the *Dover*, bound for *Tangier*.
