### PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS the time limited by His Majesty's Order in Council, of the third of May last, for prohibiting the exportation of gun-powder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar), has expired; and whereas it is judged expedient that the said prohibition should be continued for some time longer, His Majesty, by and with the advice of His Privy Council, doth therefore hereby order, require, prohibit, and command, that no person or persons what-soever (except the Master-General of the Ordnance for His Majesty's Service), do, at any time during the space of six months (to commence from the date of this Order), presume to transport any gun-powder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar) or ship or lade any gunpowder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, in order to transporting the same into any such ports or places on the Coast of Africa (except as above excepted), without leave or permission in that behalf, first obtained from His Majesty or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties inflicted by an Act, passed in the twenty-ninth year of the reign of His Ma-jesty King George the Second, intituled "An Act " to empower His Majesty to prohibit the expor-" tation of gun-powder, or any sort of arms or amm mition, and also to empower His Majesty. to restrain the carrying coastwise of salt-petre, gun-powder, or any sort of arms or ammu-"nition;" and also by an Act, passed in the thirty-third year of His late Majesty's reign, cap. 2,

John Hemy Vivian, of Marino, | intituled " An Act to enable His. Majesty to " restrain the exportation of naval stores, and " more effectually to prevent the exportation of " salt-petre, arms, and ammunition, when pro-" hibited by Proclamation or Order in Council:

> And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain. Office of Church Commissioners, 13, Great George-Street, Westminster, January 31, 1827.

THE following is the copy of an Order in Council, approving of districts being assigned to the two new churches built in the parish of Saint .Mary, Newington, in the county of Surrey:

At the Court at Saint James's, the 20th of November 1826, present, the King's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the 58th year of His late Majesty's reign, intituled "An Act for building and promoting the building of additional churches in populous parishes," it is amongst other things enacted, "that in every case in which the Commissioners appointed for carrying into execution the puposes of the said Act, shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto, under his hand and seal, and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe lands, tithes, moduses, or other endowments, which will by such division arise and accrue and remain to be within each of such respective divisions, and also the relative proportions of the estimated amount of the value, or produce of fees, oblations, offerings, or other ecclesiastical dues or profits, which may arise and accrue within each of such respective divisions, and if thereupon His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the pur-

Cornet Andrew Fletcher to be Lieutenant, vice pose of effecting such division; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" And whereas by the said Act it is further enacted "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete separate and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the Bishop, signified under his hand and seal, may deem necessary, for the purpose of affording accomodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendance of such district, and the preservation and improvement of the religiousand moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division:'

And whereas the said Commissioners have made a representation to His Majesty in Council, stating that the parish of Saint Mary, Newington, in the county of Surrey, and deanery of Croydon, the peculiar and immediate jurisdiction of the cathedral and metropolitan church of Christ, Canterbury, contains a population of thirty-five thousand persons and upwards, and that the parish church in the said parish will not contain more than about one thousand two hundred persons, exclusive of the children of the parochial schools; that by virtue of an Act of Parliament passed in the first year of His Majesty's reign, intituled "An Act for building two new churches or chapels in the parish of St. Mary, Newington, com-monly called Newington Butts, in the county of Surrey, and for other purposes relating thereto," and with aid granted by the said Commissioners, two new churches have been erected in the said parish, one in Great Suffolk-street, and the other in Beckfordplace, wherein accommodation has been provided for two thousand seven hundred persons in pews, and for one thousand two hundred poor persons in free-seats the total accommodation in such churches being for three thousand nine hundred persons. That the said churches have been consecrated, and Divine Services is regularly performed therein. That the said Commissioners, for the better carrying n'o effect the objects which they had in view, in causing the said, churches to be erected, have deemed it expedient that districts should be assigned to each of them; one to be described the "Trinity District," the second the "St. Peter's District." The Trinity District to commence in the road opposite to the

centre of the west end of the New Kent-road, where the parish joins St. George's, and to comprise the north or left-hand side of the New Kentroad as far as Union-row, the east side of Unionrow, the north side of Gloucester-row, to Brandonstreet, the east side of Brandon-street to Bedfordstreet, the north side of Bedford-street, and the north side of Salisbury-place, Cottage-row, and George-row, where the parish again joins Saint George's; then proceeding northward along the boundary of St. George's parish, passing the end of Dover-place, crossing the New Kent-road, and from thence continuing the same boundary, and crossing Great Dover-street; then proceeding in a northerly direction along Kent-street and Church-street, till it terminates opposite St. George's Church, in Blackman-street; thence returning southward, and continuing along Blackman-street and the causeway to the point opposite the centre of the west end of the New Kent-road, and all the intermediate streets, roads, and places; which district is coloured green in the map hereunto annexed. The St. Peter's district to commence at the centre of the Walworth road, opposite Manor-place, and thence proceed westward along Manor-place, including the south or left side thereof, the east side of Canterbury-place, thence westward along West-lane, and in a straight line to the back of the premises occupied by Mr. Farmer, near Kennington-common, along the boundary of St. Mary's district, thence proceeding southward, and continuing along the boundary of Lambeth parish, and afterwards eastward along the boundary of Camberwell parish to the Camberwell road, thence crossing that road by the same boundary, along Walworth-common, near to Surreysquare, where the parish again adjoins St. George's, thence northward, continuing the boundary of Saint George's to the end of George-row, until it joins the district for Trinity Church, thence westward. induding the left-hand or south side of George-row, Cottage-row, Salisbury-place, Bedford-street, and York-street, to the Walworth-road, at the east end of Manor-place, together with all the intermediate streets, roads, and places, which district is coloured red in the map hereunto annexed. That the consent of the Lord Bishop of the diocese to the proposed divisions has been obtained, as required by the 25th section of the said Act of the 58th year of the reign of His late Majesty. That the said Commissioners beg leave, therefore, to lay before His Majesty the hefore-mentioned circumstances, and humbly pray that His Majesty will be graciously pleased to take the premises into his royal consideration, and to make such order in respect thereto as to His Majesty in his wisdom shall seem meet. His Majesty having taken the said representation into consideration, is thereupon pleased, by and with the advice of His Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed divisions be accordingly made and effected agreeably to the provisions of the said Acts.

1) If any Creditor intends to oppose a Prisoner's : discharge, notice of such intention must be given : to the said Prisoner, in writing, three clear days. before the day of hearing, exclusive of Sunday, and exclusive both of the day of giving such notice : and of the said day of hearing.

But in the case of a Prisoner, whom his Creditors have removed, by an order of the Court, from a gaol in or near London for hearing in the: country, such notice of opposition will be sufficient a if given one clear day before the day of hearing.

8. The petition and schedule will be produced by the proper Officer for inspection and examination, at the Office of the Court in London, on Mondays, Wednesdays, and Fridays, between the hours of Ten and Four; and copies of the petition and schedule, or such part thereof as shall be required, will be provided by the proper Officer, according to the Act, 7 Geo. 4, c. 57, sec. 76.
