RDERS for the Courts change of mourning, on Thursday next the 22d instant, for His late Royal Highness Frederick Duke of York and Albany, His Majesty's next Brother, viz.

The Ladies to wear black silk, fringed or plain linen, white gloves, black or white shoes, fans and tippets, white necklaces and ear-rings.

Undress—White or grey lustrings; tabbies or damasks.

The Gentlemen to wear black, full trimmed, fringed or plain linen, black swords and buckles.

Undress—Grey frocks.

The Court to change the mourning further on Thursday the 15th of March next, viz.

The Ladies to wear black silk or velvet, coloured ribbons, fans and tippets.

The Gentlemen to continue in black, full trimmed, and to wear coloured swords and buckles.

And on Thursday the 5th of April next, the Court to go out of mourning.
