May it please your Majesty, WE, the Mayor, Jurats, and Commonalty of the Town and Port of Sandwich, in the County of Kent, at the Guildhall of the said Town and Port assembled, beg leave to offer to your Majesty our most sincere and respectful sentiments of regret and condolence on the very heavy loss which your Majesty and the Nation have sustained by the demise of your Majesty's beloved and august Brother, His Royal Highness Frederick Duke of York and Albany, an event which cannot but be powerfully and universally felt and lamented by all your Majesty's faithful subjects.

To the KING's Most Excellent Majesty,

Most Gracious Sovereign,

WE, the Noblemen, Gentlemen, Clergy, Free-holders, and other Inhabitants of the County of Armagh, beg leave to offer to your Majesty the expression of our most sincere sorrow for the loss recently sustained by your Majesty, the Royal Family, and the British Empire, in the lamented death of His Royal Highness the Duke of York.

Attached as we are to your Majesty's Person and Government, we must deplore any calamity, which, while it affects your Majesty with grief, diminishes to

your subjects the assurance of a continuance of that royal succession to which they are accustomed to look for the preservation of their constitutional liberties. On the present melancholy occasion, however, we are penetrated by personal considerations of the eminent services rendered to the Empire by the illustrious personage whom we lament.

We cannot cease to remember that, in the long: and most arduous struggle, in which it was the for-tune of the British Empire to be engaged, almost singly, against revolutionary France, we have experienced the effectual services of an army which had been fostered by the vigilant and paternal superin-tendance of the late Commander-in-Chief. When the maratime force of the Empire had annihilated the navies of its enemies, and it had become necessary that we should encounter on land the implacable foes of national independence, then was an army required, which could wage with energy a contest foreign from the ordinary habits of a maratime state, and then, too, was witnessed the efficacy of the provident care, which had long been silently exercised in preparing the means of finally securing the safety, and vindicating the honour of our country: nor is our sensibility to the public loss, which has been specially sustained in the decease of that great personage, limited to a consideration of the military distinction of the forces which he superintended: the soldiers of the British Empire, while they were rendered formidable to the enemies of their country, were also, under his direction, rendered so orderly and moral that, when at the restoration of peace, a large portion of the army was necessarily reduced, the public tranquillity never experienced any interruption: we know, too, that while these important services were effected, the army looked up to the Commander-in-Chief as their common friend and protector, the humblest individual was certain of finding an opportunity of making known his case, and of experiencing, with prompt and kind attention, all the consideration, and of receiving all the relief which circumstances would permit; the widow and the orphan of him who had fallen in fighting the battles of his country were well assured that they might appeal with confidence to the sympathies of a princely heart.

These are great and glorious distinctions which must indeed augment our sorrow, but yet suggest the gratifying and consoling sentiment, that the high personage whom we lament has not existed in vain, but has entwined our recollection of his services with our sense of the public safety and glory, of the benefits of public order, and of the best interests of the Empire.

To this testimony of our heartfelt concern in the calamity to which your Majesty has, by the visitation of Divine Providence, been subjected, in common with the whole Empire, we beg leave to add an assurance of our unaltered attachment to a Sovereign, under whose Government this Nation has not only maintained its independence, in a crisis of difficulty wholly unexampled, but has been exalted to be the common model of every people aspiring to the enjoyment of the blessings of freedom. trious in the world, have justly procured for him the lasting respect and gratitude of every subject, no

less than of every soldier.

That your Majesty may be supported by Him who woundeth, but whose hands make whole; that your Majesty may be blessed and long preserved; and that your Majesty's reign may continue to be glorious, happy, as it has already beyond measure proved, is the prayer of, may it please your Majesty, your Majesty's dutiful and loyal subjects, the Mayor, Sheriffs, and Inhabitants of the County of the Town of Carrickfergus.
