WE, the Ministers and Elders of the Presbytery of Stirling, assembled at Stirling, beg leave humbly to approach the Throne, for the purpose of expressing our cordial attachment to your Majesty's Person and Government, and our deepest sympathy under

Almighty God to visit your Majesty and the Country, by the death of His Royal Highness the Duke of Ýork.

In pursuance of the directions of an Act, passed in the twenty-fourth year of the reign of His late Majesty King George the Third, intituled " An Act " to repeal so much of two Acts, made in the tenth " and fifteenth years of the reign of His present " Majesty, as authorises the Speaker of the House " of Commons to issue his warrants to the Clerk of " the Crown, for making out writs for the election " of Members to serve in Parliament, in the manner " therein mentioned, and for substituting other pro-" visions for the like purposes:"

I do hereby nominate and appoint the Right Honourable Robert Peel; the Right Honourable Sir John Nicholl; Henry Bankes, Esq.; William Ralph Cartwright, Esq.; Edward John Littleton, Esq.; William Henry Ashurst, Esq.; and John Charles Herries, Esq. being Members of the House of Commons, or any one of them, to issue warrants to the Clerk of the Crown, in the cases in the said Act specified.
