# "To the KENG's Most Excellent Majesty.

WE, your Majesty's dutiful and loyal subjects, the Sheriff and Grand Jury of the County of Monaghan, most humbly beg to convey to your Majesty, the expression of our profoundest sorrow on the recontrandimost humented death of His Royal Highhess the Duke of York and Albany.

If affliction can be nutigated in the royal hosom by the sympathy of the British empire, your Majesty will fact the poignancy of grief assuaged by the condolence of its people, who have for somany years contamplated, with unqualified pride and admiration, the royal and military attributes of our lamented Commander in Chief.

We repeat our expressions of sincere condolonce, which, from a loyal and devoted people, we humbly "restance, in the hour of affliction, be some consolution to your Majesty.

"Most Gracious Sovereign,

WE, your Majesty's dutiful and loyal subjects, the Mayor, Aldermen, Bailiffs, and Citizens of the City of Carlisle, desire to lay before your Majesty our sentiments of deep condolence upon the afflicting dispensation with which it has pleased Divine Providence to visit your Majesty, in the Jamented dissolution of your Majesty's august Brother, His Royal Highness the Duke of York and Albany.

We forbear expatiating upon the many amiable qualities by which His Rayal Highness was so eminently distinguished, and which justly endeared him to all classes of your Majesty's subjects, particularly to those who had the honour of serving in the British

army during the long period in which His late Royal Highness so ably and impartially filled the high and important office of Commander in Chief.

That your Majesty may be supported under your present affliction by the same almighty arm that has, in infinite wisdom, inflicted the blow, and that your Majesty's reign, hitherto distinguished by upparalleled glory and prosperity, may be long continued a blessing to the nation, is the fervent prayer of your Majesty's dutiful and loyal subjects.
