WHEREAS it hath been humbly represented unto the King, that about half past nine o'clock on Saturday night the 12th instant, as Mr. James Ashenden, a miller, of Chartham, in the county of Kent, and Overseer of that parish, was returning home on horseback from Canterbury market, he saw two men standing by the bank side of the turnpike road at Cocking Bottom, about two miles from Canterbury, one of whom, as he was passing them at a brisk pace, shot at him with a blunderbuss or short gun, and wounded him in several places in the left arm; and the other man immediately afterwards discharged a pistol at him, but without effect;
