Foreign-Office, July 2, 1827.

T has been notified by the French Minister for Foreign Affairs to His Majesty's Ambassador at Paris, "that the French Government has declared an effective Blockade of the Port of Algiers; and that every measure authorised by the Law of Nations will be adopted and enforced against all Neutral Vessels which may attempt to violate the said Blockade."

The Speech of the Lords Commissioners to both Houses of Parliament, on Monday July 2, 1827.

My Lords, and Gentlemen,

TE are commanded by His Majesty to express to you the satisfaction which His Majesty feels in being enabled, by the state of the public business, to release you from further attendance in Parliament.

. His Majesty directs us to inform you, that He continues to receive from all Foreign Powers assurances of their earnest desire to cultivate relations of friendship with His Majesty; and that His Majesty's best efforts, as well as His Majesty's communications with His Allies, are unceasingly directed to the termination of existing hostilities, and to the maintenance of general peace.

Gentlemen of the House of Commons,

His Majesty, commands us to thank you for the supplies which you have granted for the service of the present year, and to assure you that His Majesty has given directions for a careful revision or the financial state of the country, with a view to every diminution of expenditure which may be found service, and with the permanent interests, good faith, and honour of the Nation.

My Lords, and Gentlemen,

His Majesty is confident that you participate with His Majesty in the pleasure which His Majesty derives from the indications of a gradual revival of employment in the manufacturing districts.

His Majesty trusts that although your deliberations. on the corn laws have not led, during the present sension, to a permanent settlement of that important question, the consideration of it will be resumed by you early in the ensuing session, and that such an arrangement of it may finally be adopted as shall satisfy the reasonable wishes, and reconcile the substantial interests of all classes of His Majesty's subjects.

Then a Commission for proroguing the Parliament was read; after which the Lord Chancellor said;

My Lords, and Gentlemen,

By virtue of His Majesty's Commission, under the Great Seal, to us and other Lords directed, and now read, we do, in His Majesty's name, and inobedience to His commands, prorogue this Parliament to Tuesday the 21st day of August next, to be then here holden; and this Parliament is accordingly prorogued to Tuesday the 21st day of August next.

Westminster, July 2, 1827.

HIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed every diminution of expenditure which may be found by His Majesty, for declaring His Royal Assent consistent with the necessary demands of the public to several Acts agreed upon by both Houses, do

desire the immediate attendance of the Honouruble House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for enabling His Majesty to raise the sum of five hundred thousand pounds by Exchequer Bills, and for appropriating the supplies granted in this session of Parliament.

An Act to explain and remove doubts touching

the Admiralty.

An Act to consolidate and amend certain laws relating to the revenue of Excise on malt made in the United Kingdom, and for amending the laws relating to brewers in Ireland, and to the allowance in respect of the malt duty on spirits made in Scotland and Ireland from malt only.

An Act to consolidate and amend the laws relating to the collection and management of the revenue of Excise throughout Great Britain and Ireland.

An Act to permit, until the first day of May one thousand eight hundred and twenty-eight, certain corn, meal, and flour to be entered for home consumption.

An Act to make provision for ascertaining from time to time the average prices of British corn.

An Act to amend the laws relating to the Customs. An Act to carry into execution a Convention between His Majesty and the Emperor of Brazil, for the regulation and final abolition of the African slave trade.

An Act to carry into effect the Treaty with Sweden relative to the slave trade.

An Act to consolidate the Boards of Stamps in Great Britain and Ireland.

An Act to amend the Acts for building and promoting the building of additional churches in populous parishes.

An Act to explain so much of an Act, of the present session of Parliament, for punishing mutiny and desertion, as relates to the transportation of offenders.

An Act to extend an Act, of the fifty-sixth year of His late Majesty, for enabling His Majesty to grant small portions of land as sites for public buildings, or to be used as cemeteries.

An Act to prevent arrests upon mesne process, where the debt or cause of action is under twenty pounds, and to regulate the practice of arrests.

An Act to continue, until the thirty-first day of December one thousand eight hundred and twenty-nine, an Act of the fourth year of His present Majesty, for the better administration of justice in New South Wales and Van Diemen's Land.

An Act to authorise the sale of a part of the Clergy reserves in the Provinces of Upper and Lower Canada.

An Act to establish a taxation of costs on private bills in the House of Lords.

An Act for the management and improvement of the land revenues of the Crown in Ireland, and for other purposes relating thereto.

An Act to amend the Acts for the establishing of compositions for tithes in Ireland.

An Act for further amending the laws for the recovery of small debts, and the proceedings for that purpose, in the Manor Courts in Ireland.

An Act for the better administration of justice at the holding of Petty Sessions by Justices of the

Peace in Ireland.

An Act to amend the laws for the regulation of the butter trade in Ireland.

An Act to provide for the relief of persons aggrieved by unlawful or excessive distresses in Ireland.

An Act to provide for the municipal government of the town and suburbs of Leith, for the further administration of justice, and for the regulation of the police therein.

St. James's-Palace, June 30, 1827.

THIS day the Right Honourable the Lord Mayor, the Aldermen, Recorder, Sheriffs, Common Council, and Officers of the City of London, waited upon. His Majesty with the following Address; which was read by Newman Knowlys, Esq. the Recorder:

To the KING's Most Excellent Majesty.

The dutiful and loyal Address of the Lord Mayor, Aldermen, and Commons of the City of London, in Common Council assembled.

Most Gracious Sovereign,

WE, your Majesty's most dutiful and loyal subjects, the Lord Mayor, Aldermen, and Commons of the City of London, in Common Council assembled, beg leave to renew to your Majesty the expression of our warmest feelings of veneration and respect.

Whilst we testify our unbounded regard for the Constitution of our Country, of which the prerogative of the Crown forms a most valuable and essential part, we rejoice to find that in the formation of a new Administration, your Majesty appears to have exercised that prerogative, under circumstances of great difficulty, in a manner highly dignified and constitutional.

We trust that your Majesty's Ministers, acting upon an enlightened and liberal policy, will so wield the powers entrusted to them by your Majesty, that the honour and prerogative of the Crown may be upheld, and that the liberties and happiness of the people may be maintained and protected.

Permit us to assure your Majesty, that we shall sincerely co-operate to the utmost of our power in every measure which may be essential to promote these important objects; and that we yield to none of your Majesty's faithful subjects, in loyalty and attachment towards your Majesty's Royal Person and Family.

R ULES, Orders, and Regulations for the pre-servation of His Majesty's Moorings, and for the mooring, anchoring, and placing of all private ships of war, transports, and all other private and merchant ships and vessels, lighters, barges, boats, and other craft whatsoever, in the navigable River of Thames, and near to the docks, dock-yards, arsenals, wharfs, and moorings belonging to His Majesty therein, for the purpose of keeping the same free and open, and for ensuring a free and safe passage to and from the same respectively; made and established pursuant to an Act of Parliament, made and passed in the fifty-fourth year of the reign of His late Majesty King George the Third, chapter 159, intituled "An Act for the better regulation of the several ports, harbours, roadsteads, sounds, channels, bays, and navigable rivers in the United Kingdom; and of His Majesty's docks, dock-yards, arsenals, wharfs, moorings, and stores therein; and for repealing several Acts passed for that purpose."

Art. I. It is hereby ordered, that no private ship of war or transport, nor any private or merchant ship or vessel, steam-vessel, lighter, barge, boat, or other craft whatever, shall be moored, anchored, or placed within the boundaries or limits following, that is to say:

DEPTFORD.

Within sixty fathoms from any part of the south western shore of the said River, between the north end of the wharf of His Majesty's Victualling-yard at Deptford, and a spot on the same shore, situate at the distance of forty fathoms below the lower side of the entrance of Deptford Creek.

Note.—This regulation is not meant to extend to transports, convict-ships, and other vessels having occasion to load and unload at His Majesty's Dockyard and Victualling-yard; all which ships and vessels may for those purposes, under the superintendence of the Officers of those Yards, continue to make use of the moorings which they have been accustomed to use.

WOOLWICH.

Nor within seventy fathoms from any part of the south shore of the said River, between Long's Wharf, otherwise called Trinity Wharf (which is situate above His Majesty's Dock-yard at Woolwich), and a spot called the Grove, at the eastern extremity of the same Dock-yard.

Nor within one hundred fathoms from any part of the same shore between the western boundary of the wharf of the Royal Arsenal, at Water-lane, Woolwich, and the entrance of the canal or basin at the eastern extremity of the said Arsenal.

GREENHITHE.

Nor within seventy fathoms from any part of the shore, commencing at the west end of Ingress Park, and terminating at the New Jetty, recently erected at the lower end of the said Park.

Art. II. It is further ordered, that no private ship

ship or vessel, steam-vessel, lighter, barge, boat, or other craft shall be moored, anchored, or placed within the distance of forty fathoms from the centre of any of His Majesty's moorings in any part of the said River, from the Nore upwards.

Art. III. And whereas a practice has prevailed of ships and vessels of a light draught of water, unnecessarily coming to anchor in the fair way or mid. channel, and in the fair stream of the tide, to the great inconvenience of the public and of the navigation of the River, and frequently to the danger of ships of a larger draught and requiring deeper water;

It is, therefore, further ordered, that no ship, vessel, boat, or other craft, of any description being light, or which shall draw less than eight feet of water, shall anchor or moor in the mid channel or fair stream of the tide, in any part of the said River, so that all merchant ships and vessels of burden and of larger draught, as well as His Majesty's ships. and vessels, may have free passage up and down the said River without obstruction.

And lastly, in order to prevent the danger which may arise to His Majesty's ships and stores from fire, it is ordered, that no ship or vessel, steamvessel, boat, barge, or other craft, having any furnace, forge, or fire on board thereof, shall be moored, anchored, or placed within the distance of fifty fathoms from the centre of any of His Majesty's moorings; nor shall any ship or vessel whatever, boat, barge, or other craft be breamed, repaired, or fitted with engine gear, afloat in any part of the said River or shore thereof, within a like distance of fifty fathoms from the centre of any of His Majesty's. moorings, and from His Majesty's dock-yards, arsenals, wharfs, and premises respectively.
